# Some ground rules for this course.

- 1. There are no make-up labs. We just do not have the capability for doing this.
- 2. **Absences** must be submitted to the Dean of Students.
- 3. **Any absence** note should be given within a week of the missed lab to the Dean of Students and the TA and Lab Supervisor notified. If a week has already passed, then it is a zero for the assignment/participation that was missed.
- 4. Scheduling your work time during a class time will not allow for a redo of any assignments/exams.
- 5. Do not ask to make-up a missed assignment/participation/exam without a confirmation from the Dean and the Lab Supervisor.
- 6. No extra credit will be given.

- 7. If you have a grade discrepancy when a grade is posted, you have only one week from the posting in which you can bring this up.
- 8. Issues with any grade discrepancy, must be done during TA office hours not during when the lab class is in session. Please make an appointment with the TA. The TA will only discuss the grade on an individual basis, not in a group.
- 9. As per university policy, to get an incomplete, you must be making a D or above as of the last day of your attendance.
- 10. If the TA suspects cheating and an investigation is opened and confirms it, then the student(s) will be reported to the Dean of Students and to the Academic Integrity office.
- 11. Disruptive behavior towards the TA or towards any laboratory member will result in a 1<sup>st</sup> warning given by the TA. If the behavior is continued, Campus security will be called and the student escorted out of the class. An accompanying report will be made to the Instructional Laboratory Supervisor, the Dean of Students and the Chair of the Biology Department.

#### Exams.

- 1. All exams will be closed book with no class notes or outside resources.
- 2. Exams will be taken in class and cover **all** concepts and topics that have been discussed in class as well as posted on canvas.
- 3. All electronic devices must be turned off.
- 4. Please use the bathroom before the exam starts you will not be allowed to use the bathroom during the exam.
- 5. Cheating includes, but is not limited to, getting assistance from others, accessing the web, using electronic resources, or using notes during exam time. Cheating in this course will result in you receiving a zero for that grade opportunity and a note will be placed in your academic file. If caught cheating twice you will be permanently removed from this course and receive an 'F' grade for the course.
- 6. Exams will be given at the start of the class and will only be administered for the said time. If you are late you can take the exam, but you will not be given additional time. In other words, if the exam is **2 hrs** long and if you come in an hour late from the start of any exam, then you will only have 60 minutes to complete the exam.
- 7. If you come in for an exam late and students have already completed and left the exam, then you will not have a chance to sit for the exam.
- 8. For those students who have missed an exam, you will need to provide documentation for the reason missed within a week of the exam to the Dean of Students. Students then will have the opportunity to take the missed exam as an Oral comprehensive make-up exam >2 hrs only. The Oral comprehensive make-up exam will be administered on the designated week as per syllabus via appointment with the TA. If you are late you can take the exam, but you will not be given additional time. In other words, if you come in an hour late from the start of any exam, then you will only have the left-over time to complete the exam.
- 9. An Oral comprehensive exam will not be used to replace another exam grade—not a make-up exam.
- 10. Only one exam can be made up as the Oral comprehensive make-up exam with provided documentation from the Dean of students. If you have missed more than one exam, then you will get a zero for the other missed exam(s).
- 11. Once you are scheduled for the Oral comprehensive make-up exam, you only get one chance to reschedule in case of emergencies—documentation will need to be provided.
- 12. Oral comprehensive exams must be taken by reading day.
- 13. Once you have taken an exam, there will be no "do overs" of any exams.

• Do not miss laboratory and please be on time for class. Delayed attendance, 5 minutes after class has started, will be considered late and will penalize your participation grade.

## **Suggestion**

Exam questions will come from notes. Review your laboratory notes after every laboratory. Your TA usually will ask for questions at the beginning of every laboratory. Come prepared with your questions. The laboratory is run in an informal manner, please relax and ask questions you might have as material is being presented.

### Lab policies

### Lab groups:

You will work in groups of 3-4. Groups will be assigned at the beginning of the course. All group members are expected to contribute equally to the lab work. It is the responsibility of group members to schedule out of lab work so that all members do their share of the work

## Collaboration and Plagiarism:

During the semester you will be generating data as a group, but the actual production of lab reports or any other written work is to be an individual effort and not collaboration with anyone else. You will be risking possibly failing the course and a report of academic dishonesty on you record. The lab coordinator and lab instructors do note the style of writing,

it is usually obvious when someone is plagiarizing due to the change in the style of sentence structure.

### **Academic dishonesty - Cheating**

- The term 'cheating' includes, but is not limited to: Use of any unauthorized assistance in taking quizzes, tests, or examinations;
- Dependence upon the aid of sources beyond those authorized by the instructor in writing papers, preparing reports, solving problems, or carrying other assignments;
- The acquisition, without permission, of tests or other academic material belonging to a faculty or staff member of the university;
- Dual submission of a paper or project, or resubmission of a paper or project to a different class without express permission from the instructor(s); or
- Any other act designed to give a student an unfair advantage.

# **Academic dishonesty - Plagiarism**

- The term 'plagiarism' includes, but is not limited to: The knowing or negligent use by paraphrase or direct quotation of the published or unpublished work of another person without full and clear acknowledgment; and
- The knowing or negligent unacknowledged use of materials prepared by another person or agency engaged in the selling of term papers or other academic materials.

## **Penalties for Academic Misconduct**

- First offense: A "0" will be recorded as the score for that activity AND the final course grade reduced by one complete grade
- Second offense" Assignment of F (Fail) for the final course grade
- For grievous infractions such as, but not limited to, a systematic or collaboratory event: An assignment of F (Fail) for the final course grade may be issued in the case of a first offense.

An example of a grievous 1<sup>st</sup> offense that will result in an "F" in the course would be turning in collections that you have stolen, borrowed, or otherwise not personally collected and try to pass them off as your work.

### **Biology Laboratory Procedures and Safety Rules:**

Laboratory safety is the first and foremost concern in any laboratory. The following regulations need to be followed without exception.

### IMPORTANT LABORATORY PROCEDURES

- 1. Make sure you know how to properly dispose of any chemicals used in lab.
- 2. Make sure all chemical containers are closed tightly after use.
- 3. Keep laboratory clean and organized.
- 4. Be familiar with experimental procedures you will be performing before coming to the laboratory.

### SAFETY RULES

- 5. DO NOT EAT OR DRINK IN THE LAB! This includes chewing gum!! Smoking is prohibited in all UNT buildings.
- 6. Broken glassware must be disposed of in the glass disposal box located in the lab. This box is for glass only.
- 7. If you or another student is cut or injured in any way during the lab, you must inform the instructor immediately.
- 8. Bare feet are not permitted in lab. Wear closed toe shoes as protection against broken glass or spillage. It is encouraged to wear long pants and long-sleeved tops, or purchase of a lab coat.
- 9. Know where to find emergency equipment such as the eyewash, fire extinguisher, and first aid kit.
- 10. Report any conditions that appear hazardous to the instructor.
- 11. Do not bring children or pets to the lab. Unaccompanied children are not permitted on campus.
- 12. Pay attention to warnings in the lab manual or warning the instructors announces during the lab.
- 13. Turn instruments off when the laboratory is over.
- 14. Always wash your hands after completing your laboratory work. Do not apply cosmetics during lab.
- 15. Wipe down your table with ethanol or water before you leave.
- 16. Always think before you act.
