Course Description:

Thermodynamics II is the applications of fundamental thermodynamics laws and concepts. Course will discuss exergy analysis (Ch7), vapor power cycle (Ch 8), gas power system (Ch 9; Otto cycle, Diesel cycle, Brayton cycle), refrigeration system/cycle (Ch 10), ideal gas mixture and psychrometric applications (Ch12 air conditioning system).

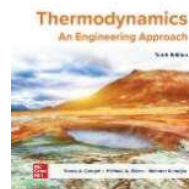
