Quizzes

There will be two unannounced quizzes during the semester, one prior to the midterm exam and the second following the midterm exam and prior to the final exam. The quizzes will require the student to answer a short battery of multiple-choice questions drawn from the texts and lecture (including multi-media.) Each quiz will contribute 5% (i.e., 10% total) to each student's final grade. Scantron sheets will be furnished to each student for each quiz. Students are responsible for furnishing a valid UNT Identification Card corresponding to their quiz submission and a #2 pencil for completing the scantron.

Exams

There will be **2 exams** in this course: One midterm exam on **Tuesday**, **March 10**, and a final exam on **Tuesday**, **May 12**, **10:30 a.m.–12:30 p.m.**, **AUDb100**. Each exam requires that the student to answer multiple-choice questions drawn from the required readings and lecture (including multi-media.) A review session will be held during the lecture period immediately prior to each exam and marked on the calendar. Scantron sheets will be furnished to each student during each exam. Students are responsible for furnishing a valid UNT Identification Card corresponding to their own exam submission and a #2 pencil for completing the scantron. Each exam will contribute 45% to each student's final course grade (90% total.)
