OBJECTIVES

1. Establish a consistent, exemplary performance standard in both rehearsal and performance.
2. Provide a setting to foster familiarity with outstanding repertoire through performance.
3. Perform a balance of literature that includes new music and standard repertoire.
4. Enhance and reinforce the study, practices, and skills encouraged in the private studio.
5. Apply historical and theoretical concepts in the development of expression and interpretation.
6. Encourage each individual's artistic and technical development while working toward goals for the group.

ATTENDANCE AND GRADING

1. Performers will be evaluated on the basis of their preparation and performance.
2. Attendance is **required** at all rehearsals, sectionals, performances, and recording sessions.
3. Sectionals may be called by the conductor or principal players as needed.
4. Cell phones must be completely off and completely put away. You should not be able to see, hear, or access your phone during rehearsal.
5. Individual measures should be numbered in parts prior to ensemble rehearsal.
6. Any unexcused absences or tardiness to a concert call will result in a lowered letter grade.
7. **Two tardies = one absence** (musicians should be in seats five minutes prior to tuning).
8. Excessive tardiness, absences, absence from a dress rehearsal or performance will result in a failing grade.
9. Please communicate conflicts as soon as possible. Requests for absences are not guarantees of approval. Our degree of flexibility is directly related to notice given and hence, our ability to solve the problem. Communication should be directed to the ensemble faculty and the conductor of your specified ensemble.
10. Events that are beyond your control, such as serious illness or family emergencies will be considered on a case-by-case basis and will be handled by the conductor of the ensemble.

CONCERT ATTENDANCE

Concert attendance, being an extraordinary opportunity to become familiar with repertoire that informs the future professional's artistic decisions, is a mandatory and assessed portion of the course. **All ensemble music majors (regardless of degree plan or matriculation level) are expected to attend all Wind Symphony, and Wind Ensemble concerts each semester. Brass Band, Concert Winds, Symphonic Winds, University Winds and other concerts listed below will be used as make-up concerts.** Each instance of an unexcused absence from a Wind Studies concert will result in a half letter grade deduction.

Music Majors should swipe their student ID in the lobby area at least **fifteen minutes prior** to the start of the concert (the table will be closed five minutes prior to the concert; you will not be able to check in after this). Following the conclusion of the concert, you will need to **swipe your ID again in the lobby**. The following are the Wind Studies concert dates for the semester.

SHARED CONCERTS AND PART ASSIGNMENTS

If you share a concert with another ensemble, you are required to be in attendance for the entire concert. Likewise, if a particular assignment on a concert cycle has you not performing on certain pieces, the expectation is to remain in the audience when not performing. This serves to foster a culture of mutual support among colleagues, as well as to further your personal education and appreciation of the wind band repertoire. Attendance policies will have comparable ramifications to other ensemble attendance grade requirements.

OUTSIDE COMMITMENTS AND SHORT-TERM LEAVES OF ABSENCE

As a member of the ensemble and student in the course, we assume that your primary responsibility is to the announced schedule. Outside work and performance opportunities are considered to be the business of the student but should not interfere with College of Music obligations. Please consider this document a contract of your commitments to the College of Music and the Wind Studies Area for the semester. Requests for excused absences for the purposes of auditions, contests, interviews, and other special professional opportunities are to be made with the ensemble conductor and are subject to approval by the Director of Wind Studies. The amount of flexibility we have in accommodating such requests is directly related to the amount of advanced notice given.

HEARING PROTECTION

The use of hearing protection (ear plugs) is strongly recommended. The UNT Speech and Hearing clinic will provide a free hearing test to every enrolled UNT student. In addition, “musician’s ear plugs” can be purchased at the clinic. The College of Music provides ear plugs at no charge; students can pick these up from the repair shop, MA 106.

CONCERT DRESS - ARTIST BLACK

- Option 1:** Full dress black: black formal trousers, black jacket, black dress shirt, optional black bow tie, optional black cummerbund or vest, black socks, and black shoes.
- Option 2:** Black full-length, long-sleeved dress OR black full-length skirt and black long-sleeved blouse/jacket (either version should have **covered shoulders, arms, and torso**).* Black close-toed shoes. Both clothing and shoes should be formal rather than casual.
- Option 3:** Black loose-fitting pants with black long-sleeved blouse/jacket (**covered shoulders, arms, and torso**).* Black close-toed shoes. Both clothing and shoes should be formal rather than casual.
- *Tasteful, conservative jewelry is permissible.

PERFUMES, COLOGNES, AND FRAGRANCES

No perfumes, colognes, or other scented lotions in rehearsal or performance. These can trigger asthma and allergic reactions for other ensemble members. If you wear scents to work or class and go straight to rehearsal, rinsing off in a bathroom before rehearsal will alleviate any unnecessary allergic reactions.

ACADEMIC INTEGRITY

Financial Aid and Satisfactory Academic Progress

Undergraduates

A student must maintain Satisfactory Academic Progress (SAP) to continue to receive financial aid. Students must maintain a minimum 2.0 cumulative GPA in addition to successfully completing a required number of credit hours based on total hours registered. Students cannot exceed attempted credit hours above 150% of their required degree plan. If a student does not maintain the required standards, the student may lose their financial aid eligibility.

Students holding music scholarships must maintain a minimum 2.5 overall cumulative GPA and 3.0 cumulative GPA in music courses.

If at any point you consider dropping this or any other course, please be advised that the decision to do so may have the potential to affect your current and future financial aid eligibility. It is recommended that you to schedule a meeting with an academic advisor in your college or visit the Student Financial Aid and Scholarships office to discuss dropping a course before doing so.

Graduates

A student must maintain Satisfactory Academic Progress (SAP) to continue to receive financial aid. Students must maintain a minimum 3.0 cumulative GPA in addition to successfully completing a required number of credit hours based on total registered hours per term. Music scholarships require a 3.5 cumulative GPA. Students cannot exceed maximum timeframes established based on the published length of the graduate program. If a student does not maintain the required standards, the student may lose their financial aid eligibility.

If at any point you consider dropping this or any other course, please be advised that the decision to do so may have the potential to affect your current and future financial aid eligibility. It is recommended you schedule a meeting with an academic advisor in your college, an advisor in UNT-International or visit the Student Financial Aid and Scholarships office to discuss dropping a course.
