Course Description

This course will prepare undergraduate music education students to go into any beginner to intermediate woodwind class setting and successfully teach oboe, bassoon, and clarinet. Skills will include, but are not limited to, instruction on instrument selection, teaching posture, breathing, instrument parts, instrument assembly, embouchure, tone production, articulation, range, fingerings, transpositions, diagnosing problems and offering solutions, and care and maintenance for each woodwind instrument.

Course Goals

Students who complete this course successfully will be able to:

- Understand the sequencing of teaching a woodwind instrument and other musical elements to a beginning band student.
- Know reasonable expectations for a beginning woodwind student.
- Demonstrate the instrument selection process.
- Teach and demonstrate correct posture for each woodwind instrument.
- Teach and demonstrate correct breathing for a wind instrument.
- Teach and demonstrate correct assembly of each woodwind instrument.
- Teach and model correct embouchure for each woodwind instrument.
- Teach and model a characteristic sound for each woodwind instrument.
- Teach and model correct articulation for each woodwind instrument.
- Be able to diagnose typical problems that may occur while a beginning band student learns a woodwind instrument both visual and aural.
- Teach and demonstrate the correct fingerings for the practical range of the woodwind instruments.
- Know instrument tuning tendencies and practical solutions for each woodwind instrument.
- Know the inherent technical problems for each woodwind instrument.
- Have a working knowledge on how to develop individual musicians past the beginner year.
- Have a working knowledge of brands of instruments, reed brands & strengths, mouthpieces and other equipment used in a band setting.

Required Texts, Materials, or Equipment

- Burk, DeSoto, Johnson, Meredith, and Talanca. *Musical Mastery Woodwind Teacher's Edition*. MRNS Music, 2016
- Appropriate instrument, mouthpiece/ligature, & reeds for the section (1125 – flute/sax; 1225 clarinet/double reeds). This is \$60 per semester for the instrument and mouthpiece/ligature/neck strap through UNT
- Note taking supplies, writing utensils, & highlighter
- Small locker mirror w/magnets on the back
- Recommended Reeds
 - Clarinet reed –Bb Clarinet Reed strength 3 (D'Addario Reserve Classic or Van Doren V12).
 - Oboe – two functioning oboe reeds purchased from [Bocal Majority](#).
 - Bassoon – two functioning bassoon reeds purchased from [Bocal Majority](#).
 - *Have your reeds and materials a week prior to the modules.*

Class Structure

MUAG 1125.500 (Griffin)

- Double Reeds – August 18 – October 10 (instrument exchange on October 9)
- Clarinet – October 13 – December 12 (instrument return before December 12)

MUAG 1225.501 (Griffin)

- Clarinet – August 18 – October 10 (instrument exchange on October 8)
- Double Reeds – October 13 – December 12 (instrument return before December 12)

Course Expectations

- *Preparation* to succeed, demonstrate, understand, participate, and contribute to class culture.
- *Participate* in discussion, instructional sessions, demonstration, and performance.
- *Deadlines* - Take quizzes and exams on the days they are offered and submit assignments on due dates.
- *Professionalism* – practice using the language, terminology, behavior, and communication of the professional you are preparing to become. This includes writing in complete sentences, using the subject line in an email, starting with a salutation, writing the body of the email in a clear and concise manner using proper grammar, and a proper closing.
- All expectations deemed fit by the Music Education Department, the College of Music, The University of North Texas, and the State of Texas required to grant a degree in music education.
- The materials for this class are chosen and administered with the ultimate success of the students in mind.
- Part of the requirements for this class is to have all listed supplies, including, but not limited to, the Musical Mastery Teachers Edition textbook, the appropriate instrument, mouthpiece & reed, a small locker mirror, and note-taking supplies. Failure to have the required supplies will impact the success of the student and will result in forfeiture of credit for assignments and participation related to said supplies.

Course Topics

- All elements required to teach a young musician.
- How to help a student select an instrument.
- Musical elements that must happen simultaneously.
 - Breathing (proper use of air)
 - Rhythmic Counting
 - Musical Alphabet
 - Basic Music Theory
- Embouchure for each instrument.
- Tone production for each instrument.
- Parts of the instrument, instrument assembly, instrument maintenance and care.
- Transpositions, ranges, and the function of the instrument in an ensemble.
- Specific technical concerns for each woodwind instrument.
- Aural and visual detection of problems and methods of correction.
- Brands & models of instruments, reeds, mouthpieces, and other equipment used in a band class.

Participation

- Materials – having the required materials and equipment that you need for each class.
- Preparation – having read/practiced/written what you need for each class.
- In-Class Performance – teaching and playing for the entire allotted time on these days.
In-Class Discussion – actively taking part in class discussion, playing sessions, and instructional sessions during every class.
- All interactions in class will be civil, respectful, and supportive of an inclusive learning environment for all students and teachers.
- Cell phones should be stored out of sight unless in use for the class.

In-Class Performance

- Each student will demonstrate and teach instrument assembly and maintenance.
- Each student will be expected to model a characteristic sound on every woodwind instrument.

Daily Work/Homework

- May include, but will not be limited to, questions on assigned reading, lesson plans, and basic pedagogical understanding.
- Fingering practice ‘quizzes’ can be found on quizizz.com; codes will be given out in class.
- Class participation playing the assigned instruments, discussions, etc.
- Self-guided practice between classes is essential to success in this course.

Assessment- Quizzes

- Quizzes and tests will be taken via Canvas, Quizizz and/or Google Forms
- Fingering quizzes on each woodwind instrument
- Knowledge of woodwind pedagogy, including, but not limited to teaching embouchure, instrument assembly, articulation technique, instrument parts, and reading for each instrument.
- Weekly playing quizzes for each instrument
 - Tone demonstration
 - Required scales
 - Required repertoire/exercises - Selections to be taken from anything that you play in class from any textbook, handout, or method book; so, reading, home study, and practice are very important.
- Reading and embouchure quizzes will be given through Canvas, Quizizz.com; codes will be given out in class. Deadlines to complete these quizzes will be firm, so plan accordingly.
- Quizzes will always follow lecture, demonstration, and student lead teaching done in class. Quizzes will include fingerings from Musical Mastery, proper terminology, parts of the instruments, instrument assembly, embouchure formation, & common problems and solutions. *Quiz makeups are given only in the event of a university or Dean of Students approved absence.*

Major Assignments

- Project – Assemble and maintain a virtual notebook on your chosen device. This is for your reference and use once you are student teaching/teaching in the classroom.
 - On your electronic device, make a folder for instrumental methods.
 - Make sub- folders for woodwinds, brass, and strings (vocal if you want).
 - Make sub-sub-folders for each woodwind instrument, each brass instrument, and each string instrument.
 - Move handouts over from Canvas into the appropriate folder on your device for this class. You will only be responsible for handouts and materials for this class, but having all your information in one place will help when you need to access it during student teaching and beyond.
- Teaching – Students will be required to create a lesson plan and teach the class at least once during the semester.
 - The lesson plan template is provided.
 - Make 3 copies of the completed lesson plan; one for the student and two for the instructors.
 - A teaching guide and script will be provided to help you organize your lesson.

Timely Return of Student Work, Projects and Final Exams

Students are required to turn in assignments on the day they are due according to the syllabus and timeline. Student work will be graded and returned in a timely manner.

Exams

- Mid-term – the mid-term exam will cover *all information up to the date of the exam*. Questions will be selected from homework assignments, instrument quizzes, in class lectures, and information from the required textbooks. The format will be multiple choice and essay questions. The mid-term exam date will be on the course schedule posted to Canvas.
- Final – The final exam will be comprehensive covering *all information through the end of the course*. Questions will be selected from homework assignments, the instrument quizzes, in class lectures, and the required textbooks. The format will be multiple choice, essay questions, & fingerings for all instruments.

Attendance Policy

- As per MUED policy, students may not miss more than 3 classes in a given semester.

Undergraduates

A student must maintain Satisfactory Academic Progress (SAP) to continue to receive financial aid. Students holding music scholarships must maintain a minimum 2.5 overall cumulative GPA and 3.0 cumulative GPA in music courses.
