Course Description

This course investigates the relationship between music, activism, and politics through a wide range of historical and geographical contexts. Perspectives may include, but are not limited to: musical nationalism, censorship, cultural policy making, war and peace, the cultural industries, and/or musical activism and social movements.

The course is designed so that students can be successful without a background in music. A musical performance background (reading music notation) is also not a prerequisite. The main requirement is a willingness to listen carefully, listen wider, and to reflect on those experiences.

Course Structure

MUMH3200 is designed in several big topics. These topics range from specific piece analysis to larger issues. Canvas holds the learning objectives and detailed schedule for each week.

Course Prerequisites or Other Restrictions

There are no prerequisites for this course.

UNT Creative Arts Core Objectives

- Students will articulate how music engages with political ideologies and practices. To most effectively examine these musical issues, students will introduce problems and questions; present, interpret and analyze historical documents and contemporary scholarship related to the music being studied in this course; consider the context and credibility of this source material; develop and present arguments related to music and activism; and present conclusions, while assessing their implications. (Core LO: Critical Thinking)
- Students will evaluate and communicate how political ideologies have influenced all realms of music and media. To communicate effectively, students will be asked to present a central idea; organize material cohesively; develop content; and apply rules of Standard English in their arguments. (Core LO: Communication)
- Students will identify elements of social responsibility across all kinds of musics. In so doing, students will acknowledge and apply diverse perspectives to various musical genres/songs; acknowledge and apply civic responsibility to various musical genres/songs; and articulate insights about personal attitudes, behaviors, or beliefs as they relate to various musical genres/songs (Core LO: Social Responsibility)
- Working as a part of a team, students will participate in frequent in-class team activities and a final creative team project. Throughout these activities, students will reflect frequently on how best to contribute to a group; prepare and collaborate with a team; foster a constructive team climate; and respond to feedback constructively. (Core LO: Teamwork)

Materials

There is no required textbook for this course. All course materials will be made available via Canvas as PDFs or links to UNT's library databases.
