COURSE EXPECTATIONS

- Be ready for downbeat at 5:00 p.m. on rehearsal days.
 - Five tardies will result in the dropping of a letter grade. *Exceptions will be made on a case-by-case basis.
- If a student must miss a rehearsal, student must email the instructor one week ahead of time providing the date and reason for absence, as well as the name of the substitute. It is the responsibility of the student to make sure the sub has all music needed for rehearsal.
 - One absence with no sub provided and no communication with will result in the dropping of a letter grade. *Exceptions will be made on a case-by-case basis.
- Have all gear (i.e. mutes, doubles, extension cords, amps, pencils, music, etc.).
- Be musically prepared for rehearsal and listen to recordings pertaining to class repertoire.
- Coordinate and attend sectionals.
 - All students are expected to attend sectionals.
 - Section leaders must send me an email to let me know when sectionals will be held and email me if an absence occurs.
- Participate in band logistics as directed.
- Be punctual and professional at all performances.
 - Missing a performance will result in the dropping of a letter grade.
- Lead players/section leaders will be responsible for the management of their respective sections.

- Listening assignments may be given as needed.
- Course information will be disseminated via the Canvas page. Check regularly (i.e. daily) for updates and new information.

ATTENDANCE POLICY

- Attendance is required for all class activities.
 - Five tardies will result in the dropping of a letter grade. *Exceptions will be made on a case-by-case basis.
 - One absence with no sub provided and no communication with will result in the dropping of a letter grade. *Exceptions will be made on a case-by-case basis.
- On a case-by-case basis with **advance notice** a substitute may be arranged.
- If a substitute is approved for rehearsal it is your responsibility to ensure the sub has the music, is qualified to play your chair, and is prepared.
- You are expected to play ALL performances and dress rehearsals during this semester. In rare cases an exception may be made after consultation.

Students are expected to attend class meetings regularly and to abide by the attendance policy established for the course. It is important that you **communicate** with the instructor prior to being absent, so you can mitigate the impact of the absence on your attainment of course learning goals. Please inform the instructor as soon as possible if you are unable to attend class meetings because you are ill.

MEMBER RESPONSIBILITIES

- You are responsible for all music and your music folder.
- You will be charged a fine determined by the Jazz Department for loss of any music or your folder.
- It is your responsibility to acquire appropriate concert attire. Appropriate concert attire is required and will be specified before each performance.

Financial Aid and Satisfactory Academic Progress

<u>Undergraduates:</u> A student must maintain Satisfactory Academic Progress (SAP) to continue to receive financial aid. Students must maintain a minimum 2.0 cumulative GPA in addition to successfully completing a required number of credit hours based on total hours registered. Students cannot exceed attempted credit hours above 150% of their required degree plan. If a student does not maintain the required standards, the student may lose their financial aid eligibility.

Students holding music scholarships must maintain a minimum 2.5 overall cumulative GPA and 3.0 cumulative GPA in music courses.

If at any point you consider dropping this or any other course, please be advised that the decision to do so may have the potential to affect your current

and future financial aid eligibility. It is recommended that you to schedule a meeting with an academic advisor in your college or visit the Student Financial Aid and Scholarships office to discuss dropping a course before doing so.

<u>Graduates:</u> A student must maintain Satisfactory Academic Progress (SAP) to continue to receive financial aid. Students must maintain a minimum 3.0 cumulative GPA in addition to successfully completing a required number of credit hours based on total registered hours per term. Music scholarships require a 3.5 cumulative GPA. Students cannot exceed maximum

timeframes established based on the published length of the graduate program. If a student does not maintain the required standards, the student may lose their financial aid eligibility.

If at any point you consider dropping this or any other course, please be advised that the decision to do so may have the potential to affect your current and future financial aid eligibility.
