Course Objectives

To provide the student with a working knowledge of management science/operations research techniques for use in business. This will be achieved by using the real-world problem-oriented approaches and using examples that emphasize the multi-disciplinary nature of business problems. Spreadsheets will be used to strengthen students' ability to make business decisions. The course uses case studies, games, simulations and assignments that require communication and interaction, to strengthen students' understanding. Techniques covered will include Decision Analysis, Multi-objective optimization, Simulation, and Forecasting. (Be prepared to think innovatively, independently, logically and without the use of cook-book formulae in order to succeed in this course.)

Prerequisite(s)

Please see UNT Undergraduate Catalog, specifically you should have taken DSCI 2710, 3870 and BCIS 2610.

(It is assumed that students taking this course have completed the college algebra course and also have a good foundation in calculus, basic statistics and probability theory as covered in the basic statistics course. Although some review of elementary concepts and terminology is provided in the textbook, it is not intended to replace a complete course, but rather to refresh your memory. While a high degree of mathematical skill is not necessary in an "applied" course such as this, there are certain insights into the course that are gained through the mathematics involved.)

(It is fine if you have the 14 or 15th Edition of this textbook. You will however need to <u>reconcile</u> the self-test exercises, end-of-chapter cases and problems with the 16th edition as needed. I will be using the 16th edition in class.)

2. A Simulation Game Code

You will be playing an online simulation game for which you will need an access code. You can buy the code directly at http://mgr.responsive.net/Manager/ShowClient. You will have to create

an account to login. Note that the institution name in the dropdown menu appears as "North Texas". The product is titled "SU code for Professor Verghese". Operational details pertaining to the game appear later in this syllabus and semester. The simulation would be played for three weeks starting late October (It will be a 3 weeks simulation, where you will enter decisions based on your strategy. There are only 4 variables you can change and an excel sheet would be provided to help you in analyzing) - \$18 per person. A link will be provided in canvas for it. (It is played by teams of four, you will have the option to choose your partners and there will be group evaluation provided for it.)

3. Beergame

An online simulation game. <u>No charge for it.</u> Each supply chain will have up to four players, however they will be assigned randomly. Will be in class and you need a laptop or tablet (<u>no cell phones or any other smaller mobile devices</u>) to play the game.

4. Business or scientific calculator

Must be able to perform at least the following functions: square, square root, raise to nth power, extract nth root, logarithm. The lack of a calculator does not excuse the student from making math errors on exams.

5. An access to a computer/laptop with Excel Solver.

Teaching Method

- 1. You are encouraged to attend classes regularly. I believe that 70% of studying is done in classrooms, the students who understand the topics while being presented in class tend to do well in exams and assignments.
- 2. You are encouraged to pay attention to commercials and news items in printed as well as audio-visual media to become aware of the wide use of modeling techniques in our daily lives. To better assist you in understanding the use of these methodologies in business many of the class problems will be presented as simple business cases.
- 3. You should <u>study</u> the material in the PowerPoint slides. You are strongly encouraged to try to independently solve the problems included in the lecture slides, not simply verify that the provided solutions "make sense". Actually work the problem by hand!

General Comments

- 1. Doing the assignments and regular work is essential for success in this course. In fact, the assignments and group activities constitute a large portion of your grade in this course (50%). You are encouraged to keep up with the work and meet the submission deadlines. Even if you make 100% in all exams and score 0 in the assignments, the best grade possible will be "C" or lower. Therefore, doing assignments is crucial. They are simple and help you with the preparation.
- 2. You should not hesitate to ask questions in class. Usually someone else has the same question, so, when you ask a question in class, others can benefit from the question.
- 3. Regular and punctual attendance for the **full** period of each class is expected (irrespective of whether roll calls are made, or attendance is otherwise verified). Absences and tardiness are likely to cause you to miss the presentation of significant material and this may result in a lower grade. There will be no make-up if you miss any of the mid-term exams, unless you have a <u>University-approved excuse</u>. Whenever applicable, such an excuse is to be provided to the instructor in writing, as early as possible.
- 4. You have the final responsibility for seeing that you properly withdraw before the scheduled last drop day, in case you wish to withdraw from/ drop the course. If you stop attending class,

you should execute the drop procedure since failure to do so will result in a grade of "F" which cannot be changed.

Course Specific Policies:

- 1. **Email Correspondence:** All electronic communication will be conducted over email (not on canvas). All student emails to the instructor will be sent from the student's official UNT email with a subject line starting with: **DSCI 4510: <Type of concern>**. Emails sent in violation of these guidelines will be ignored. All grade related questions and concerns need to be communicated in writing over email (not on canvas) with the subject line: **DSCI 4510: Grade Concern.** Any grade-related emails should only contain information relevant to the grade in question. Any references to your grades in other courses, or the impact of the grade on your overall academic standing are irrelevant and will result in the grade concern being dismissed.
- 2. Assignments/Readings/Cases: Problems/cases from the textbook will be assigned as the course progresses. Some problems/ cases are already assigned in the "Course Outline" which appears later. The student is responsible for solving these problems/cases in a timely manner. I will also hand out readings (magazine articles, newspaper clippings etc.) which I expect the student to go through.
- 3. **Quizzes:** Most quizzes will be online during class and will be closed book/closed notes (so make sure you bring your laptop to class, if you have issues reach out to me early). The quizzes are to evaluate your progress in the class and help you prepare towards the exam.
- **4. Exams:** There will be two exams and it is not comprehensive. <u>Each exam will have two parts</u>. One portion of the exams will be closed books (i.e. you are not allowed to browse internet nor read the text), Respondus lockdown, another portion of exam will involving solving problems using software. For each exam, bring a calculator, and your Student ID.

Missed exams will receive zero marks unless a legitimate excuse is presented. If you miss an exam, please follow the steps below:

- **Step 1:** If you miss an exam for any acceptable reason, please e-mail the instructor as soon as you are able about the reason why you missed the exam.
- **Step 2:** Then, you should provide the instructor proof in the form of an official document as soon as you are able with proper documentation. Your documentation should be acceptable based on an interpretation of College of Business or University policy.
- **Step 3:** After the instructor receives an acceptable proof, the instructor will then e-mail you to schedule a make-up exam.
- 5. **Face to Face class:** This is an on-campus class. The class sessions may not be recorded and posted online for reference. A few select portions of the class may be recorded and posted online for the entire class to reference. This would be ad-hoc and subject to the instructor's decision.

Remember, class participation and quizzes will be given only during in class sessions. There are points for class participation and some sessions like (project presentation, startup game presentation and beer game sessions have higher points). If there is a health-related reason for missing these sessions, a proper documentation should be provided to the instructor. An appropriate make up opportunity would be provided, if the excuse is deemed

acceptable.

6. **Grading Policies:** All assignments will be graded fairly and scores will be available typically in a week.

There will be some bonus opportunities throughout the class. There is a possibility of about 20- 30 bonus point activities in class. If you earn them, they will added to the raw score.

- 7. Startup Game and project are group activities: You need to select a team of 4 by end of Week 2. There will be separate peer evaluation for each group activity, you are expected to work together and contribute towards the team.
- **8. Written (Typed) Work Submission:** Students may be required to submit written/typed assignments for this class to Turnitin, a web-based plagiarism detection service. Before submitting your paper to Turnitin, **please remove your title page and other personal information.** Any paper that is not submitted to Turnitin may not be accepted by the instructor and may not be graded.
- 9. **Late Work:** The due date of each quiz and exam is clearly communicated in the syllabus and on Canvas. Therefore, if you are late completing these assessments without a valid excuse, I will not extend the deadline. For permitted late submissions (requires consent of the instructor, individual assignments only) there might be a penalty, and the assignment needs to be completed within 1 week from the original date.
- 10. Attendance Policy: In-person class attendance is expected. No standard accommodations for non-attending students will be provided. Come on time and stay for the duration of each class. It is critical that you not only attend class meetings, but are fully engaged and participating in such meetings. Excessive absences and/or failure to participate will impact your grade. Specifically, more than 3 absences without a documented medical reason may reduce your overall points by ½ a letter (40 points) and more than 6 absences may reduce your grade by 1 letter (80 points). Coming to class late more than 3 times or abstaining from participating in more than 3 instructor presented opportunities may reduce your overall points by (20 points) and coming late or abstaining from participation more than 6 times

- may reduce your overall points by ½ a letter (50 points). In addition, if you must miss a class, you remain fully responsible for all material, changes in the schedule, and other information given during class.
- 11. **Syllabus Change Policy:** The schedule and information provided is tentative and subject to change. Any changes to the syllabus will be notified to the students via announcements on Canvas and/or emails from the instructor.

- **13. Photo ID Requirement for Exams and Quizzes:** You may be required to show your student ID card for submitting exams and/or quizzes in class.
- 14. Generative AI Use Is Prohibited: The use of AI tools is strictly prohibited in this course.
- 15. Random Knowledge checks: We reserve the right to test you further on your submissions during the semester. We would randomly check your knowledge on the topics and see how you answered the assignments. As long as it is your work, you will NOT have any issues. Only students who plagiarize will be reported to the Dean of students for further actions, and will receive a failing grade in the class. Remember, anything you submit to the class should be your work and you should be able to explain the answer and repeat/show the process again when questioned.
