Required Text/Access to WebAssign

Cengage WebAssign is an online homework platform which can be accessed directly through Canvas. WebAssign access includes all online homework assignments, the textbook, and additional learning resources. Use the link in Canvas to register immediately. You must register in WebAssign by the 2nd class day of the semester. The textbook is Stewart, James, Lothar, Redlin, Saleem, Watson Precalculus – Mathematics for Calculus, 8th Edition, Cengage Learning (2016). It is available online through the WebAssign platform. WebAssign offers a no-cost trial 14-day access, beginning on the first day of the semester. You must purchase access before the trial expires on the 14th day of class. If you do not make the purchase before the trial period ends, you may lose credit for all work previously completed.

Course Description:

5 hours. Preparatory course for calculus: trigonometric functions, their graphs and applications; sequences and series; exponential and logarithmic functions and their graphs; graphs of polynomial and rational functions; general discussion of functions and their properties.

Prerequisite(s):

Officially, the prerequisite is a grade of C or higher in MATH 1100, or placing in the class via a placement test

Good note-taking skills and the discipline to review your notes.

A willingness to put in several hours of work each week to absorb the material in each module. In math courses – especially this one – the content will build upon itself making it very difficult to catch up if you fall behind.

Course Objectives

Upon successful completion of this course, learners will be able to:

1. Apply properties of functions to graphing and modeling.
2. Solve equations involving algebraic and transcendental functions.
3. Use graphing techniques to graph algebraic and transcendental functions by hand.
4. Identify and determine exact and approximate values of trigonometric functions of angles in both radians and degrees.
5. Prove trigonometric identities.
6. Solve right and oblique triangles.
7. Define polar coordinates and graph polar equations.
8. Apply the terminology of sequences and series to determine terms and sums.

Calculator Policy

Calculators will not be permitted for quizzes or exams. Calculators may be used on all homework assignments. A TI 83 or 84 or equivalent is recommended, but any scientific calculator should be enough.

There are several free online calculators you can use while working on homework assignments as well (e.g., Desmos, GeoGebra, etc.).

WebAssign Online Homework

Your WebAssign homework can be accessed through the Cengage link on Canvas. The online homework assignments will be due at midnight. You have five attempts per problem for most problems in WebAssign. At the end of the semester, your two lowest WebAssign homework scores will be dropped.

To encourage keeping up with the homework, you will receive a 10% bonus for any work on WebAssign completed more than 48 hours before the due date.

Written Assignments

You will have several written assignments. These assignments require you to show, in your own handwriting, the mathematical process for selected problems. These written assignments must satisfy the following conditions:

- Must be completed in your own legible handwriting
- Must show your own original work
- Project-level quality: well-organized, steps clearly ordered, mathematically correct,
- Little to no credit for correct answers without correct work

A grade penalty will be assigned to any submission that does not meet all the submission requirements. The written assignments will be due at the beginning of class. No late homework will be accepted for any reason whatsoever. At the end of the semester, your two lowest written homework scores will be dropped.

Quizzes

Quizzes will be administered roughly once a week in the recitation portion of our class meetings. Quizzes are collaborative but closed-note work. At the end of the semester, your two lowest quiz grades will be dropped.

Exams

You will have four midterm exams and a comprehensive final exam. Actual exam dates and content will be announced in class. The tentative exam dates are:

No make-up exams will be given for any reason. If you will miss an exam, you must let the instructor know as soon as possible to determine accommodations.

Attendance

Attendance is important and required. This entails writing lecture notes and asking questions in class.

Worksheets

You will receive a bonus of 5% for your final grade if you turn in **at least 70%** of your handwritten worksheets done during class. The worksheets will be accepted only at the end of the class on the day the worksheet was assigned.

Generative AI Policy

Learning mathematics requires independent thought and the ability to see and learn from one's own mistakes. In addition, generative AI is known to math educators to make serious errors, assume facts unknown to the student, and produce a great deal of clutter in addition to valid steps. Therefore, the use of Generative AI like ChatGPT, Claude, Gemini, etc., is strictly prohibited in this course. Depending on the nature of the assignment in question, if a student is caught using such services to do their work, the student's grade may be heavily penalized, including the possibility of a zero on the assignment. At the instructor's discretion, depending on the severity of the infraction, this conduct may be reported to the Office of Academic Integrity.

Academic Integrity Policy

Important Notice for F-1 Students taking Distance Education Courses

Federal Regulation

To read detailed Immigration and Customs Enforcement regulations for F-1 students taking online courses, please go to the [Electronic Code of Federal Regulations website](http://www.ecfr.gov/) (<http://www.ecfr.gov/>). The specific portion concerning distance education courses is located at Title 8 CFR 214.2 Paragraph (f)(6)(i)(G).

The paragraph reads:

(G) For F-1 students enrolled in classes for credit or classroom hours, no more than the equivalent of one class or three credits per session, term, semester, trimester, or quarter may be counted toward the full course of study requirement if the class is taken on-line or through distance education and does not require the student's physical attendance for classes, examination or other purposes integral to completion of the class. An on-line or distance education course is a course that is offered principally through the use of television, audio, or computer transmission including open broadcast, closed circuit, cable, microwave, or satellite, audio conferencing, or computer conferencing. If the F-1 student's course of study is in a language study program, no on-line or distance education classes may be considered to count toward a student's full course of study requirement.

University of North Texas Compliance

To comply with immigration regulations, an F-1 visa holder within the United States may need to engage in an on-campus experiential component for this course. This component (which must be approved in advance by the instructor) can include activities such as taking an on-campus exam, participating in an on-campus lecture or lab activity, or other on-campus experience integral to the completion of this course.

If such an on-campus activity is required, it is the student's responsibility to do the following:

- (1) Submit a written request to the instructor for an on-campus experiential component within one week of the start of the course.
- (2) Ensure that the activity on campus takes place and the instructor documents it in writing with a notice sent to the International Student and Scholar Services Office. ISSS has a form available that you may use for this purpose.

Because the decision may have serious immigration consequences, if an F-1 student is unsure about his or her need to participate in an on-campus experiential component for this course, s/he should contact the UNT International Student and Scholar Services Office (telephone 940-565-2195 or email internationaladvising@unt.edu) to get clarification before the one-week deadline.

Student Verification

Transmission and Recording of Student Images in Electronically-Delivered Courses

1. No permission is needed from a student for his or her image or voice to be transmitted live via videoconference or streaming media, but all students should be informed when courses are to be conducted using either method of delivery.
2. In the event an instructor records student presentations, he or she must obtain permission from the student using a signed release in order to use the recording for future classes in accordance with the Use of Student-Created Work guidelines above.
3.
