Course Description

Calculus I is the study of limits and continuity, derivatives, and integrals. The class will cover differentiation and integration of polynomial, rational, trigonometric, and algebraic functions as well as applications, including slope, velocity, extrema, area, volume, and work, and will provide preparation for students in STEM majors.

Required Text/Materials

The textbook is Stewart, James, *Calculus*, 9th Edition. It is available online through WebAssign platform.

Cengage WebAssign: WebAssign is online course delivery platform accessed directly through [Canvas](#). WebAssign access includes all online homework assignments, the e-text of *Calculus 9th Edition*, by James Stewart, and additional learning resources. Use the link in Canvas to register immediately. You must register in WebAssign by the 2nd class day of the semester.

WebAssign grants a no-cost temporary 14-day access, starting the first day of the course (not the first day you activate). You must purchase your access before the temporary access expires. If you do not make the purchase before trial period ends, you may lose credit for all work previously completed.

You may use a basic scientific or graphing calculator for worksheets or exams, but nothing more advanced than a TI-83/84 equivalent, and work will still need to be shown. I suggest you use the same calculator on homework that you will on exams, if you do so.

Course letter grades will be determined as follows: **A:** 89.5 or above, **B:** 79.5 to below 89.5, **C:** 69.5 to below 79.5, **D:** 59.5 to below 69.5, **F:** below 59.5.

These cutoffs will not be adjusted by any amount for any reason, and grades will not be adjusted outside of the listed assignments. If it is important for you to make a certain grade in this class, determine that and begin the effort now, not at the end of the semester.

Late work will not be accepted in this course regardless of the reason.

Course Structure

This course will meet in person 4 times per week for lecture. There will be regular homework, 3 midterm exams, and quizzes or activities during lectures on Fridays, as well as a final exam.

Homework

Each week there will be homework on WebAssign for the sections covered that week. The homework will be due by 11:59 PM on Thursday of the following week. For instance, in week 1 we will cover all of 1.4 and 1.5. Thus, the homework on these sections will need to be completed by Thursday night during week 2. This is to give ample time and flexibility should the unexpected happen, but ideally you should be completing the homework as you go through the module during the week. To provide an incentive, you will receive a 5% bonus for any work on the homework completed more than 48 hrs before the deadline. Keep in mind you will have to check WebAssign frequently to keep up with the due dates, there will not be reminders in Canvas. On the homework you will generally have 10 attempts on each question with some possible exceptions (e.g. multiple choice or true false questions). Your lowest two (2) homework scores will be dropped, with an opportunity for more later in the semester.

Quizzes

There will also be a quiz each week on Friday in class covering the material from the prior week (i.e. over the homework you submitted that Thursday). These will be used both as an assessment for how prepared you are with the material, and as practice in communicating your understanding through showing work and written statements. Your lowest worksheet score will be dropped, with an opportunity for more later in the semester.

Calculus Readiness

During the three weeks of the semester, you will need to complete a somewhat lengthy review assignment in WebAssign. This assignment goes over the main topics from Precalculus to make sure you are prepared for this (and future classes). You will have 100 attempts on each question, so that you have ample opportunity to review and get it right. This assignment is 5% of your grade.

Exams

There will be 3 midterm exams administered in person during lecture. There are NO remote/online options for exams. If there is a conflict with an exam, you need to notify me at least 1 full week in advance.

If you miss an exam, you receive a zero for that exam. There are no make-up exams. However, your lowest exam grade (including a zero from a missed exam) may be replaced by your score on the final exam if it is higher. You may ask me to go over exam problems with you. However, all decisions on partial credit are final and not open for discussion.

Final Exam

A mandatory and comprehensive final exam will be given on **Wednesday, December 9th from 8:00-10:00 am.**

Attendance

Attendance is important and required. It will be taken using iClicker, so please make sure to log in at the beginning of each class. Failure to log in may result in a reported absence.

Notes

Partial notes will be provided ahead of time on Canvas. It is strongly recommended that you print these out and fill them as we cover the material in class. Timing of lectures will assume these notes are available to you. You may not take photographs of the completed notes without explicit permission. If there is something you did not get during lecture, you may come by office hours or get them from a classmate. If you have a condition that requires note-taking accommodations, please contact the ODA, information below.

- A willingness to put in several hours of work each week to absorb the material in each module. In math courses, especially this one, the content will build upon itself making it very difficult to catch up if you fall behind

Course Objectives

Upon successful completion of this course, learners will be able to:

- Develop solutions for tangent and area problems using the concepts of limits, derivatives, and integrals;
- Create graphs of functions considering limits, continuity, and differentiability at a point;
- Determine whether a function is continuous and/or differentiable at a point using limits;
- Use differentiation rules to differentiate functions;
- Identify appropriate calculus concepts and techniques to provide mathematical modules of real-world situations and determine solutions to applied problems;
- Evaluate definite integrals using the Fundamental Theorem of Calculus;
- Articulate the relations between derivatives and integrals using the Fundamental Theorem of Calculus;
- Determine the area between curves using integration techniques; and
- Determine the volume generated by rotating a curve about an axis.

Federal Regulation

To read detailed Immigration and Customs Enforcement regulations for F-1 students taking online courses, please go to the [Electronic Code of Federal Regulations website](http://www.ecfr.gov/) (<http://www.ecfr.gov/>). The specific portion concerning distance education courses is located at Title 8 CFR 214.2 Paragraph (f)(6)(i)(G).

The paragraph reads:

(G) For F-1 students enrolled in classes for credit or classroom hours, no more than the equivalent of one class or three credits per session, term, semester, trimester, or quarter may be counted toward the full course of study requirement if the class is taken on-line or through distance education and does not require the student's physical attendance for classes, examination or other purposes integral to completion of the class. An on-line or distance education course is a course that is offered principally through the use of television, audio, or computer transmission including open broadcast, closed circuit, cable, microwave, or satellite, audio conferencing, or computer conferencing. If the F-1 student's course of study is in a language study program, no on-line or distance education classes may be considered to count toward a student's full course of study requirement.

University of North Texas Compliance

To comply with immigration regulations, an F-1 visa holder within the United States may need to engage in an on-campus experiential component for this course. This component (which must be approved in advance by the instructor) can include activities such as taking an on-campus exam, participating in an on-campus lecture or lab activity, or other on-campus experience integral to the completion of this course.

If such an on-campus activity is required, it is the student's responsibility to do the following:

- (1) Submit a written request to the instructor for an on-campus experiential component within one week of the start of the course.
- (2) Ensure that the activity on campus takes place and the instructor documents it in writing with a notice sent to the International Student and Scholar Services Office. ISSS has a form available that you may use for this purpose.

Transmission and Recording of Student Images in Electronically-Delivered Courses
