## **Course Description**

Students will learn the regulatory & compliance aspects of shipping both domestically and internationally. We will be breaking down the regulations for Air, Ocean, Rail, Trucking, and Intermodal and Customs services. Looking at this from a regulations and risk perspective. In addition, we will work examples of live contracts.

We have two-group assignment reviewing all aspects of a global contract including risk.

Role 2: Shipper Role 3: Carrier

Role 4: Forwarder – Commercial & Operations

Role 5: Other Parties – Legal and Risk

## **Course Goals**

The overall goal of this course is to develop a detailed an understanding of what is behind the shipping industry from a regulatory, compliance and risk/insurance. This course is designed to provide a basic understanding of how management and companies work together to be compliance in a complex matrix environment of today's global organizations.

## **Course Objectives**

Upon successful completion of this course, students will have a basic understanding of:

- Air Regulations
- Ocean Regulations
- Rail Regulations
- Trucker/Intermodal Regulations
- CBP Regulations
- Contractual understanding at a Management level
- Risk and costs associated with Insurance
- General Contract knowledge
- Stakeholder Management C- Level
- Managing Risks and Constraints
- Common Contract Problems Negotiations

Each of the above student-learning outcomes must be performed at an appropriate level per course assignment requirements and grading scale.

### **Course Structure/Approach**

This course meets in both the classroom, and distance based learning. It involves individual and small groups, as well as whole classroom learning. Students will form small groups for discussions, when directed to do so, by the professor, and will work to complete a project Business Case to present at a Board Level. Students will utilize Canvas for turning in written assignments using the Canvas Assignment Tool.

#### **Course Requirements**

#### **Attendance and Participation:**

This is an interactive course. In-class assignments cannot be made up. If you are scheduled to present, it is your responsibility to be in class to share your work or lead a discussion. All individual assignments must be turned in on Canvass.

**Note:** Students who fail to engage with the course materials in a timely manner risk being administratively dropped from the class.

**Time commitment:** Business students are expected to devote approximately 3 hours per week to study for every unit of coursework. Logistics students should anticipate spending 4 hours weekly engaged with course readings and learning experiences.

## Academic Integrity

The G. Brint Ryan College of Business takes academic honesty seriously. Ethics and integrity are important business values, essential to building trust and adhering to both professional and legal standards. Academic dishonesty destroys trust, damages the reputation and the value of the degree and is unacceptable.

According to UNT Policy 06.003, Student Academic Integrity, academic dishonesty occurs when students engage in behaviors including, but not limited to cheating, fabrication, facilitating academic dishonesty, forgery, plagiarism, and sabotage. A finding of academic dishonesty may result in a range of academic penalties or sanctions from admonition (a warning) to expulsion from the University.

Some of the most common examples of academic integrity violations include plagiarism or cheating, such as unauthorized assistance on examinations, homework, research papers or case analyses. Your work must be entirely your own. When working on assignments, you should not discuss your work with others unless approved by the course instructor. Group assignments should only be discussed with members assigned to your group, and all group members may be held accountable in some way for known academic integrity violations in a group assignment.

Another example of academic dishonesty relates to improper attribution. When preparing your assignments, you must cite all outside sources in the manner requested by your instructor. Copying or using material from any source prepared by or previously submitted by others, at UNT or other institutions, or downloaded from the Internet, is plagiarism. Unless directed otherwise in an assignment, large scale "cutting and pasting" from other sources, even if properly footnoted, is not appropriate. You should synthesize this material in your own words and provide a footnote.

Your instructor will specify what materials, if any, may be used on the tests and exams. Using materials other than those permitted, talking with other individuals during the exam, individuals exchanging information about an exam when one has taken the exam and the other has not, or copying or using material from another individual's exam is academic dishonesty and will result in a meeting to discuss academic integrity violations and potentially issue sanctions mentioned above, and may result in ineligibility for academic scholarships. The use of online assistance, such as sites commonly used for finding homework solutions, group chat, cell phones, smart watches, and similar tools during exams is not allowed for any reason unless specifically permitted. No portion of an exam may be copied or photographed without permission.

Students are expected to conduct themselves in a manner consistent with the University's status as an institution of higher education. A student is responsible for responding to a request to discuss suspected academic dishonesty when issued by an instructor or other University official.
