Barriers to adaption. Setting up the development environment (introduction to Solidity, Truffle, IPFS, Metamask, web3.js), deploying applications (Test Network Ropsten and Ganache blockchain tutorial). Literature review. Applications include smart contracts to: IoT, networks, healthcare, finance, supply chain and identity management. Architectural tradeoff for performance improvement. Studying the blockchain industry. Guest lecturers from the industry.

Course Objectives

Course outcomes are measurable achievements to be accomplished by the completion of a course.

- 1. Explain blockchain related concepts including distributed ledgers, UTXOs, transactions, Merkle trees, hashes, blocking transactions, chaining blocks, consensus, trust without trust, etc.
- 2. Build small stand-alone components or modules or classes and compose them to produce larger programs.
- 3. Design and implement programs using asynchronous programming concepts.
- 4. Design and implement programs using event-based programming concepts.
- 5. Install, configure and utilize blockchain related libraries, packages, browser extension and web interfaces.
- 6. Create and utilize smart contracts.
- 7. Develop applications using Ethereum test networks.
- 8. Implement code in the areas of DeFi, DAOs and others.

Course Materials

This course has no textbook. I will post materials on Canvas and provide links to open source software. We will discuss concepts and programming issues in class.

Teaching Philosophy

Just like you can't read a musical score and claim you know how to play an instrument or sing, you cannot read a programming textbook or read a bunch of papers or blogs and claim you can develop software. You have to write code and fix syntactic and semantic errors and deal with unexpected asynchronous behavior. You need to understand unfamiliar concepts and deal with strange APIs. You need to build your code on top of software already written by others over which you may not have control. It is easy to become frustrated and blame your computer and everything else. After doing all that, take another look at your code and more than likely your mistake would be staring at you! There is nothing like it when you make things work and things click in your head.

Please watch Canvas for weekly assignments and/or quizzes. All assignments and quizzes have a max score of 100 points. Late penalty is 15 points. For team projects you need to submit your own report written from your point of view highlighting your participation and contribution. Substantial overlap with other team members is allowed.

Grades will be posted on Canvas throughout the semester to provide an ongoing assessment of student progress, though final assessment will be measured using the weighted average above. Once a grade is posted on Canvas, students have two (2) weeks to dispute the grade, unless otherwise instructed. The proper channel for grade disputes is to first go to the original grader (i.e., the TA) in an attempt to resolve the issue. If, however, a resolution cannot be reached between the student and the grader, the student shall then go to the instructor who will have the final say on the grade.

Students are responsible for submitting the *correct* assignments (i.e., uploading the proper files) for each applicable assignment submission on Canvas. If you have any questions or concerns about your submission, please work with your instructor or TA to ensure the correct file(s) is/are submitted.

Course Evaluation

You should not work with other students on shared program solutions or use program solutions found on the Internet. Specifically, you should never copy someone else's solution or code, and never let a classmate examine your code. A sophisticated program will be used to compare your work to the work of all other students (including students in past classes). If you are having trouble with an assignment, please consult with your instructor or TA associated with the class.

You must do your own work on exams. There should be no ambiguity here.

Federal Regulation

To read detailed Immigration and Customs Enforcement regulations for F-1 students taking online courses, please go to the <u>Electronic Code of Federal Regulations website</u> (http://www.ecfr.gov/). The specific portion concerning distance education courses is located at Title 8 CFR 214.2 Paragraph (f)(6)(i)(G).

The paragraph reads:

(G) For F-1 students enrolled in classes for credit or classroom hours, no more than the equivalent of one class or three credits per session, term, semester, trimester, or quarter may be counted toward the full course of study requirement if the class is taken on-line or through distance education and does not require the student's physical attendance for classes, examination or other purposes integral to completion of the class. An on-line or distance education course is a course that is offered principally through the use of television, audio, or computer transmission including open broadcast, closed circuit, cable, microwave, or satellite, audio conferencing, or computer conferencing. If the F-1 student's course of study is in a language study program, no on-line or distance education classes may be considered to count toward a student's full course of study requirement.

University of North Texas Compliance

To comply with immigration regulations, an F-1 visa holder within the United States may need to engage in an on-campus experiential component for this course. This component (which must be approved in advance by the instructor) can include activities such as taking an on-campus exam, participating in an on-campus lecture or lab activity, or other on-campus experience integral to the completion of this course.

If such an on-campus activity is required, it is the student's responsibility to do the following:

(1) Submit a written request to the instructor for an on-campus experiential component within one week of the start of the course.
