COURSE DESCRIPTION

Management Concepts (MGMT 3820) is a junior-level course that will introduce the student to management theory, the different functions of management, and how managers interact with internal/external environments. Students will be introduced to several important topics such as ethical issues, decision making, global management, managing change and innovation, creating and managing teams, managing human resources, organizational structure, workplace communication, and leadership.

COURSE STRUCTURE

This lecture course will meet once per week in-person on Wednesdays, 6:30 PM – 7:50 PM in FRLD 400, and the remainder of the week is left to complete your assignments and quizzes on or before the due date at a time that is most convenient for you.

At the end of the course, the student should be able to:

- 1.) Recognize the value of taking a general manager's view of the firm (Knowledge).
- 2.) Discuss Management concepts by focusing on the key management functions (Comprehension).
- 3.) Analyze the relationships that exists between various organizational functions (Analysis).
- 4.) Identify current management issues confronting today's managers (Application).
- 5.) Build a foundation for advanced work in the field of Management (Synthesis).
- 6.) Explain how the study of Management Concepts expanded your business knowledge (Evaluation).

EXAM POLICY (No Webcam required)

Four non-cumulative exams will be administered online via Canvas. Each exam can consist of multiple-choice and/ or true-false questions. **Exams will open at 12:00 AM and remain open until 11:59 PM (CST) on the due dates (see schedule).** The timing is dictated by UNT’s semester structure. You will complete all exams online within the time allotted. Each of the four exams may have different time limits (i.e., 50, 60 minutes). Modify your pop-up blocking software including the new Yahoo and Google browsers! The course textbook is permitted for all exams.

DSL, cable, or better connections are preferred for exams. Most homes and apartments have robust Internet service. Using wireless connections in your home will be OK. Dial-up and cellular wireless connections have proven unsatisfactory and problem laden in the past. Exam times will always be stated in Central Standard Time (CST) and will be located under the “Quizzes” tab (left side navigation menu) on the home page. ASSIGNMENT POLICY (No Artificial Intelligence Use)

SYLLABUS QUIZ: Each student will complete an online syllabus quiz (SQ) by the designated due date. This will familiarize you with how to take an online exam within Canvas LMS®.

DISCUSSION BOARDS:

1. Getting to Know You

To kick off the semester, all students will introduce themselves on the Discussion Board. Be sure to respond to all questions (name, major, etc.). The Discussion requires you to post an Original Response to each of my Questions and to reply to at least one (1) of your classmates. **Please complete this assignment no later than Tuesday, August 18, 2026, at 11:59 PM CST. Completing this assignment before our first class will help us begin building our learning community and allow us to actively engage in meaningful class discussion from day one.**

2. Discussion Board Assignments

Four (4) discussion boards will be administered throughout the semester, with due dates on Sunday at 11:59 PM CST. These discussions are a chance to gain different perspectives from your peers. Please keep comments professional and respect each other's thoughts and opinions.

Initial Post: You are responsible for writing a 150-word original discussion of the week's readings. Your post should go beyond summarizing the reading. Explain your understanding of the topic and connect it to a real-world example, a personal experience, a current event, or your future career.

Peer Response: Reply to one (1) classmate's post with a thoughtful response of 75-100 words. Your response should contribute to the discussion by asking a question, sharing an example, or offering another perspective. Responses such as *"I agree"* or *"Great post"* without additional explanation will not receive full credit.

Once the Discussion is locked/closed, there is NO provision for making up the missed assignment.

RESEARCH TERM PAPER: There will be one synopsis research term paper (RTP) submitted this term. There is more information located on the RTP assignment page in Canvas. It is due as assigned at 11:59 PM CST. Late assignments will not be accepted unless covered by university policy.

CHAPTER QUIZZES: 16 Chapter Quizzes (CQ) will be made throughout the semester. You will have two (2) opportunities at each chapter quiz. It is the student's responsibility to be aware of, complete, and submit quizzes as required. Quizzes will

open immediately following the Wednesday class meeting and remain available until Tuesday at 11:59 PM CST. Late assignments will not be accepted unless covered by university policy. You will receive a zero if you do not complete a quiz by its due date. No make-up quizzes allowed. Completing the chapter quiz before Wednesday's class helps reinforce the previous week's concepts and prepares you to actively participate in the next class session.

ATTENDANCE POLICY

Students are expected to attend class meetings regularly and to abide by the attendance policy established for the course. It is important that you communicate with the professor prior to being absent, so you and the professor can discuss and mitigate the impact of the absence on your attainment of course learning goals. However, every semester a student will ask me for a deal that is not available to all students. A common mistake is to ask to extend deadlines for assignments and/or exams. Under no circumstances will I grant such a request (unless covered by university policy) for it is unfair to other students. Missed assignments are assigned a 0. And the most unethical mistake is to ask for a higher grade at the end of the course when you did not earn it. There are points available in the course.

NON-CONFIDENTIAL EMPLOYEES

We all feel stressed, upset, or melancholy at times. **You are normal!** Keep in mind that faculty and staff are now considered **non-confidential** employees according to Texas State law. Individuals/ students sharing that they suffer from depression, learning disabilities, are contemplating suicide, are involved in sex trafficking (including Sugar

Babies), or are victims of crimes (to include domestic violence) must be referred to the proper UNT office. Faculty and staff that fail in this requirement are subject to criminal prosecution and termination of employment.

LATE WORK POLICY

RCOB STATEMENT ON ACADEMIC HONESTY

The G. Brint Ryan College of Business takes academic honesty seriously. Ethics and integrity are important business values, essential to building trust and adhering to both professional and legal standards. Academic dishonesty destroys trust, damages the reputation and the value of the degree and is unacceptable.

According to UNT Policy 06.003, Student Academic Integrity, academic dishonesty occurs when students engage in behaviors including, but not limited to cheating, fabrication, facilitating academic dishonesty, forgery, plagiarism, and sabotage. A finding of academic dishonesty may result in a range of academic penalties or sanctions from admonition (a warning) to expulsion from the University.

Some of the most common examples of academic integrity violations include plagiarism or cheating, such as unauthorized assistance on examinations, homework, research papers or case analyses. **ChatGPT, Grammarly, and other AI apps are not authorized in this course.** Your work must be entirely your own. When working on assignments, you should not discuss your work with others unless approved by the course instructor. Group assignments should only be discussed with members assigned to your group, and all group members may be held accountable in some way for known academic integrity violations in a group assignment.

Another example of academic dishonesty relates to improper attribution. When preparing your assignments, you must cite all outside sources in the manner requested by your instructor. Copying or using material from any source prepared by or previously

submitted by others, at UNT or other institutions, or downloaded from the Internet, is plagiarism. Unless directed otherwise in an assignment, large scale “cutting and pasting” from other sources, even if properly footnoted, is not appropriate. You should synthesize this material in your own words and provide a footnote.

Your instructor will specify what materials, if any, may be used on the tests and exams. Using materials other than those permitted, talking with other individuals during the exam, individuals exchanging information about an exam when one has taken the exam and the other has not, or copying or using material from another individual's exam is academic dishonesty and will result in a meeting to discuss academic integrity violations and potentially issue sanctions mentioned above, and may result in ineligibility for academic scholarships. The use of online assistance, such as sites commonly used for finding homework solutions, group chat, cell phones, smart watches, and similar tools during exams is not allowed for any reason unless specifically permitted. No portion of an exam may be copied or photographed without permission.

Students are expected to conduct themselves in a manner consistent with the University's status as an institution of higher education. A student is responsible for responding to a request to discuss suspected academic dishonesty when issued by an instructor or other University official. If a student fails to respond after a proper attempt at notification has been made, the University may take appropriate academic actions in the absence of the student's participation.

HOW TO STUDY FOR EXAMS

Due to the quick timing of the course, I have a few suggestions to prepare you for the exams. Let's acknowledge that most of us have never met and I don't know you're learning style. Let me offer the following:

1. Read the chapter.
2. Look at the PPT slides.
3. Read the Canvas lesson material.
4. Now, reread the chapter and outline on paper by hand. Use the same chapter (paragraph) headings for content. I use two highlighter colors and a black pen.
5. View the chapter videos and PDFs.
6. Transfer your hand written notes over to a computer for printing.
7. (Consider) recording your notes to a Mp3 file for playback.

UNIVERSITY POLICIES

Academic Integrity Policy (No ChatGPT or Grammarly)

Academic Integrity Standards and Consequences. According to UNT Policy 06.003, Student Academic Integrity, academic dishonesty occurs when students engage in behaviors including, but not limited to cheating, fabrication, facilitating academic dishonesty, forgery, plagiarism, and sabotage. A finding of academic dishonesty may

result in a range of academic penalties or sanctions ranging from admonition to expulsion from the University.

UNT Code of Student Conduct and Discipline (06.003) defines misconduct and provides penalties for misconduct by students, including academic dishonesty. Academic dishonesty includes cheating and plagiarism.

The term **cheating** includes, but is not limited to, (1) use of any unauthorized assistance in taking quizzes, tests or examinations; (2) dependence upon the aid of sources beyond those authorized by the instructor in writing papers, preparing reports, solving problems, or carrying out other assignments; or (3) the acquisition, without permission, of tests or other academic material belonging to a faculty member or staff of the university. This also includes taking pictures of or posting exam questions on the Internet (i.e., social media).

The term **plagiarism** includes, but is not limited to, the use, by paragraph or direct quotation, of the published or unpublished work of another person without full and clear acknowledgment. It also includes the unacknowledged use of materials prepared by another person or agency engaged in the selling of term papers or other academic materials. This includes using papers written in other classes.

Policy Now Covers Chat GPT, AI, and Other Technologies.

You may not use **ChatGPT**, Grammarly, MS Autopilot 365, Google Gemini, or other Artificial Intelligence apps in this course. These apps insert AI markers into your term papers that are easily picked up by www.Turnitin.com. Current university policy treats AI use as an academic integrity violation. The issue is about original authorship.

Work Around Solution.

Many of you will be working on feasibility assignments. Your answers are based on the textbook, industry overview reports, the UNT library research page, and select Google searches. You are following instructions as to formatting and proper citations. You are not cutting and pasting content from web sites or reports and placing quotations marks around the sentences. Using diagrams and citing the exhibit is OK. I never quote anything or anybody unless I conduct the interview.

Remember, I asked you to **NOT** use ChatGPT, Grammarly, MS Auto Pilot 365, Google Gemini, and other products. (Even though your writing will improve). This is due to the University's position on Artificial Intelligence (AI). (BTW, do use spelling and Grammar check in MS Word as these are safe). Let me suggest a work around that might include using AI to get started.

I would like you to create two (2) documents. The first is your personal rough draft (don't show me) where AI has made a few suggestions. The second document is the **Official RTP Assignment** to be turned into Canvas. If you like the suggestions in your rough draft, then hand keyboard (type) that language into your **Official RTP Assignment**. Do not cut and paste as this will infect the graded assignment with AI markers (Think fleas on a dog). Do not select "yes" or "accept" for Grammarly, MS Auto Pilot 365, or Gemini suggestions into the **Official RTP Assignment**. Again, with the AI markers.

I believe this suggestion will save both of us a lot of time. Faculty are required to investigate AI scores over 20% as picked up by www.Turnitin.com. Investigations take too much time, and we do not want to file charges against you with the Office of the Provost. This is not a good use of time for either of us. Avoid the issue.

Faculty Required Reporting.

The incident will be reported to the UNT Office of the Provost and the investigation will follow the outlined "Academic Integrity Process" as referenced at <https://vpaa.unt.edu/ss/integrity>. If you have engaged in academic dishonesty related to this class, you will receive a failing grade on the test or assignment, and a failing grade in the course. This policy is intended to protect the honest student from unfair competition with unscrupulous individuals who might attempt to gain an advantage through cheating.

***Please Note:** I will use a plagiarism detection service (i.e., Turnitin.com) to scan your term paper. This will be done in full compliance with university policy.

ADA Policy

Important Notice for F-1 Students taking Distance Education Courses

Federal Regulation. To read detailed Immigration and Customs Enforcement regulations for F-1 students taking online courses, please go to the [Electronic Code of Federal Regulations website](http://www.ecfr.gov/) (<http://www.ecfr.gov/>). The specific portion concerning distance education courses is located at Title 8 CFR 214.2 Paragraph (f)(6)(i)(G).

The paragraph reads. (G) For F-1 students enrolled in classes for credit or classroom hours, no more than the equivalent of one class or three credits per session, term, semester, trimester, or quarter may be counted toward the full course of study requirement if the class is taken on-line or through distance education and does not require the student's physical attendance for classes, examination or other purposes integral to completion of the class.

An online or distance education course is a course that is offered principally through the use of television, audio, or computer transmission including open broadcast, closed circuit, cable, microwave, or satellite, audio conferencing, or computer conferencing. If the F-1 student's course of study is in a language study program, no online or distance education classes may be considered to count toward a student's full course of study requirement.

University of North Texas Compliance. To comply with immigration regulations, an F-1 visa holder within the United States may need to engage in an on-campus experiential component for this course. This component (which must be approved in advance by the instructor) can include activities such as taking an on-campus exam, participating in an on-campus lecture or lab activity, or other on-campus experience integral to the completion of this course.

If such an on-campus activity is required, it is the student's responsibility to do the following:

- (1) Submit a written request to the instructor for an on-campus experiential component within one week of the start of the course.
- (2) Ensure that the activity on campus takes place and the instructor documents it in writing with a notice sent to the International Student and Scholar Services Office. ISSS has a form available that you may use for this purpose.

1. No permission is needed from a student for his or her image or voice to be transmitted live via videoconference or streaming media, but all students should be informed when courses are to be conducted using either method of delivery.
2. In the event an instructor records student presentation, he or she must obtain permission from the student using a signed release in order to use the recording for future classes in accordance with the Use of Student-Created Work guidelines above.
3.
