# Course Objectives:

This course develops elementary music literacy and analytical tools. After a review of fundamentals, the class delves into diatonic harmony. Class activities will develop fluency in analysis, part writing, and model composition. Prerequisites: Must be a music major. Co-requisite: MUTH 1410 (Aural Skills I).

and MTSB. You will be using these books for at least three semesters of theory classes, meaning you will have far less to buy in later semesters.

# **Extra Help Sessions**

Each week, the TA will be leading drill/study sessions during an office hour to review concepts and skills from class. These sessions are *open to all students* who want further guided practice on materials from class. Any student may attend as many or a few of these as he/she wishes. Some might attend weekly; others might choose to go only when they need improvement on a specific topic. **TA Office Hours** will be determined and posted during the first week of class.

The **UNT Learning Center** offers free tutoring sessions specifically designed for Music Theory I students. These sessions follow the speed test topics and/or general topics from Music Theory I. All students should take advantage of the free tutoring from the UNT Learning Center.

\*For every Learning Center event a student attends, he/she will earn one additional point on his/her Test III score. The maximum number of points earned is five.

## **Assignments**

Homework will be assigned weekly. All homework and exams must be completed neatly and legibly—especially in an online format. Assignments are due to your grader by the start of the class. If you do not understand how to complete an assignment, please see Dr. Graf (or any member of my team) before the assignment is due. If you know you will be absent, take a picture and email your completed homework to your grader before class begins (CC: Dr. Graf). Please let me know the circumstances for your late work, and I will work with you. Exceptions will only be made for unplanned excused absences (emergencies only) or other extreme circumstances at the discretion of the instructor. If you believe that your grader lost or misplaced your assignment, you must ask Dr. Graf to resubmit within two class periods of the due date; after that two week time period expires, it will remain a zero in the gradebook.

## Attendance

I expect everyone to keep up with the posted materials online each week. Normally, the TA would take attendance, but instead, this fall we will ask you to upload your notes each week to show that you participated in the class activities for that week. These will be graded at 10 points each and we will use them to track classwork and participation with musical and creative activity in the class.

## Financial Aid and Satisfactory Academic Progress

Undergraduates A student must maintain Satisfactory Academic Progress (SAP) to continue to receive financial aid. Students must maintain a minimum 2.0 cumulative GPA in addition to successfully completing a required number of credit hours based on total hours registered. Students holding music scholarships must maintain a minimum 2.5 overall cumulative GPA and 3.0 cumulative GPA in music courses.
