#### **Course Description**

This course explores the social justice issues that shape health outcomes, with a focus on the intersections of culture, race, ethnicity, social class, gender, and migration status. Students will engage with the foundational concept of health equity and gain a comprehensive overview of health disparities in the United States and beyond. Through an examination of historical contexts, theoretical frameworks, empirical research, and intervention strategies, students will critically analyze the root causes of health inequities and the systemic factors that sustain them.

The course also emphasizes the multifaceted nature of promoting health equity and advancing social justice in health. Students will learn about past and ongoing public health efforts aimed at reducing disparities and improving health outcomes across diverse populations. Instructional materials—including scholarly readings, multimedia content, class discussions, and lectures—will provide diverse perspectives and real-world applications of key issues.

By the end of the course, students will be equipped with the knowledge to critically assess health disparities and contribute to efforts that foster equitable health outcomes for all.

#### **Learning Objectives**

- Explain how various cultural theories are used to explain health disparities
- Apply theories and models to explain individual, community, and population health
- Understand the determinants of health disparities
- Generate ideas for programs and policies that can promote health equity
- Understand the importance of social justice in health among population groups
- Learn intervention approaches for some health-related behaviors
- Evaluate the importance of all the social determinants of health in creating health disparities.

## Core Competencies (student will be able to ...)

- Describe the historical development of public health and its role in society
- Incorporate the determinants of health in the causation of disease and access to health services
- Identify and contrast cultural factors contributing to disparities in population health
- Articulate the social determinants of health status in population groups
- Understand health disparities and factors that explain the disparities.
- Describe a socioecological approach to how social factors play a role in health behaviors.

**Readings and Assignments**: Students are expected to do all assigned readings for each week and be prepared to share their views on the different issues raised in the readings.

1. Quizzes: (50 points). There will be NO make-up quizzes. A quiz will be given weekly, starting May 19th, 2025. The quizzes are designed to test your knowledge and help you study for the exams. You will decide on the score that you want to earn on each quiz because you have multiple attempts until you earn a perfect score if that is what you want. Questions will be drawn from materials covered (textbook, articles, etc.). You must complete the quiz during the allotted time.

2. <u>Video Evaluations</u>: (75 points total)--Three videos will be shown in this class. The purpose is to provide students with an opportunity to think about and comment on particular issue(s) that is/are being covered. You are required to submit at least a one-page typed-written (font size =12) reaction paper of the video (300 words).

#### General guidelines for all the video evaluations

While you're viewing a video, think about and write down the following:

- a. What are the most important points or ideas in the video? (2 point)
- b. What significance do these ideas have for a course of this nature? (2 point)
- c. Write a brief response to at least one major issue discussed. Use your critical thinking skill here. Make sure you integrate relevant concepts and theories that you learn in the textbook, videos, notes, etc. to substantiate your views. (13 points).
   Make sure you clearly address this point because your answer is worth 13 points.
- d. Do you think the video is relevant to the class topic under discussion (here you state if the video presents anything to illustrate or explain a point raised in the text or in class discussion? Did the video make you look at anything differently?) If you think the video is not relevant to the topic, feel free to say so but you must be certain to explain your position. (7 points). Make sure you clearly address this point because your answer is worth 7 points.
- e. Did you find anything problematic? (1 point).

Note: Your grade will be based on the breadth and depth of your answers.

#### You must complete video assignments during these times.

3. <u>Discussions</u>: (75 points total). Discussion questions are posted in the Discussions tab. You are required to POST in your comments, read all of the posts of your classmates, and reply to two of the posts that you read.

In your discussions, be as detailed as possible. Refrain from simple answers like "I agree", "yes, this is true", etc. Please make sure you explain why you agree or think the posting is good or true. Whatever you say, make sure you explain why you think the way you do. What I will be looking for in the postings is how well students integrate concepts and theories learned in the text and articles into their discussions. **Show off your critical thinking skill!!!** Students will have **Fridays from 11:59 pm to Sundays 11:59 pm** to post and reply to two of their classmates' posts. After 11:59 pm on Mondays, you will NOT be ABLE to post your answer to the discussion question. NOTE: You have to post your answer for the discussion question(s) FIRST before you see the posts of your classmates.

90%-100% -- Very detailed answer. Answer/post has an extensive use of relevant textbook material –concepts and theories.

80%-89% -- Detailed answer. Answer/post contains a high level of use of textbook material—concepts and theories.

70%-79% -- Moderate answer. Answer/post has a moderate use of relevant textbook material—concepts and theories

60-69% -- Basic answer. Answer/post contains a superficial knowledge of relevant textbook material --concepts and theories.

59% and below – Answer/post has little to no knowledge of relevant concepts/theories.

- 2. <u>Discussions</u>: (75 points total). Discussion questions will be posted throughout the semester (see calendar). You are required to POST in your comments, read all of the posts of your classmates, and reply to two of the posts that you read.
- 3. Examinations. (300 points total)—There will be three exams given during the semester on the dates specified in the schedule. You have a 72-hour window for the exam. However, you will have a certain amount of time to take the exam once you begin it. Also, you will have only ONE attempt once you begin an exam.

## The paragraph reads:

(G) For F-1 students enrolled in classes for credit or classroom hours, no more than the equivalent of one class or three credits per session, term, semester, trimester, or quarter may be counted toward the full course of study requirement if the class is taken on-line or through

distance education and does not require the student's physical attendance for classes, examination or other purposes integral to completion of the class. An on-line or distance education course is a course that is offered principally through the use of television, audio, or computer transmission including open broadcast, closed circuit, cable, microwave, or satellite, audio conferencing, or computer conferencing. If the F–1 student's course of study is in a language study program, no on-line or distance education classes may be considered to count toward a student's full course of study requirement.

## **University of North Texas Compliance**

To comply with immigration regulations, an F-1 visa holder within the United States may need to engage in an on-campus experiential component for this course. This component (which must be approved in advance by the instructor) can include activities such as taking an on-campus exam, participating in an on-campus lecture or lab activity, or other on-campus experience integral to the completion of this course.
