# **Communication Expectations**

The primary tool of communication with students will be UNT email and announcements in Canvas. Any personal concerns or questions should be emailed to your instructor. # **Course Description**

**Spanish 2050 online** is a language course designed to bring students to an intermediate level of proficiency in the Spanish language. The course focuses on Spanish grammar and emphasizes in particular listening, speaking, reading and writing skills. Students will participate in listening comprehension activities, oral projects, in-depth cultural study, readings, audio and video resources, as well as Web-based language interaction. The class will be conducted in Spanish and students are expected to use only Spanish on all assignments.

## **Important**

All exams will be taken using LockDown Browser, a proctoring system provided by UNT that requires the use of a webcam. Students will be recording their environment before taking the exam

or quiz. They will also be recorded the whole time while taking exams. This does not constitute a violation of the student's privacy. If the student does not feel comfortable using a webcam while taking exams, it is suggested the student takes a face-to-face course. By taking this course, the student is aware and accepts the instructor will be watching the videos recorded in LDB.

## **Course Structure**

This is an intensive online course. The content of a regular semester course (16 weeks) will be covered in 4 weeks. All the content of the course is in the main menu on Canvas. Study assignments are organized in weekly modules. Modules cover **chapters 15-18** in the textbook (*Puntos de Partida*, 11<sup>th</sup> Edition). Each module contains folders with quizzes, specific information, guidelines, and grading rubrics for assignments. Exams, exam reviews, study guides and practice test are in the last module of each chapter.

To be well informed about the course, students are expected to carefully read each folder in the informational modules. To follow on time with all assignments, at the beginning of each week, students are expected to read all the folders in each module.

## **Readings and Assignments**

Information about weekly readings, pages to study, and assignments can be found in the **Course Assignments Schedule** in this syllabus. It is the student responsibility to continually consult the class schedule and meet the due dates for all assignments. This is an **extremely fast-paced course**. To keep up with the heavy workload, you must work on assignments every day following the schedule in the syllabus. Late work will be accepted only for excused situations according to the policy on late work and attendance policy.

# **Course Prerequisites or Other Restrictions**

This course is designed for students who have passed Spanish 1010, 1020, 1030, and 2040 at UNT or the equivalent. Do not enroll in this course if you have not taken the pre-requirements. For more information, please contact the Department of Spanish in LANG 101, (940) 565-2404.

# **Course Objectives**

By the end of this course, students will be able to:

- 1. Analyze the diverse cultural aspects of the Hispanic world
- 2. Discuss topics related to natural and urban environments
- 3. Talk about relationships and stages of one's life
- 4. Express contingency and purpose in complex sentences using the subjunctive
- 5. Recall and describe past events using more complex sentences
- 6. Discuss about money, finances, and job opportunities
- 7. Analyze situations related to diverse professions
- 8. Express probability using the future
- 9. Examine hypothetical events using the conditional
- 10. Discuss about government and civic responsibilities

# **Required Materials**

- Proofread and fact-check your sources.
- Keep in mind that online posts can be permanent, so think first before you type.

## **Connect Homework**

You will be assigned a variety of online reading, cultural, Grammar videos and grammar assignments on Connect, the textbook electronic platform. The link to open your Connect homework is available in each Chapter module in Canvas. It is highly recommended to work on all assignments before taking exams.

Connect homework is **due every Sunday 11:59 pm. Late work is not accepted.** Using translators or outside help for written assignments will result in a grade of 0 without the opportunity to redo the work.

Important: if you are using the electronic textbook in Connect, please use the blue textbook (not the yellow one). The pages assigned in the homework in this syllabus are based in the blue textbook.

# **Connect Practice Assignments**

For each chapter of the book, there will be Connect practice assignments. Each assignment is tailored to meet the specific needs of each student. Although these assignments are not obligatory, working on these assignments as much as possible helps to improve grades in Connect Homework, quizzes, exams and discussions.

# **Writing Assignments (Discussions)**

There will be 2 writing assignments throughout the semester to help you to further develop your writing and cognitive skills in Spanish. Instructions, topics, and grading rubrics are in each assignment in Canvas. To receive a grade on writing assignments, **the student must write the written sections of each exam**. Your writing proficiency in writing assignments must be close to your writing in exams. Using translators or outside help for written assignments will result in a grade of 0 without the opportunity to redo the work.

# **Speaking Assignments (Discussions)**

Students will create two video assignments throughout the course. Each assignment will be recorded in a 3–4-minute video and uploaded in Canvas. Students will be graded according to the grading rubric. The purpose of these assignments is to evaluate your Spanish speaking skills. Reading the assignments is not allowed and it will result in a 50%-point deduction. Late work will not be accepted.

## **How to Earn Extra Points on Discussions**

Students who 1) submit their first post early (see the assignments schedule); 2) submit all the comments required before or by the due date, and 3) comply with all the rules described below, will earn 2 points extra credit added to their discussion score for that week. The purpose of this incentive is to motivate early submission, and thereby provide a wider variety of posts for reply commenting by classmates.

# Rules to receive the 2 extra points:

- a). Comments to each classmate must be substantial, including vocabulary and all the grammatical structures required in the discussion. Comments that do not meet all the requirements stated in the grading rubric, will not receive the extra points. Details in the grading rubric in Canvas.
- b). Students who submit their first post early, **but do NOT** submit their 3 reply comments **will not be eligible** for the bonus points because they did not fully complete the assignment.

# **Lockdown Browser System**

Quiz 1 and all exams will be using LockDown Browser System. Instructions and the link to download the application on your computer is in the "Where to get help" Module. To take the quiz and exams, you will need a webcam on your computer. If your computer does not have a webcam, you can take the exam in the Language Lab. Check their winter schedule or call them in advance. If this is your first time

using LDB, it is highly recommended to take the practice quiz available in Module 1 (Chapter 15) in Canvas.

# Quizzes

There will be 2 quizzes assigned in **Canvas:** a practice quiz (not for a grade) that will help you to familiarize yourself with the exam format and how to record your environment correctly using Lockdown Browser. **Quiz 1** (for a grade) will evaluate your knowledge on this syllabus and the Informational Modules in Canvas: "Start Here", "Course Information" and "Instructor Information" in Canvas. You will have two attempts for quiz 1.

Take your quiz and exams as soon as possible. In case of computer problems, you will need time to solve them before the exam closes. If you experience technical problems, contact the UNT Help Desk for help, then contact your professor to report the incident. Make up for quizzes and exams will not be allowed due to computer, internet problems or uncharged batteries.

# **Chapter exams**

To evaluate your listening, reading, writing, vocabulary and grammatical skills, there will be **4 chapter** exams (chapters 15-18) throughout the course. Study guides, exam video review, practice test and complete information with instructions on how to take the exams using LockDown Browser are available on Canvas.

# **Examination Policy**

- Each exam will be available ONLY on the days and time assigned.
- Do not exit and re-enter the exam. Any answers after re-entering the exam will receive a grade of 0.
- All quizzes and exams must be taken *alone* and communication with other individuals is not allowed.
- The usage of electronic translators is completely prohibited. As a UNT student, academic integrity and honesty are expected. Infringements on this policy will result in a grade of 0.
- It is the student's responsibility to read in full and follow all the rules and regulations before taking exams and quizzes. Rules are available in Canvas in the folder "Rules and Regulations for Exams and Quizzes". Failure to follow the rules may result in a grade of 0 on your exam or quiz with no opportunity to retake it.
- Take your quiz or exam as early as possible. In case of a technical issue with your computer, you need time to solve the issue and take the exam before it closes.
- Make sure your laptop computer is fully charged before beginning any quiz or exam. Make up for the quiz or exams will not be allowed due to computer problems.

#### Student issues with the Instructor

## **Grade Appeal Policy**

- 2) Instructor departed from standards set out in the course syllabus without a rational academic reason, or

Student attendance for this online course is defined as **active participation** as described in the course syllabus. Class attendance is obligatory. Students are required to log in to the course by the first day of class. As a component of attendance student email, course announcements and discussion forums must be checked daily. If a student fails to meet the attendance requirements, he or she may be recommended for withdrawal from the course. Academic Integrity Standards and Consequences. # Important Notice for F-1 Students taking Distance Education Courses

#### **Federal Regulation**

To read detailed Immigration and Customs Enforcement regulations for F-1 students taking online courses, please go to the <u>Electronic Code of Federal Regulations website</u>. The specific portion concerning distance education courses is located at Title 8 CFR 214.2 Paragraph (f)(6)(i)(G).

#### The paragraph reads:

(G) For F-1 students enrolled in classes for credit or classroom hours, no more than the equivalent of one class or three credits per session, term, semester, trimester, or quarter may be counted toward the full course of study requirement if the class is taken on-line or through distance education and does not require the student's physical attendance for classes, examination or other purposes integral to completion of the class. An on-line or distance education course is a course that is offered principally through the use of television, audio, or computer transmission including open broadcast, closed circuit, cable, microwave, or satellite, audio conferencing, or computer conferencing. If the F-1 student's course of study is in a language study program, no online or distance education classes may be considered to count toward a student's full course of study requirement.

#### **University of North Texas Compliance**

To comply with immigration regulations, an F-1 visa holder within the United States may need to engage in an on-campus experiential component for this course. This component (which must be approved in advance by the instructor) can include activities such as taking an on-campus exam, participating in an on-campus lecture or lab activity, or other on-campus experience integral to the completion of this course.

If such an on-campus activity is required, it is the student's responsibility to do the following:

(1) Submit a written request to the instructor for an on-campus experiential component within one week of the start of the course.

(2) Ensure that the activity on campus takes place and the instructor documents it in writing with a notice sent to the International Student and Scholar Services Office. ISSS has a form available that you may use for this purpose.

Because the decision may have serious immigration consequences, if an F-1 student is unsure about his or her need to participate in an on-campus experiential component for this course, s/he should contact the UNT International Student and Scholar Services Office (telephone 940-565-2195 or email internationaladvising@unt.edu) to get clarification before the one-week deadline.

#### **Student Verification**

UNT takes measures to protect the integrity of educational credentials awarded to students enrolled in distance education courses by verifying student identity, protecting student privacy, and notifying students of any special meeting times/locations or additional charges associated with student identity verification in distance education courses.

#### **Use of Student Work**

A student owns the copyright for all work (e.g. software, photographs, reports, presentations, and email postings) he or she creates within a class and the University is not entitled to use any student work without the student's permission unless all of the following criteria are met:

- The work is used only once.
- The work is not used in its entirety.
- Use of the work does not affect any potential profits from the work.
- The student is not identified.
- The work is identified as student work.

If the use of the work does not meet all of the above criteria, then the University office or department using the work must obtain the student's written permission.

#### Transmission and Recording of Student Images in Electronically-Delivered Courses

- No permission is needed from a student for his or her image or voice to be transmitted live
  via videoconference or streaming media, but all students should be informed when courses
  are to be conducted using either method of delivery.
- 2. In the event an instructor records student presentations, he or she must obtain permission from the student using a signed release in order to use the recording for future classes in accordance with the Use of Student-Created Work guidelines above.
- 3. Instructors who video-record their class lectures with the intention of re-using some or all of recordings for future class offerings must notify students on the course syllabus if

students' images may appear on video. Instructors are also advised to provide accommodation for students who do not wish to appear in class recordings.

Example: This course employs lecture capture technology to record class sessions. Students may occasionally appear on video. The lecture recordings will be available to you for study purposes and may also be reused in future course offerings.

No notification is needed if only audio and slide capture is used or if the video only records the instructor's image. However, the instructor is encouraged to let students know the recordings will be available to them for study purposes.
