COURSE PHILOSOPHY AND OBJECTIVES

As jazz musicians, it is important to develop fundamental piano skills which will serve to strengthen one's musicianship and understanding the role of the piano/keyboard in a jazz context. Studying the piano gives the serious musician new tools and ways to visualize ideas, as well as display these ideas with an alternate sense of clarity. This course will continue the study of piano technique through scales and focus largely on jazz specific practices. While developing both technical facility and basic jazz skills, this course wraps up the undergraduate jazz studies keyboard skills classes, the goal being that any one of you can read through a lead sheet and transpose to near keys with basslines, chordal accompaniment, and melody.

COURSE CONTENT AND MATERIALS

I will provide PDFs for many of your assignments, but there is one book you should buy. As mentioned in keyboard skills III, this book is most applicable to this course (Keyboard Skills IV).

1. Alfred's Piano Library: The *Complete* Book of Scales, Chords, Arpeggios & Cadences (Around \$14 on Amazon)

COURSE POLICIES AND INFORMATION

GRADING: Your final grade is determined by the following criteria. Note that grades are reflective of a student's progress made in class, rather than his/her innate skills. If you show up to class on time every day, you will score at least a 50% in the class even if you failed all your assignments. Furthermore, while I do take late work, there is a 10-point penalty per day the assignment is late.

In the case of an absence a missed quiz due to an **unexcused** absence will be considered missing/late. I will mark the missing quiz as a 0 in the gradebook until it is made up, which will be the next time that you show up to class. Per syllabus, late work receives a 10-point penalty per class day. If you miss a class **unexcused** on Tuesday and you show up on Thursday, we will do your quiz that class day, and the highest you can earn is a 90. If you show up on the following Tuesday, then the highest you can score is an 80 etc.

If you email me ahead of time with a legitimate reason, work, illness, family emergency etc. the absence will be **excused** and there will be no penalty to making up quizzes the next class period or two.

IMPORTANT: There is a special category of assignment, called the Piano Proficiency Quiz (there are 7), which will be graded in the Weekly Assignments Category. At the end of the semester, you will have the opportunity to retest any 2 of the Proficiency Quizzes that you scored below 72 on. If you still have 2 or less quizzes unpassed you can try them again by request after the class has finished. But by the end of MUJS 1014 (this semester), you must have passed all 7 Quizzes with a minimum grade of 72 or higher. If at the end of this semester you have 4 or more proficiency quizzes unpassed, you will receive an F in the course (regardless of other grades you earned) and must register to repeat Piano III next year. A student receiving an F in the course must repeat the course to change the grade. Graduate Students have all assignments weighted the same, so they do not have any quizzes classified as proficiency quizzes.

If you pass your 7 Proficiency Quizzes, your Semester Grade will be calculated as follows:

50%: Daily Lesson Attendance

50%: Weekly Assignments (Canvas Video or in-person assessment)

Proficiency Quizzes are worth twice as much as in class weekly assessments for both undergraduate and graduate students

The final grade is determined by the following scale:

A = 90-100%, B = 80-89%, C = 70-79%, D = 60-69%, F = below 60%.

****Grades that are one point or less below a cutoff can be rounded up at the sole discretion of the instructor based on a student's overall effort, disposition, and attendance both in class and in office hours. For example, 89.1 and 89.0 *can* be rounded at the instructor's discretion, 88.9 *cannot*.**

ATTENDANCE: If you miss class unexcused, that day's lesson attendance grade will be a 0, as will your weekly assignment grade if you are not there when it happens. If you have a legitimate reason to miss class (e.g. medical emergency, family strife), email me within 24 hours of next class, and I will work with you to make up missed work in a way that will not harm your grade. If you arrive late to class after I have taken attendance (usually sometime in the first 5 minutes of class), that day's lesson attendance grade will drop by 20%. If you arrive after the first 10 minutes of class, you will be marked as absent and will receive a 0 for that day's lesson attendance grade, though you will still be graded normally on your assignments, so it is beneficial for you to come anyways.

If you feel overwhelmed in any way, or if you are dealing with something that is causing you to miss a significant amount of class, the best thing to do is speak with me as soon as possible. Do not wait until the end of the semester when grades are published.

COURSE SCHEDULE (Subject to adjustment throughout semester)

Weeks 1-4: Scales, Prepared Choral Score

Weeks 5-8: Reading & Accompanying, Stylistic Comping to lead sheets

Weeks 8-12: Transposition

Weeks 12-16: Extra Jazz info that can be useful, ie. Solo piano practices, voicings, rhythmic study

Undergraduates

A student must maintain Satisfactory Academic Progress (SAP) to continue to receive financial aid. Students must maintain a minimum 2.0 cumulative GPA in addition to successfully completing a required number of credit hours based on total hours registered. Students cannot exceed attempted

credit hours above 150% of their required degree plan. If a student does not maintain the required standards, the student may lose their financial aid eligibility.

Students holding music scholarships must maintain a minimum 2.5 overall cumulative GPA and 3.0 cumulative GPA in music courses.

If at any point you consider dropping this or any other course, please be advised that the decision to do so may have the potential to affect your current and future financial aid eligibility.
