Principles of teaching social studies in primary and elementary school. Students observe social studies instruction and materials in real settings, apply principles of social studies instruction in classroom settings and experience first-hand the scope and sequence of the curriculum in a school setting. Course contains a field experience requirement.

- Plan for interdisciplinary social studies inquiry that engages young learners from diverse backgrounds and integrates technology;

- Commit to integrating social studies instruction into your future practice.

- **Book Club** (25): Students will form book clubs and will meet throughout the semester to discuss an assigned text. You will be evaluated on your attendance and effort during book club meetings, the quality of your book club journal entries, and the final product. You will meet with your book club in class throughout the semester.
- Mini Inquiry Design Model unit plan (30): Because social studies is often integrated with language arts (or other content areas) within the elementary classroom, this portion of the assignment is meant to provide practice designing meaningful integration. You will create a novel (meaning new and not copied from the Internet or any other source) comprehensive resource unit that reflects a theme or topic appropriate for an elementary grade level. The unit should be coherent and unified in concept, not disparate lessons "stuck" together. The unit should be integrated with other content areas, but it must foremost be teaching and assessing social studies content. It must be in the template provided. Use maps, timelines, primary sources and other online resources as tools to teach content, not as the basis for a complete lesson. You must first select the grade level, and then pick a topic or theme that is appropriate for your selected audience. Begin your unit with an engaging title and identify the target audience. The completed unit must include an IDM template that will outline the inquiry. It must include your compelling and supporting questions, featured sources, formative and summative performance tasks, and task informed action for the unit. Find examples on C3Teachers.org and make a copy of the IDM template here.
- Journey Box (25): You will create a modified digital 'journey box' (see Labbo & Field, 1999), which is a collection of primary sources and Document Based Questions (DBQs) that attends to a topic in social studies that is not often explored or taught at the K-8 level. Your journey box must include a specific collection of primary sources that highlights 2 photos, 2 participant accounts (quotes, letters, or journal entries), and 2

artifacts that depict the historical figure or event through multiple perspectives. Each primary source should be accompanied by 3 DBQs, a citation (website where you found the primary source), provide some context for the primary source (give the readers some clues), and include a one-page (double spaced) narrative that you have written.

Participation and Professionalism (20): Conduct throughout the semester as well as completing each assignment, module, activity, and readings.
