Special Problems: Advanced Topics in Arabic: The Israeli-Palestinian Conflict Fall 2021

Course Description

This course is designed for students who have had at least four semesters of Arabic instruction. It explores the complex origins, history, and perceptions of the conflict between Israel and Palestine. Students will evaluate key historical milestones and investigate their modern consequences. This course will provide a deeper understanding of the perspectives of both Israelis and Palestinians, as well as a greater insight into the possible conditions that may bring about a resolution between them. During the semester, students are expected to work on a lengthy research project and on building the required vocabulary to be able to discuss the researched topic.

Vocabulary lists (15%)

- Throughout the semester, the student will be compiling a vocabulary list on google doc where new words or expressions are added throughout the semester. A list of a minimum of 12 words must be emailed to the instructor bi-weekly by Saturday at 8 pm. Please email your first list by the fourth Saturday of the semester.
- Vocabulary lists must include words or expressions that are important to know for your research paper or that you came across in your readings.
 - o For nouns, please provide singular and plural forms.
 - For verbs, please list past, the present and gerund (MaSdar) forms and the preposition when necessary. Pay attention to MaSdar patterns as you will need to list the verb in the past and the present along with the MaSdar.

- You are encouraged to consult the Hans Wehr dictionary when compiling your list. <u>Here</u> is a link to the website
- Your instructor will provide feedback on your list. You must make any required changes along with your next list. Vocabulary lists will be graded on a scale of 1 to 12. Students will be graded on:
 - Choice of words included on the list. Students will need to judiciously include words that are relevant for their topic and necessary to express

their ideas. Students are encouraged to express their ideas using previously learnt vocabulary. Only include on your list vocabulary words you absolutely need to learn for your topic and avoid including words you could have expressed with vocabulary you have previously learnt.

- Corrections made to the previous list.
- o accuracy of the words listed and the forms required.

Drafts of research paper (15%)

- The research paper is approximately 1500 words long and will explore the complex origin, history, and perceptions of the Israeli-Palestinian Conflict. It will require research and a bibliography.
- The writing is not a one-step process; rather, it will be based on several drafts which will be edited and polished up until the submission of the final version. Students are expected to email the instructor five progressive writing drafts throughout the semester.
 - o First draft (minimum of 300 words): due by Saturday 8 pm of week 3.
 - Second draft (minimum of 600 words): due by Saturday 8 pm of week 5.
 - Third draft (minimum of 900 words): due by Saturday 8 pm of week 7.
 - o Fourth draft (minimum of 1200 words) is due by Saturday 8 pm of week 9.
 - Fifth draft (approximately 1500 words) is due by Saturday 8 pm of week
 12.

Vocabulary quizzes (15%)

- You are expected to study and use the words and expressions compiled in your vocabulary list
- Two vocabulary quizzes will take place during the semester. The first quiz is during week 8 and the second one is during week 11. Contact your instructor to schedule the quiz at a convenient time.

Presentation (15%)

 During week 13, students are expected to deliver a 10 minute presentation about their research paper. Students are expected to incorporate a majority of the vocabulary learned throughout the semester (from their personal vocabulary list) in the presentation.

Research paper (40%)

The revised draft of the research paper is due on Canvas by December 10 at 8 pm

- Week 1: Paragraph about your research topic in English
- Week 2: Email the instructor a preliminary bibliography for your paper. Two of your sources must be in Arabic; they do NOT need to be scholarly. Two sources must be in English and must be scholarly.
- Week 3: First draft (minimum 300 words) due on Canvas
- Week 4: First list of vocabulary; share the google doc link on canvas. Please make sure your instructor has permission to edit the document.
- Week 5: Second draft (minimum 600 words)
- Week 6: Second list of vocabulary due
- Week 7: Third draft (minimum 900 words)
- Week 8: Quiz 1 (Vocabulary of first and second lists); third list of vocabulary due
- Week 9: Fourth draft of the paper due (minimum 1200 words)
- Week 10: Fourth list of vocabulary due
- Week 11: Quiz 2 (All the vocabulary covered in all 4 lists)
- Week 12: Fifth draft of the paper due (minimum 1500 words; this draft must include your concluding paragraph/s)
- Week 13: Presentation
- Dec 10: Revised draft due on Canvas by 8 pm
