# Special Problems: Advanced Topics in Arabic: Implications of the Syrian Civil War Fall 2020

### **Course Description**

This course is designed for students who have had at least four semesters of Arabic instruction. It explores factors leading to civil protests and disobedience in Syria beginning in 2011, as well as events and reactions that led to the outbreak of civil war in 2012. This paper will examine social, political, and economic stressors that created the conditions necessary for protest and violence. Finally, this paper will discuss implications of civil conflict on Syria's future. Throughout the semester, the student is expected to work on a lengthy research project and on building the required vocabulary to be able to discuss the researched topic.

#### Vocabulary lists (20%)

- Throughout the semester, the student will be compiling a vocabulary list on google doc where new words or expressions are added throughout the semester. A list of a minimum of 12 words must be emailed to the instructor bi-weekly by Saturday at 8 pm. Please email your first list by the third Friday of the semester.
- Vocabulary lists must include words or expressions that are important to know for your research paper or that you came across in your readings.
  - o For nouns, please provide singular and plural forms.
  - o For verbs, please list past, the present and gerund (MaSdar) forms and the preposition when necessary. Pay attention to MaSdar patterns as you will need to list the verb in the past and the present along with the MaSdar.

 Your instructor will give you feedback on your list. You must make any required changes before you submit your next list. Please submit a print out of the previous list of vocabulary (to show that you have made any necessary changes) along with your new list.

#### Quizzes (20%)

- You are expected to study and use the words and expressions compiled in your vocabulary list; they will be included in the quizzes.
- Two vocabulary quizzes will take place during the semester. The first quiz is during week 8 and the second one is during week 12.

#### Presentation (10%)

• After the paper is written and submitted (during week 12), the student is expected to deliver an 8 to 10 minute presentation about their research paper. It is expected that the student uses a majority of the vocabulary learned throughout the semester (from their personal vocabulary list) in the presentation.

#### Research paper (50%)

- The research paper is approximately 2000 words long and will explore intricacies relating to the Syrian Civil War which began in 2012 as well potential ramifications for the state. It will require research and a bibliography.
- It is not a one-step process; rather, it will be based on several drafts which will be edited and polished up until the submission of the final version due on December 11th. The student is expected to email the instructor three progressive writing drafts throughout the semester that show the student's research and progress in writing.
  - First draft (minimum of 500 words): due by Saturday 8 pm of week 4.
  - Second draft (minimum of 1000 words): due by Saturday 8 pm of week 6.
  - o Third draft (minimum of 1500 words): due by Saturday 8 pm of week 8.
  - Paper (approximately 2000 words) is due by Saturday 8 pm of week 10.
