Course Prerequisites or Other Restrictions

This course is only for students who are TSI incomplete in math. Students enrolled in UGMT 1300.761 must also be enrolled in Math 1100.760.

Course Grades

<u>Grading</u>

This course is graded Pass/No Pass (P/NP). A grade of Pass (P) will be assigned to students who score 60% or more in the accompanying lecture course (Math 1100.760). A grade of No Pass (NP) will be assigned to students who score less than 70% in the lecture course (Math 1100.760). Students with a grade of Pass (P) in this course will fulfill their TSI requirement for math.

Attendance Policy
