# **Course Description**

This course will provide an overview of fashion as art and as an industry, including manufacturing processes, terminology and line organization. Principles and elements of design as applied to fashion.

#### Course Structure

This course is offered only through an online modality (considered 100% remote), without any scheduled live zoom sessions or in-person face-to-face teaching. This course is scheduled for sixteen weeks, and the number of units/modules in the course and includes fifteen modules.

# **Course Objectives**

Upon successful completion of this course, learners will be able to:

- 1. Identify areas of the fashion design industry and outline the different stages of the apparel design and retail cycle.
- 2. Understand and employ industry standard vocabulary regarding garments, textiles, and

- construction techniques.
- 3. Explain the difference between fashion design and fashion merchandising.
- 4. Research and design a conceptual collection based on a designated client, and present using industry standard presentation formatting.
- 5. Analyze emerging developments in the fashion design industry in design, textiles, technology, and sustainability.

#### Assessment

The assessments in this course consist of quizzes, a mid-term and final exam, a series of discussion posts, and three projects. A comprehensive breakdown of the grading point allocation will be provided along with the assignment instructions.

- 8 Quizzes (120 points, 24% of total)
- 8 Discussion Boards (80 points, 16% of total)
- 3 Projects (100 points, 20% of total)
- Mid-Term exam and Final Exam (200 points, 40% of total)

#### Grading

Your grade will be based upon the percentage of total points that the student accumulates from assigned activities/exams. Specific grading criteria for each project and assignment will be provided with the project instructions. Your grade is NOT based on the amount of time and/or effort you spent working on perfecting a skill, rather it is based on the degree to which the final product meets the established guidelines (on each project's rubric). The instructor of record determines all grades for each project, in class work, and attendance. For students who are intending to apply for the Fashion Design program, a final grade of "C" or higher is needed to proceed in the program.

- A: 90 100% (Outstanding, excellent work. The student performs well above the minimum criteria.)
- B: 80 89% (Good, impressive work. The student performs above the minimum criteria.)
- C: 70 79% (Solid, college-level work. The student meets the criteria of the assignment.)

- F: 59% or below (Sub-par work. The student fails to complete the assignment.)

- Failure to use correct file naming convention will result in a reduction of 5 to 10 points from that assignment.
