COURSE MATERIALS

We will continue using www.dddgerman.org for our online textbook. In German 1020, we will be covering the next 5 chapters (Kapitel/Inhalte 6 through 10).

If you already used dddgerman.org last semester, you do not need to sign up for a new account. Keep using the one you set up last semester. If you have never used dddgerman.org, you need to sign up for an account using your UNT (University of North Texas) email. Instructions for signing up for an account are shared and uploaded to Canvas by your instructor.

Please follow these instructions carefully! Canvas shall serve as the primary form of communication so please check for announcements there daily.

COURSE Prerequisites

The prerequisite for this course is the successful completion of Germ 1010 or the equivalent.

COURSE DESCRIPTION AND OBJECTIVES

German 1020 (Beginning German II) is instructed in-person. The focus of this course is to continue to build a solid foundation in the language by emphasizing vocabulary and pronunciation, speaking/communication, grammar, listening comprehension, reading, and writing.

WHAT CAN YOU EXPECT FROM THIS COURSE?

You can expect to continue building your German language skills and learn about German culture. The course is designed to help you achieve a good foundation of German through visual and audio learning, reading, and writing assignments, interactive peer-work, and drill exercises.

REQUIREMENTS FOR THIS COURSE:

1. **(READING) MATERIAL AND HOMEWORK** will be assigned daily by the instructor from the online textbook (www.dddgerman.org) and announced at the end of each class. Students will hand in the homework when they walk into the classroom. No online submission of homework is accepted. Note that no late homework will be accepted. Two homework assignments will be dropped at the end of the semester so you can miss two without it affecting your grade.

2. **LAB** assignments are part of Germ 1020 and are assigned from the online textbook as well (Interaktionen II). They will be submitted online. The assignments are listed in the tentative schedule below. They are due weekly on Mondays at midnight (week of Labor Day will be on Tuesday). The purpose of the lab component of the course is to review and reinforce the material of each chapter, and explore a little bit more about German culture. You have the opportunity to practice your language skills in the context of what has already been taught in class. Note that no late lab assignments will be accepted. One lab assignment will be dropped at the end of the semester so you can miss one without it affecting your grade.

3. **QUIZZES** will cover vocabulary and will be taken in class. There are two quizzes for each chapter (Kapitel/Inhalt). One quiz will cover vocabulary in Thema 1 und 2 and the next will cover vocabulary from Thema 3 and 4, which means that there will be 10 quizzes in all. It is therefore imperative that you keep up with your studies on a consistent basis. Each *Wortschatz* offers *quizlet* practices on the bottom of the page. Quizzes are indicated in the tentative schedule below and will be announced in class. Note: There will be NO make-up quizzes. **The lowest scored quiz will be dropped at the end of the semester.**

4. **CHAPTER TESTS** will cover vocabulary and grammar. They will be taken in class. There will be two tests: one over chapters (*Inhalte*) 1 and 2 and one over chapters (*Inhalte*)

3 and 4. There will be NO make-up tests unless cleared with the instructor beforehand.

5. **ORAL EXAMS** There will be a midterm and a final oral exam (see tentative schedule below). Detailed guidelines on the oral exams will be provided by the instructor and posted on Canvas.

6. **THE FINAL EXAM** is comprehensive (with an emphasis on chapter 10). Taking the final exam is mandatory to receive a passing grade.

8. **ATTENDANCE/PARTICIPATION** Since this course is instructed in person, you will need to attend all your classes. There is no Zoom option. Attendance in person is mandatory. Regular attendance is required. **Repeated unexcused absences and tardiness will affect your grade significantly.** Three tardies is the equivalent of one absence. Leaving class before the end of the period will be considered an absence. You are allowed a maximum of two unexcused absences without penalty. After two absences, your attendance grade will suffer. After the twelfth absence, you will receive a failing grade for the entire class. Excused absences are only: A.) illness with doctor's documentation, B.) official university sponsored activities, and C.) the observance of certain religious holidays. Consistent participation in class is also part of this grade.
