

# Journalism 3700.001/2 -- Photojournalism Spring 2020

## Course Goals and Outcomes

This course introduces students to the history, prominent forms, styles, practitioners, techniques, practice and ethical concerns of professional photojournalism. We will also explore thematic and narrative visual constructions. Students will develop a vocabulary for critique of visual communication in general and photojournalism in particular. Students will assemble a collection of original images that may be used as a professional photographic portfolio.

## Required Equipment

Sufficient capture cards for 300 high-resolution images

Self-powered portable hard drive or USB flash storage (minimum 4Gb)

Furthermore each student must arrange for a secondary file backup system on a separate file storage device. It is the student's responsibility to back up his or her work in progress. I will not accept flash storage or hard drive loss or failure as an excuse for failure to complete a project on deadline.

*(Please read that last sentence again – this time with a shudder.)*

## Recommended Equipment

Digital full manual control camera with multiple lens focal lengths: wide, normal, and some telephoto. *All photos must be shot with cameras which have full manual ISO, aperture & shutter speed adjustment controls. (Not all assignments will require full manual settings, but your camera must have the option.)*

## Optional software

We use Photoshop and Photo Mechanic extensively in this class. The classroom computers and lab computers have this software. You may find it useful to have this software on your own computer. Adobe (Photoshop) has very reasonable monthly student fees for its software. Students can run Photo Mechanic on a free demo license for 21 days: <http://www.camerabits.com/products/>

## Workload and Grading

This is a heavy-workload course. It involves a great deal of shockingly time-consuming photography and printing, almost weekly written critiques, detailed reporting and caption writing, and out-of-class research. You will be graded on your writing skills as well as your photography skills. The course will require some facility with computers for processing of photography and audio and transmission of those files. The course will also likely require learning new computer software, largely on your own time, including Adobe Photoshop, Adobe Premiere, Final Cut Pro X, or Soundslides.

Your cumulative grade will be determined by your individual grades in roughly the following manner (percentages may be adjusted slightly as the course proceeds):

50% -- Numerous Individual Photo Assignments

25% -- Photo Essay / Photo Story Multi-picture Audio Slideshow Project

15% -- "Day in the Life" Audio Slideshow Assignment

5% -- History of Photojournalism Test

5% -- Unannounced Quizzes, Spot Checks, and Class Participation

Note: One (and only one) assignment may be resubmitted for a potentially higher grade, but only if the original assignment was handed in on time.

## Deadlines

Rock Solid deadlines are a fact of life for journalists. If you can't meet deadlines then you are in the wrong field. If you know at least two days ahead of time that *due to extraordinary circumstances* you can't meet a deadline then contact me immediately and we may be able to arrange an alternate deadline for you. Otherwise, the first individual assignment turned in late will be penalized by the equivalent of one letter grade. The second late assignment will be penalized by the equivalent of two letter grades, and so on. Of this harsh policy I'd like to say "this is going to hurt me more than it is going to hurt you," but that wouldn't be true.

### **First Assignment – Part I – Assignment Slug: firstevent**

This week attend and photograph one *interesting* event on or off campus using any camera you have access to. *Newsworthy* events will get you extra credit. "Behind the Scenes" photos are encouraged. Post one captioned photo to our online group by the start of the next class. Also submit the photo to the Journalism server at the start of our next class. Refer to the submission guidelines for further instruction on file sizing and naming.

*Values of newsworthiness: Timeliness, Proximity (Issue Localization), Novelty, Conflict, Prominence, Significance (Impact), Human Interest*

### **First Assignment – Part II – Assignment Slug: portfolio1**

Bring to next class a "portfolio" collection 3-8 photographs which is representative of your photography experience. The photos should be no greater than 1Mb each in file size. Points will be deducted for failure to meet the assignment criteria.

## Assignment Submission Guide for Photojournalism, JOUR 3700

All work you submit (except the portfolio presentation) must be your own original work created this semester. Photography you submit for an assignment must have been taken AFTER the assignment was made. You must be flexible in adapting to multiple forms of submission. All photography assignments will ultimately be submitted digitally through a direct file transfer to the Mayborn Journalism server. If you fail to submit to the Journalism server then you will not receive any credit for that assignment.

**If your photo is not on the Journalism server then, for grading purposes, it doesn't exist!**

**Number of Image Submissions per Assignment:** ONE

Unless specifically requested all assignment submissions must consist of ONE and ONLY ONE photograph.

Editing is one of the most valuable skills you must learn.

### Filesize and type

Digital submissions must be:

- \* JPEG format – Compression 12 (maximum quality / minimal compression)
- \* 1500 pixels on the longest dimension

### Filename

Unless otherwise specified, filenames must follow this convention

YYMMDDxxx\_YourName\_AssignmentSlug.jpg  
(where xxx is the unique sequence number)

### Caption Requirements

Captions must include a dateline, a credit line, and an informative caption in AP style with no mistakes in grammar or spelling.

## **EMBEDDED CAPTION**

A complete caption must be embedded in the "file info" of each image you submit. Missing captions will result in a loss of a letter grade for that assignment.

### **Caption Style and Format of Caption:**

Captions typically begin with a present-tense sentence with critical identification information and a description of what's happening in the photograph. Subsequent sentences, written in AP style and usually (but not always) in the past tense, give secondary identification, supplementary information, and contextual information which indicates the news, thematic, or narrative value of the image.

The format for captions for this class will be as follows:

Dateline MM/DD/YYYY

Caption information appears in complete sentences.

Credit: Your Name

### **For Example:**

Najaf, Iraq 08/27/04

A lone man walks through a decimated business and residential street west of the Imam Ali shrine in Najaf. The street was a front line fighting position for American army and Mehdi Militia fighters during a nearly three-week battle that left much of the old city of Najaf and surrounding neighborhoods in ruins. An agreement was reached yesterday for the withdrawal of Moqtada al-Sadr's Mehdi Militia from Najaf and, for the first time in three weeks, residents were able to check up on their homes and businesses in the battle ground. The shrine is at the center of an American siege of the old city of Najaf where Mehdi Militia fighters loyal to Moqtada al-Sadr staged a rebellion against the Iraqi government and American military occupation.

## **MSOJ Syllabus Statements**

### **JOURNALISM REQUIREMENTS & GUIDELINES**

#### **(Statement for JOUR 1210, 2000, 2300 and 2310 syllabi only)**

For journalism majors, not minors: This is a foundational class. Once you have completed all foundational requirements you will have access to upper-level journalism courses after visiting the Office of Student Advising. If you have questions about what your foundational requirements are, please see an adviser.

#### **(Statements for all JOUR courses)**

#### **JOURNALISM COURSE REGISTRATION**

1. Registration will begin on the dates noted in the schedule of classes each semester. The system is a live, first come/first serve program.
2. By registering for this course, you are stating that you have taken the required prerequisites according to your catalog year and major/minor status. If the instructor later determines that you haven't taken and passed these requirements, then you may be dropped at any point in the semester. If you have questions about your prerequisites, please see an advisor.
3. A journalism major enrolled in any restricted 3000 and 4000 level classes must have taken and passed the GSP test and all foundational courses. Students must earn and maintain a 2.5 UNT and/or overall GPA (depending upon catalog year) to be eligible for major-level courses.

#### **RE-TAKING FAILED JOURNALISM CLASSES**

Students will not be allowed to automatically take a failed journalism course more than two times. Once you have failed a journalism course twice, you will not be allowed to enroll in that course for one calendar year after the date you received the second failing grade. Once a student has waited one calendar year after failing a course twice, the student may submit a written appeal to the director to be approved to enroll a third time. Students will not be allowed to re-take a failed journalism course more than three times.

#### **TEXTBOOK POLICY**

The Mayborn School of Journalism doesn't require students to purchase textbooks from the University Bookstore. Many are available through other bookstores or online.

One absence in the course is the limit without penalty toward your final grade, unless you have communicated with me from the beginning about an extraordinary problem. Coming to class late or leaving early may constitute an absence for that day. This is a seminar course, and it requires your attendance and participation each class meeting.

### **FINANCIAL AID SATISFACTORY ACADEMIC PROGRESS (SAP) UNDERGRADUATES**

A student must maintain Satisfactory Academic Progress (SAP) to continue to receive financial aid. Students must maintain a minimum 2.0 cumulative GPA in addition to successfully completing a required number of credit hours based on total registered hours per semester. Students cannot exceed attempted credit hours above 150% of their required degree plan. If a student does not maintain the required standards, the student may lose financial aid eligibility.



The school's policy aligns with UNT Policy 06.003 and requires reporting any act of academic dishonesty to the Office for Academic Integrity for investigation. If the student has a previous confirmed offense (whether the first offense was in the journalism school or another university department) and the student is found to have committed another offense, the department will request the additional sanction of removing the student from the Mayborn School of Journalism. The student may appeal to the Office for Academic Integrity, which ensures due process and allows the student to remain in class pending the appeal.

Any MSOJ equivalent course from another university must receive prior approval from the MSOJ academic advisor to insure that all MSOJ degree plan requirements are met. For example, courses that are taken online or from a program that offers course material via CD, booklet, or other manner of correspondence must have prior advisor approval.

### **IMPORTANT NOTICE FOR F-1 STUDENTS TAKING DISTANCE EDUCATION COURSES**

To comply with immigration regulations, an F-1 visa holder within the United States may need to engage in an on-campus experiential component for this course. This component (which must be approved in advance by the instructor) can include activities such as taking an on-campus exam, participating in multiple on-campus lecture or lab activity, or other on-campus experience integral to the completion of this course.

If such an on-campus activity is required, it is the student's responsibility to do the following:

(1) Submit a written request to the instructor for an on-campus experiential component within one week of the start of the course.

(2) Ensure that the activity on campus takes place and the instructor documents it in writing with a notice sent to the International Advising Office. The UNT International Advising Office has a form available that you may use for this purpose.

**Because the decision may have serious immigration consequences, if an F-1 student is unsure about his or her need to participate in an on-campus experiential component for this course, students should contact the UNT International Advising Office (telephone 940-565-2195 or email [international@unt.edu](mailto:international@unt.edu)) to get clarification before the one-week deadline.**

### **EMERGENCY NOTIFICATION & PROCEDURES**

UNT uses a system called Eagle Alert to quickly notify you with critical information in an event of emergency (i.e., severe weather, campus closing, and health and public safety emergencies like chemical spills, fires, or violence). The system sends voice messages (and text messages upon permission) to the phones of all active faculty staff, and students.
