### German 4338: German Translation Spring 2023

Course Description: This course introduces basic techniques for translating texts from German to English. This course is designed to deepen your knowledge about the German language, the relationship between German and English, and the art and science of translation. Assignments will require you to translate various text types from German into English. You will need to explain and justify the decisions that you make as you create your translation. Language of instruction is English and German.

**Course Objectives:** By the end of this course, students will be able to:

- Understand basic concepts of translation
- Understand key issues and considerations in translation
- Understand formal properties of texts
- Compare German and English language systems
- Improve their knowledge of German vocabulary, grammar, and culture

**Course Prerequisite:** Successful completion of 3 hours of advanced German.

**Required Text:** *Thinking German Translation. A course in Translation Method: German to English.* Eds. Margaret Rogers and Michael White. Routledge. ISBN: 9781138920989.

You can purchase a copy of the book from the UNT Bookstore. I encourage you to choose the textbook option that fits best with your learning style and your budget.

<u>ADDITIONAL REQUIRED MATERIALS:</u> A laptop, iPad, tablet or other Wi-Fi enabled device should be brought to each class session.

#### COURSE REQUIREMENTS AND GRADE ASSESSMENT

1. Participation (15%): Students are expected to participate actively in class discussions and to prepare the readings and written assignments prior to each class. Class participation, effort, attentiveness, preparation, responsibility, and, in general, active and constructive involvement in all aspects of the course will be graded by the instructor. Please refrain from the following: late arrival, early departure, cell phone/laptop usage unrelated to class work. When you are absent, it is YOUR responsibility to obtain the day's assignment (by consulting the syllabus, a classmate and/or Canvas).

Attendance: Students are expected to attend class meetings regularly. If you do not attend, you cannot participate actively in the class discussions and conversations, which will affect your overall participation grade. It is important that you communicate with the professor **prior** to being absent, so you and the professor can discuss and mitigate the impact of the absence on your attainment of course learning goals. Please inform the professor if you are unable to attend class meetings because you are ill, in mindfulness of the health and safety of everyone in our community.

2. Homework assignments (30%): Homework assignments will derive from the exercises in the textbook as well as short translation activities beyond the information in the textbook. Assignments should be prepared prior to class as they will also form the basis of class discussions and group work.

- 3. Quizzes (15%): There will be weekly quizzes based on the assigned readings.
- 4. Translation project (40%): Students will select a text in German that they will translate into English. The text should be approximately 1000 words in length, and may derive from any genre (literature, scientific text, consumer text) and medium (print or web). Students will be required to work through several stages of the project: translation project proposal; outline of translation strategy (including purpose and audience); draft translation; detailed discussion of the decisions made in the translation; translated text; and information about the text and author (to be written in German).

#### **Project Development Stages (Deadlines noted below)**

Translation Project Proposal Identification of text type (5%). Students should write a 200-word proposal in German that describes the translation project they wish to undertake. The proposal must identify the text type/genre and medium. **Due: February 15.** 

Outline of Translation Strategy (10%). Students will submit a detailed outline of the strategies they will use to complete the translation, including identifying the purpose of the translation. Due: March 22.

**Draft Translation (5%).** At week 13, students will submit a draft of the translation. Students should feel free to identify specific problems/ questions in the draft. The instructor will return the drafts with comments and suggestions for revisions. Students can also schedule consultation meetings with the instructor. **Due: April 19.** 

Translated Text and detailed justification (15%). Students will submit a revised/final version of the translation along with a detailed justification for the specific decisions they made in the translation. Students should attempt to address all comments and suggestions from the draft. **Due: May 10 at 4 pm.** 

**Author and text information (5%).** Students will write a 2-page summary about the text and its author **in German**, including biographic information about the author and an explanation of the text's historical importance/context. **Due: May 10 at 4 pm.**

#### General course and university guidelines

**Canvas**: All course assignments and materials will be posted on the course Canvas site. Assignments that cannot be submitted via Canvas should be turned in during class.

**Communication Expectations:** The instructor will communicate with students through Canvas Announcements and through UNT e-mail. All e-mail will be sent to students' UNT e-mail accounts. It is the students' responsibility to check UNT e-mail regularly or have UNT e-mail forwarded to another account. In addition, the instructor will only respond to student e-mail if it is sent from the official UNT account. Any messages sent Monday-Friday will be answered within two days.

**Cell phones and laptops**: The instructor utilizes technology and other media in the learning process. All students are expected to bring a Wi-Fi-enabled device (cell phone, iPad, tablet, or laptop) to every class to facilitate collaborative work.

**Religious holidays**: In accordance with Section 51.911 of the Texas Education Code, UNT will allow a student who is absent from class for observance of a religious holy day to take an examination or complete an assignment scheduled for that day within a reasonable time. Students are required to file a written request with each professor within the first 15 days of the semester to qualify for an excused absence. A copy of the state rules and procedures regarding holy days and the form for notification of absence from each class under this provision are available from the Registrar's Office.

Disability accommodation: The University of North Texas makes reasonable academic accommodation for students with disabilities. Students seeking reasonable accommodation must first register with the Office of Disability Access (ODA) to verify their eligibility.
