## 1. COURSE INFORMATION

**COURSE DESCRIPTION**

Students in this course will build on skills developed in previous design courses to concept, develop, and execute a multifaceted packaging design system, supported by a professional packaging design guide, a client presentation and production handoff.

**COURSE OBJECTIVES**

In this course students will learn or improve in

**1. Research**

- Company profile
- Product segment, market competition, and retail environment
- Target-audience analysis including consumer demographics, psychology and persona
- Packaging construction, material, and production
- Environmental and ethical considerations

**2. Conceptual process and strategic thinking**

- Communication design processes, creative problem-solving methodologies, iterative process, and system thinking

**3. Development of effective integrated packaging solutions**

- Typography, image, color, and composition
- Consumer psychology and emotional connection
- Cohesive branding and logical system
- Production mechanical

**4. Creating professional client and portfolio presentation of**

- Design, system, and details of the packaging
- Intended retail context, target customer, and display effect
- Polished digital mockup and photography

**5. Professionalism**

- Presentation and defense skills
- Efficient working habits and professional attitudes
- Participate in class critiques
- Proficiency with terminology, history and concepts in three dimensional design
- Effective communication—positive, solution based, clear, and honest

**COURSE STRUCTURE**

- This class is structured as a studio course and focused on assigned projects.
- Class time will be dedicated to discussions, brainstorming, and critiques—both one-on-one and in group. Students also will spend class time working on their assignments.
- Working on projects from other classes are strictly prohibited.
- Students are expected to spend substantial time outside of class to complete their homework.

**PROJECT AND TIME MANAGEMENT**

Students will work on multiple projects or tasks simultaneously throughout the semester. They are responsible for independently managing their time and projects. Students are expected to bring homework to each class in an organized and professional manner, prepared for critique.

**PROJECTS AND GRADING WEIGHTS**

1. Assignment 1: Handbuilt Mockup—Personoan Packaging	10%
2. Assignment 2: Core Package Redesign (2-3 packages in a series)	50%
3. Assignment 3: Complete System (2 packages)	30%
4. Assignment 4: Client Presentation	10%

Your final grade will be based on an average of all assignments in the given percentages, and affected by attendance (as described in the attendance policy – attached), daily deadline performance and participation.

**WORK SUBMISSION**

Submissions for assignments include hand-built models, presentation banners, process documents, and design files. Specific deliverables will be stated in each assignment.

**FILE NAMING**

All final files must be clearly labeled when uploaded on the date they are due. Any modification to files after the due date should be labeled as a REVISION.

**ASSESSMENT**

Your final grade is based on the average of scores accumulated throughout the semester. Final grades are rounded to the nearest 10th of a point. Rubrics and specifications are to be provided for each assignment, but assessment is primarily based on four categories:

**1. Participation**

Respect classmates by listening and participating, especially in critiques. Your opinion is valuable! Points are docked for sleeping, texting, working on other class work, or using social media in class.

**2. Professionalism**

Everything turned in represents you, so make it good and do your best. Keep files organized, and clearly label uploads with your name. Keep up with attendance, and don't be late to critiques.

**3. Concept**

This is what it's all about. Apply research, and push yourself toward a unique and logical approach. Refine your work throughout a project's progression. Use demos/feedback, and revise projects as needed. Include thorough process documentation as requested. Keep everything!

**4. Design**

Create compelling visuals based on clearly defined purpose and unique concept. Meet all specifications, including size, format, etc. as outlined for each assignment. Visual decisions should all address the problem posed in the assignment prompt. Closely follow instructions: double- and triple-check those handouts!

### AI POLICY

Certain assignments in this course may allow or even encourage the use of generative artificial intelligence (GAI) tools. Discuss with the professor beforehand if you intend to use AI. When permitted, any use of GAI tools must be appropriately acknowledged and cited. You are obligated to evaluate the legitimacy and applicability of any GAI output that you use in your work. Violations of this policy will be considered plagiarism. Different classes at CVAD and UNT may implement different AI policies. It's your responsibility to understand and conform to expectations for each course.

### PLAGIARISM

Plagiarism is a serious academic offense and may result in failure of an assignment, the class, or result in removal from the university. Students caught cheating or plagiarizing will receive a "0" for that particular assignment or exam. The student will first be notified in writing via email to schedule a face-to-face meeting with the instructor and another faculty member to determine the next level of action. If further action is warranted, the incident will be reported to the Dean of Students, who may

Copying someone else's writing or art, intact or with inconsequential changes, and adding one's name to the result constitutes plagiarism.

**RISK FACTOR**

Risk Factor: 2. In level 2 courses, students are exposed to some significant hazards but are not likely to suffer serious bodily injury. In this class those risks are related to x-acto knife usage, adhesives, fumes and repetitive stress injuries related to extended computer use. Students will be informed of any potential health hazards or potential bodily injury connected with the use of any materials and/or processes and will be instructed how to proceed without danger to themselves or others."

**IMPORTANT NOTICE FOR F-1 STUDENTS TAKING DISTANCE EDUCATION COURSES****Federal Regulation**

To read detailed Immigration and Customs Enforcement regulations for F-1 students taking online courses, please go to the Electronic Code of Federal Regulations website (<http://www.ecfr.gov/>). The specific portion concerning distance education courses is located at Title 8 CFR 214.2 Paragraph (f)(6)(i)(G).

(G) For F-1 students enrolled in classes for credit or classroom hours, no more than the equivalent of one class or three credits per session, term, semester, trimester, or quarter may be counted toward the full course of study requirement if the class is taken on-line or through distance education and does not require the student's physical attendance for classes, examination or other purposes integral to completion of the class. An on-line or distance education course is a course that is offered principally through the use of television, audio, or computer transmission including open broadcast, closed circuit, cable, microwave, or satellite, audio conferencing, or computer conferencing. If the F-1 student's course of study is in a language study program, no on-line or distance education classes may be considered to count toward a student's full course of study requirement.

**UNIVERSITY OF NORTH TEXAS COMPLIANCE**

To comply with immigration regulations, an F-1 visa holder within the United States may need to engage in an on-campus experiential component for this course. This component (which must be

approved in advance by the instructor) can include activities such as taking an on-campus exam, participating in an on-campus lecture or lab activity, or other on-campus experience integral to the completion of this course.
