SECTION 1 Course Information

COURSE DESCRIPTION

In this course, students will practice developing brand identity and promotional campaigns to help clients reach their business goals. This work will be among the most important parts of your portfolio. You will develop campaign strategies and creative solutions targeting specific customer groups. You will apply and improve the design skills learned in previous courses to produce high-level, aesthetically refined design. Equally important, you should push originality and out-of-the-box solutions.

COURSE OBJECTIVES

1. Learn the fundamentals of brand identity and promotional campaigns.
2. Manage the process of developing brand identity and promotional campaigns.
3. Create campaigns that showcase students' best capabilities in concept, strategy, and design.
4. Complete strong works for design competitions and the job search portfolio.
5. Continue developing professionalism in project management, presentation, and delivery to prepare for the workplace.

COURSE STRUCTURE

This class is structured as a studio course and focused on assigned projects. Class time will be dedicated to discussions, brainstorming, and critiques—both individual and group. Students are expected to spend substantial time outside of class to complete their homework.

- Students are expected to apply the knowledge, skills, tools, and methodologies they have learned in the Communication Design program for creative problem-solving.
- Students are expected to work at an advanced level of strategic thinking, creative problem-solving, and production.
- The student assumes the role of initiator, account executive, creative director, and designer at various stages of the process. The instructor acts as a guide, creative director or client when appropriate.
- Your peers will provide the substantial amount of feedback on your work. Conversely, they will rely on your input during critiques.
- To succeed in this course, each student must manage multiple projects and tasks at the same time.

COURSE CONTENT AND GRADING WEIGHTS

There are three projects, each a campaign with a different emphasis. Students together with and instructor will identify the subjects of the campaigns. Students will go through a comprehensive design process that includes discovery, concept development, strategy, and design.

AI POLICY

Certain assignments in this course may allow or even encourage the use of generative artificial intelligence (GAI) tools. Discuss with the professor beforehand if you intend to use AI. When permitted, any use of GAI tools must be appropriately acknowledged and cited. You are obligated to evaluate the legitimacy and applicability of any GAI output that you use in your work. Violations of this policy will be considered plagiarism. Different classes at CVAD and UNT may implement different AI policies. It's your responsibility to understand and conform to expectations for each course.

PLAGIARISM

Plagiarism is a serious academic offense and may result in failure of an assignment, the class, or result in removal from the university. Students caught cheating or plagiarizing will receive a "0" for that particular assignment or exam. The student will first be notified in writing via email to schedule a face-to-face meeting with the instructor and another faculty member to determine the next level of action. If further action is warranted, the incident will be reported to the Dean of Students, who may impose an additional penalty. According to the UNT catalog, the term "cheating" includes, but is not limited to: a. Use of any unauthorized assistance in taking quizzes, tests, or examinations; b. Plagiarism is also literary or artistic theft. It is the false assumption of authorship; the wrongful act of taking the product of another person's mind and presenting it as one's own. Copying someone else's writing or art, intact or with inconsequential changes, and adding one's name to the result constitutes plagiarism.

RISK FACTOR

Risk Factor: 2. In level 2 courses, students are exposed to some significant hazards but are not likely to suffer serious bodily injury. In this class those risks are related to x-acto knife usage, adhesives, fumes and repetitive stress injuries related to extended computer use. Students will be informed of any potential health hazards or potential bodily injury connected with the use of any materials and/or processes and will be instructed how to proceed without danger to themselves or others."

RIGHT INSTRUCTOR TO CHANGE SYLLABUS

The right to change this syllabus with or without notice remains at the discretion of the professor. Moreover, based on the fluid nature of the course, its ongoing classroom experiences and developing research activities, the professor may and will likely elect to change projects, learning experiences, outcomes, scheduling, assessment and in- and outside classroom activities during the semester. At his discretion, the professor will alert students to any changes if and when they are to occur and provide them with sufficient time to adjust their respective class and research activities. IMPORTANT NOTICE FOR F-1 STUDENTS TAKING DISTANCE EDUCATION COURSES

Federal Regulation

To read detailed Immigration and Customs Enforcement regulations for F-1 students taking online courses, please go to the Electronic Code of Federal Regulations website (<http://www.ecfr.gov/>). The specific portion concerning distance education courses is located at Title 8 CFR 214.2 Paragraph (f) (6) (i) (G).

The paragraph reads:

(G) For F-1 students enrolled in classes for credit or classroom hours, no more than the equivalent of one class or three credits per session, term, semester, trimester, or quarter may be counted toward the full course of study requirement if the class is taken on-line or through distance education and does not require the student's physical attendance for classes, examination or other purposes integral to completion of the class. An on-line or distance education course is a course that is offered principally through the use of television, audio, or computer transmission including open broadcast, closed circuit, cable, microwave, or satellite, audio conferencing, or computer conferencing. If the F-1 student's course of study is in a language study program, no on-line or distance education classes may be considered to count toward a student's full course of study requirement.

UNIVERSITY OF NORTH TEXAS COMPLIANCE

To comply with immigration regulations, an F-1 visa holder within the United States may need to engage in an on-campus experiential component for this course. This component (which must be approved in advance by the instructor) can include activities such as taking an on-campus exam, participating in an on-campus lecture or lab activity, or other on-campus experience integral to the

completion of this course.

If such an on-campus activity is required, it is the student's responsibility to do the following:

(1) Submit a written request to the instructor for an on-campus experiential component within one week of the start of the course.
