### Course Description

Spanish 3001 is an advanced conversation course for non-native speakers of Spanish who have successfully completed SPAN 2050 or its equivalent. This course will expand your vocabulary and improve your ability to read, comprehend, listen, and discuss a broad variety of topics in Spanish. Students will discuss events, present detailed arguments, and summarize information at a level appropriate to third-year students.

# Course Prerequisites

SPAN 2050 Intermediate Spanish II or equivalent from transfer credit or credit by exam.

Upon successful completion of this course, learners will be able to:

- 1. Demonstrate oral proficiency appropriate to third-year students
- 2. Demonstrate fluency and the ability to summarize information, present arguments, persuade, analyze, and interpret the opinions of others at a level appropriate to third-year students
- 3. Demonstrate vocabulary and grammar necessary to support and facilitate in-depth conversation and expression of opinions at a level appropriate to third-year students
- 4. Converse knowledgeably about the assigned readings, videoclips, and contribute to the topical discussions
- 5. Develop cultural awareness of the Spanish-speaking world appropriate to third-year students

# **Participation**

To achieve the highest possible personal level of proficiency in Spanish and to be successful in this course, it is necessary to come to each class focused on that goal. Students who perform the five basic tasks listed in the rubric below will be well on their way to being successful in communicating in Spanish. Additionally, students will see these efforts recognized and rewarded; class participation is a substantial portion of the course grade. Please note students must perform <u>all</u> five tasks listed in the rubric below to receive participation points. Students not meeting expectations for all five tasks listed in the rubric below will receive a zero (verbal/written warnings and reduced points may also be assigned according to the policy of the instructor).

#### Attendance

After the 4<sup>th</sup> absence, whether excused or unexcused, one percentage point (1%) per absence will be deducted from the student's final course grade.

# **Late Submission Policy**

Students can submit late assignments for credit.

Overdue VHL homework will be penalized -10% per day.

Overdue Participation, Video Journals, or Podcast assignments will be penalized -20% per day. Overdue Quizzes, Midterm or Final examinations, or Oral Tasks are not allowed (if you have special needs that may affect your attendance in this course, please speak with me after class, during office hours, or arrange an appointment to discuss your needs privately and arrange the accommodations).

#### **Student Issues with Instructors**

### **EXAMINATION POLICIES**

### **Midterm**

Students will engage in a 5-minute paired conversation. A random draw on the day of the exam will determine the topic of the conversation. The choices will be based on the topics covered up to the date of the midterm exam. Conversations will be graded on their content, grammar, vocabulary, pronunciation, and fluidity. You will have access to the actual rubric via Canvas.

### **Final**

Students will engage in a 8-minute paired conversation. A random draw on the day of the exam will determine the topic of this conversation. The choices will be based on the topics covered throughout the semester. Conversations will be graded on their content, grammar, vocabulary, pronunciation, and fluidity. You will have access to the actual rubric via Canvas.

### **ASSIGNMENTS**

#### VHL Homework

Homework will be assigned for each week with a due date of Friday at 11:59 p.m. Homework can include content (readings, videos, others) not covered in class. To access the online component of your textbook (VHL), you must create an account. If you already have an account, you log in as normal and find your Spanish course at <a href="https://www.vhlcentral.com">www.vhlcentral.com</a>

### **Quizzes**

There will be 5 quizzes at the end of the lessons. These will be based on the homework and material covered in class.

#### **Oral Tasks**

Students will complete two oral tasks in class. The presentations will be given during class time and will focus on a topic related to the themes, conversations, and grammar covered in the textbook *Revista*. The presentations must not be read and must meet the time requirements (between three and four minutes). Practice ahead of time. If using a PowerPoint presentation, students will be allowed one slide only with photos and no more than 10 words, in Spanish, on the slide. The grading rubrics for assessment of oral skills and any additional instructions will be

posted to Canvas. Students will be graded on their 1) organization, 2) content, 3) grammar, 4) pronunciation, and 5) fluidity.

### **Video Journals**

Each student will use Canvas to record a total of 3 video journals that address a different topic assigned from the chapters studied within the semester. Videos must be 2-3 minutes in length and must be turned in according to the directions of the instructor. Videos will be graded on their organization, content, grammar, pronunciation, and fluidity.

Set up a 3-minutes in-person meeting in Spanish with me during the first 3 weeks of classes and it will count as a video journal assignment. Email me for more details.

# **Hispanic Film Podcast**

Students will talk about a Hispanic film in an informal context. Audio files must be 16-20 minutes in length and must be turned in according to the directions of the instructor. The grading rubrics for assessment of oral skills and any additional instructions will be posted to Canvas. Students will be graded on their 1) organization, 2) content, 3) grammar, 4) pronunciation, and 5) fluidity.
