#### **COURSE DESCRIPTION:**

Training for the freshmen in the art of singing. Through weekly individual lessons and periodic studio classes, students will develop a healthy vocal technique, musicality and performance skills. This course emphasizes classical vocal repertoire, memorization, diction, self-confidence and expressive interpretation.

## **PRE-REQUISITES:**

None

# **COURSE REQUIREMENTS:**

Weekly individual lessons (50 min for 2 credit hours). Students are expected to attend all individual lessons prepared and ready to work. Exercises and repertoire will be based on the student's level and progress.

#### **STUDIO CLASS:**

Studio performance classes provides performance opportunities and peer feedback. Students enrolled in Applied Voice Lessons must attend a minimum of six studio classes (at least four with your private professor and two more with another professor and voice studio class). # PERFORMANCE REQUIREMENT:

Students must perform a minimum of 4 memorized pieces during the semester. At least 2 must be from the classical repertoire (operatic aria, art song, oratorio aria...) and the other may be another appropriate style, with professor's approval.

## **REPERTOIRE REQUIREMENT:**

Students must provide all translation and IPA transcriptions no longer than mid-september.

## **DEPARTMENTAL RECITALS:**

Departmental voice recitals are scheduled on selected at 4:00 pm. Attendance is mandatory. Tuesdays Attendance is required at all studio classes and departmental recitals. Students must inform in advance of any planned absences. A schedule listing all departmental recital meetings is available on CANVAS. concentrations students are required to submit a recital attendance record sheet with confirmed signatures of faculty present during each recital, by the end of the semester.

#### **JURY:**

Voice concentration students must perform a jury at the end of each semester, except the first year students in their first semester. The students in their 5<sup>th</sup> semester may choose to perform a recital rather than a jury.

## **GRADING EVALUATION:**

Lesson Attendance – 30% Studio Class Attendance – 20% Departmental Attendance – 20% Final Performance – 30%

#### ATTENDANCE POLICY:

Students are expected to attend class meetings as scheduled and stated by the attendance policy established for the course. It is important that you communicate with the professor and the instructional team prior to being absent, so you, the professor, and the instructional team can discuss and mitigate the impact of the absence on your attainment of course learning goals.

The College of Music has established THIRTEEN as the normal number of lessons per semester, and EIGHT as the minimum number of lessons a student must attend to

receive a passing grade. Therefore, students who have missed a total of SIX lessons, either excused or unexcused, will be asked to drop voice for the semester or receive a grade of F. A grade of "I" ("Incomplete") will only be given for verified reasons and with permission of the major professor. An Incomplete should not be given due to lack of preparation or simply needing more time. If you must miss a lesson, your teacher should be notified with at least 24 hours' notice. Students should not expect that a lesson will be made up if they cancel.

If a student misses two lessons without notification, the student will receive a "Notice of Unsatisfactory Progress" report. If an additional lesson is missed without notification, the student will be dropped with a F. Lessons missed by the teacher are always to be made up. If a studio teacher is missing an excessive number of lessons or if make-ups are not being offered in a timely manner, students should contact the Division Chair immediately.

Lessons that occur on official university holidays (e.g., Thanksgiving) do not have to be made up by your teacher nor do lessons that were scheduled for a day that the university is closed due to inclement weather, or lessons that the student misses due to ensemble rehearsals or trips.

**Financial Aid and Satisfactory Academic Progress** 

#### **UNDERGRADUATES**

A student must maintain Satisfactory Academic Progress (SAP) to continue to receive financial aid. Students must maintain a minimum 2.0 cumulative GPA in addition to successfully completing a required number of credit hours based on total hours registered. Students cannot exceed attempted credit hours above 150% of their required degree plan. If a student does not maintain the required standards, the student may lose their financial aid eligibility.

Students holding music scholarships must maintain a minimum 2.5 overall cumulative GPA and 3.0 cumulative GPA in music courses.

If at any point you consider dropping this or any other course, please be advised that the decision to do so may have the potential to affect your current and future financial aid eligibility. It is recommended that you to schedule a meeting with an academic advisor in your college or visit the Student Financial Aid and Scholarships office to discuss dropping a course before doing so.

## **GRADUATES**

A student must maintain Satisfactory Academic Progress (SAP) to continue to receive financial aid. Students must maintain a minimum 3.0 cumulative GPA in addition to successfully completing a required number of credit hours based on total registered hours per term. Music scholarships require a 3.5 cumulative GPA. Students cannot exceed maximum timeframes established based on the published length of the graduate program. If a student does not maintain the required standards, the student may lose their financial aid eligibility.

If at any point you consider dropping this or any other course, please be advised that the decision to do so may have the potential to affect your current and future financial aid eligibility. It is recommended you schedule a meeting with an academic advisor in your college, an advisor in UNT-International or visit the Student Financial Aid and Scholarships office to discuss dropping a course.
