Course Description:

This course involves planning, implementing, and evaluating a comprehensive worksite health promotion program in a corporate setting. The course will include the role of the health manager, and/or team, in developing worksite health promotion programs within a corporate setting.

Student Learning Objectives

- To identify and understand the economic forces affecting worksites.
- To demonstrate understanding of the front-end programming components such as identification, assessment, marketing and funding.
- To identify employee risk-reduction strategies and worksite health promotion program evaluation.
- To understand the advantages and disadvantages of health promotion in a corporate setting.

Assignments

Two Online Exams: Students will have **one hour** to complete each exam online. Waiting until the end of the exam time may not give you the full amount of time. Please use your time wisely! Team Project: The purpose of this project is to allow the student opportunities in planning and

developing an innovative idea for worksite health promotion. This project will require time and a maximum effort from each team member in order to develop an effective product. Teams will be assigned, then begin to decide on a corporation to target and begin developing ideas to improve the health of its employees. **The project is a proposal to begin a brand new or to improve an existing employee health program; the project can focus on a fictitious company or a currently existing business or company.** A budget page or pages should be included indicating the overall cost benefit and the program's economic advantage to the organization. Please note: You are expected to submit your assignments individually. Your group is allowed to use the same product, but each person must submit it. If you fail to submit your work, you will not get credit.

This project will consist of 6 assignments worth 50 points each.
