**Course Description** This course will introduce the student to the basic concepts of indexing and abstracting. While theoretical issues will be discussed, the emphasis will be on how-to-do-it. The overall goal is essentially to give to the student the basic fundamentals of indexing and abstracting which will be applicable to any career options in the fields of library and information sciences. With practical indexing and abstracting experience, student will become more proficient in retrieving information.


