Course Objectives

This course continues to develop both the “hearing eye” and the “seeing ear.” Singing activities will include prepared melodies, sight singing, and ensemble singing in various clefs (including C-clefs). Dictation exercises will focus on melody, rhythm, two-part counterpoint, and harmony. By the end of the course, students will be able to sing and identify the following:

1. Chromatic melodies using treble, alto, tenor, and bass clefs (using **movable do**)
2. Diatonic and chromatic modulation
3. Harmonic vocabulary commensurate with MUTH 2400
(applied chords, modal mixture, Neapolitan, augmented sixth chords)
4. Further subdivision of the beat and syncopation

Prerequisites: MUTH 1500 and MUTH 1510 with a “C” or better. Co-requisite: MUTH 2400.

- Staff papers and pencils with erasers everyday

Assignments

All homework, quizzes, and exams must be completed neatly in pencil. Assignments are due 8:00 am every Tuesday. Late work will be accepted up to TWO days (if assignment is due on Tuesday, then Thursday is the latest it will be accepted), and late work will receive a 5% deduction per day. Any work after Thursday will be given a zero. Exceptions will only be made for unplanned excused absences (such as medical emergencies) at the discretion of the instructor.

Attendance

Because gaining fluency in music takes consistent practice, I expect you to attend every class. If you do miss a class for any reason, you are still responsible to know the material covered that day and for submitting all assignments on time. Attendance will count as 10% of the final grade.

Excused absences include official University or College of Music activities, medical emergencies, religious observances, and documented illnesses. Excused absences do not count against your attendance or lower your grade. E-mail me as soon as possible with the reason and documentation for your absence. If you are ill, please provide me a doctor's note, but please keep your medical condition private. If you expect to be absent for several days or weeks, please contact the Dean of Students Office. If you have a chronic medical condition that might affect your class attendance or performance, please see the Office of Disability Accommodations.

AI USAGE

Generative Artificial Intelligence (GenAI) refers to software systems and platforms that create new content, such as text, images, audio or video using generative models. Students in this course will not likely have assignments in which GenAI can be utilized. However, if a student *does* use GenAI, they are required to disclose when and how they used it for any assignment.

Financial Aid and Satisfactory Academic Progress

Undergraduates

A student must maintain Satisfactory Academic Progress (SAP) to continue to receive financial aid. Students must maintain a minimum 2.0 cumulative GPA in addition to successfully completing a required number of credit hours based on total hours registered. Students cannot exceed attempted credit hours above 150% of their required degree plan. If a student does not maintain the required standards, the student may lose their financial aid eligibility.

Students holding music scholarships must maintain a minimum 2.5 overall cumulative GPA and 3.0 cumulative GPA in music courses.

If at any point you consider dropping this or any other course, please be advised that the decision to do so may have the potential to affect your current and future financial aid eligibility. It is recommended that you to schedule a meeting with an academic advisor in your college or visit the Student Financial Aid and Scholarships office to discuss dropping a course before doing so.

Graduates

A student must maintain Satisfactory Academic Progress (SAP) to continue to receive financial aid. Students must maintain a minimum 3.0 cumulative GPA in addition to successfully completing a required number of credit hours based on total registered hours per term. Music scholarships require a 3.5 cumulative GPA. Students cannot exceed maximum timeframes established based on the published length of the graduate program. If a student does not maintain the required standards, the student may lose their financial aid eligibility.
