#### Course Description

A survey of individual and organizational decision making in the acquisition, consumption and disposition of goods and services, with selected applications in market segmentation, marketing communications and marketing management. Topics include consumer and organizational behavior models and decision processes; internal influencing forces of motivation, perception, learning, personality, lifestyle and attitudes; external influencing forces of culture, subculture, demographic, social class, reference group and household.

- 1. Define the consumer decision making process and its role in marketing.
- 2. Explain how consumers form and change their attitudes towards products, brands and services.
- 3. Articulate how consumers process, interpret and use marketing related information when forming evaluations and making decisions.
- 4. Identify basic psychological processes that influence consumer behavior and their implications for marketing.

## Rules of Engagement

## Course Requirements

## **Exams** (30%)

The course has two (2) major required exams: a midterm and a final. The midterm and final are both timed.

## **Quizzes** (20%)

The course has fourteen (14) module assessments (one for each module). Each assessment is worth 25 points.

Questions for the exams and quizzes will be based on material covered in class from the book, slides and videos, including exercises. Any student who misses an exam or quiz without a legitimate excuse is unable to receive credit.

Make-up policy: For those students who have a legitimate, documented excuse for missing an exam or quiz, a make-up attempt will be offered.

## Assignments (25%)

There are two (2) case study assessment assignments and two (2) video assignments. Students will read a case study/watch a video related to the module and take a short assessment to test their comprehension of the material presented.

## Class Participation (25%)

The course has four group discussion assignments. Students will be placed into small groups and asked to complete a task. Each question presented must be answered with a **complete paragraph** using **proper grammar** and **spelling**. All papers must be **double-spaced** and **use a twelve-point** (12pt.) **Times New Roman font**. Each paper must also have a **header** that includes **each student's name**, the **assignment name** (e.g., Group Assignment Module 1), **course information** (MKTG 4120) and **term information** (e.g., Spring 2021). One individual from the group must submit the assignment for the entire group via Canvas. Team member contributions to group work will be assessed via anonymous group member evaluations. These evaluations will be used along with the overall group grade to determine the student's final grade on the assignment.

## **Extra-Credit Opportunities**

Throughout the semester, several discussion boards will be created. In order to receive extra credit, students need to provide an initial substantial post to the discussion questions by day 4 of the week (Thursday) @ 11:59pm EST each week as well as respond to two different classmates with insightful comments that move the discussion forward by day 7 (Sunday) of the current week @ 11:59pm EST to earn points for online discussions. Be sure to review the grading rubric shown in Canvas to earn maximum points. Below are some following ways to respond to your classmates:

- Expand on your classmate's posting
- Explain why and how you see things differently
- Ask a probing or clarifying question
- Share an insight from having read your classmate's posting
- Offer an opinion and support it (using an outside resource)

No extra credit will be given for late posts. All extra-credit points will be added to your final grade.

## Academic Integrity Policy

The G. Brint Ryan College of Business takes academic honesty seriously. Group assignments should only be discussed with members assigned to your group, and all group members may be held accountable for known academic integrity violations in a group assignment.

Another example of academic dishonesty is improper attribution. You must quote or footnote all outside sources used when preparing your assignments. Copying or using material from any source prepared by or previously submitted by others, at UNT or other institutions, or downloaded from the Internet, is plagiarism. Unless directed otherwise in an assignment, large scale "cutting and pasting" from other sources, even if properly footnoted, is also considered as plagiarism. You should synthesize this material in your own words and provide a footnote.

Your professor will specify what materials, if any, may be used on the tests and exams.

Using materials other than those permitted, talking with other individuals during the exam, individuals exchanging information about an exam when one has taken the exam and the other has not, or copying or using material from another individual's exam is academic dishonesty and will result in an academic referral or penalty. The use of online assistance, group chat, cell phones, smart watches, and similar tools during exams is not allowed for any reason unless specifically permitted. No portion of an exam may be copied or photographed without permission.

Students are expected to conduct themselves in a manner consistent with the University's status as an institution of higher education. A student is responsible for responding to an academic dishonesty report issued by an instructor or other University official. Important Notice for F-1 Students taking Distance Education Courses

## **Federal Regulation**

To read detailed Immigration and Customs Enforcement regulations for F-1 students taking online courses, please go to the <u>Electronic Code of Federal Regulations website</u> (http://www.ecfr.gov/). The specific portion concerning distance education courses is located at Title 8 CFR 214.2 Paragraph (f)(6)(i)(G).

#### The paragraph reads:

(G) For F-1 students enrolled in classes for credit or classroom hours, no more than the equivalent of one class or three credits per session, term, semester, trimester, or quarter may be counted toward the full course of study requirement if the class is taken on-line or through distance education and does not require the student's physical attendance for classes, examination or other purposes integral to completion of the class. An on-line or distance education course is a course that is offered principally through the use of television, audio, or computer transmission including open broadcast, closed circuit, cable, microwave, or satellite, audio conferencing, or computer conferencing. If the F-1 student's course of study is in a language study program, no online or distance education classes may be considered to count toward a student's full course of study requirement.

## **University of North Texas Compliance**

To comply with immigration regulations, an F-1 visa holder within the United States may need to engage in an on-campus experiential component for this course. This component (which must be approved in advance by the instructor) can include activities such as taking an on-campus exam, participating in an on-campus lecture or lab activity, or other on-campus experience integral to the completion of this course.

If such an on-campus activity is required, it is the student's responsibility to do the following:

- (1) Submit a written request to the instructor for an on-campus experiential component within one week of the start of the course.
- (2) Ensure that the activity on campus takes place and the instructor documents it in writing with a notice sent to the International Student and Scholar Services Office. ISSS has a form available that you may use for this purpose.

# Transmission and Recording of Student Images in Electronically-Delivered Courses

- 1. No permission is needed from a student for his or her image or voice to be transmitted live via videoconference or streaming media, but all students should be informed when courses are to be conducted using either method of delivery.

- 3. #### **Other Course Policies**

#### Netiquette

Students are expected to be respectful of peers' opinions expressed in the discussion postings. ## **Email Requirement**

## **Incomplete Grade**

An Incomplete Grade ("I") is a non-punitive grade given only during the last one-fourth of a term/semester and only if a student (1) is passing the course and (2) has a justifiable and documented reason, beyond the control of the student (such as serious illness or military service), for not completing the work on schedule. The student must arrange with the instructor to finish the course at a later date by completing specific requirements. These requirements must be listed on a Request for Grade of Incomplete form signed by the instructor, student, and department chair; and also entered on the grade roster by the instructor. Grades of "I" assigned to an undergraduate course at the end of the Fall 2007 semester and later, will default to "F" unless the instructor has designated a different automatic grade.

A student may remove a grade of "I" within one year by completing the stipulated work. After completion of the stipulated work the instructor of record records the final grade on a UNT Grade Change Form and obtains the department chair's signature. The instructor's academic dean completes processing with the Registrar's Office, where the grade point average is adjusted accordingly. For undergraduate courses taken Fall 2007 or later, if a student does not complete the stipulated work within the time specified, the grade will default to F unless the instructor has designated a different automatic grade. The GPA is adjusted accordingly, and the student will be subject to academic penalty should any exist.
