Welcome to UNT!

Course Description

The essence of this class boils down to- **Objects tell stories**. As they say "That's it. That's the tweet." As designers it is our job to use objects to tell stories.

(Please note when I use the word "Object" I mean- clothing, shoes, earrings, chairs, cookware--- all of it. All things that have been human made for use. This is different than a painting or sculpture that is made as to only be what it is- as opposed to be used or worn.)

So, Objects tell stories. As Theatre Artist we are story tellers. Shouldn't we use everything in our arsenal to tell that story? Yes.

SO this class for these 15 weeks will be about how to find the story in objects as well as expanding your **visual dictionary** so you have the ability to recognize trends and periods. It will also be about learning new places to look for information and inspiration. In no way can we cover anything but a surface glance at the different eras and areas but I hope that you will be able to take away from this class a good foundation for how to "read" objects and become familiar with their lines, materials etc so you can make an educated guess as to where it came from and a little about the culture that made it so that you can use it effectively on stage.

Course Structure

This is a fully online class.

The class will be made of the following components:

- 25 video lectures giving an overview of the era and location we are covering that week. (2 lectures a week- released on Monday am.)
- 25 VERY brief quizzes to ensure you have watched each of the videos. (Released with the videos)

- 23 "Friday Projects" Based on the era and area we are studying. (Released with the weekly videos on Monday and they will be due Sunday).
- 4 Research Projects.
- Each Friday we will have an optional "work session" via Zoom where you can ask questions and work on your "Friday Project" with me and others in the class. (From 11-11:50 via Zoom)

DO NOT BE OVERWHELMED. THIS ISN'T AS MUCH AS YOU THINK IT IS.

Video Lectures & Quizzes

Each week we will cover two subjects that will be broken down in individual modules with it's own video lecture, supporting materials you can look at as well as the quiz and Friday project. We will do this three weeks on and one week off... (But the off weeks will be when one of your Research Projects will be due so you're not totally off the hook.)

Friday Projects

There will be one released with each Video Lecture that will challenge you to do one of two things:

- Find an online or print VISUAL source for the subject and share it on the discussion board set up for the project.
- **OR**
- Find the best object for the scenario given. I will give you a description of a character and you will have to find the best object that is called out as well as site your source material and why you made the choice.

These Friday projects are more about your quick response research skills than a laborious undertaking.

The Research Projects

These will be 4 visual research projects that will require to expand your realm of visual knowledge and shape the story of your research into one of the project's requirements. I will ask you to be creative and bring a fresh eye to what you will be researching- I want your spin too! Please see the Research Project Module where they are all ready for you to do at your leisure.

Feedback Extra Credit

As this is the first time I have taught this class and I value student feedback I will be offering TWO anonymous surveys in the course of the semester to see how the class is going and to see I need to make adjustments. (SPOT scores are useless to help shape a class while you are taking it.) But how will I know who did the extra credit? It will be based on how many students participate- so it over 75% response rate than you will all get the extra credit.

- Avoid using “text-talk” unless explicitly permitted by your instructor.
- Proofread and fact-check your sources.
- Keep in mind that online posts can be permanent, so think first before you type.

Important Notice for F-1 Students taking Distance Education Courses

Federal Regulation

To read detailed Immigration and Customs Enforcement regulations for F-1 students taking online courses, please go to the [Electronic Code of Federal Regulations website](http://www.ecfr.gov/) (<http://www.ecfr.gov/>). The specific portion concerning distance education courses is located at Title 8 CFR 214.2 Paragraph (f)(6)(i)(G).

The paragraph reads:

(G) For F-1 students enrolled in classes for credit or classroom hours, no more than the equivalent of one class or three credits per session, term, semester, trimester, or quarter may be counted toward the full course of study requirement if the class is taken on-line or through distance education and does not require the student's physical attendance for classes, examination or other purposes integral to completion of the class. An on-line or distance education course is a course that is offered principally through the use of television, audio, or computer transmission including open broadcast, closed circuit, cable, microwave, or satellite, audio conferencing, or computer conferencing. If the F-1 student's course of study is in a language study program, no on-line or distance education classes may be considered to count toward a student's full course of study requirement.

University of North Texas Compliance

To comply with immigration regulations, an F-1 visa holder within the United States may need to engage in an on-campus experiential component for this course. This component (which must be approved in advance by the instructor) can include activities such as taking an on-campus exam, participating in an on-campus lecture or lab activity, or other on-campus experience integral to the completion of this course.

If such an on-campus activity is required, it is the student's responsibility to do the following:

- (1) Submit a written request to the instructor for an on-campus experiential component within one week of the start of the course.
- (2) Ensure that the activity on campus takes place and the instructor documents it in writing with a notice sent to the International Student and Scholar Services Office. ISSS has a form available that you may use for this purpose.

Because the decision may have serious immigration consequences, if an F-1 student is unsure about his or her need to participate in an on-campus experiential component for this course, s/he should contact the UNT International Student and Scholar Services Office (telephone 940-565-2195 or email internationaladvising@unt.edu) to get clarification before the one-week deadline.

Student Verification

Transmission and Recording of Student Images in Electronically-Delivered Courses

1. No permission is needed from a student for his or her image or voice to be transmitted live via videoconference or streaming media, but all students should be informed when courses are to be conducted using either method of delivery.
2. In the event an instructor records student presentations, he or she must obtain permission from the student using a signed release in order to use the recording for future classes in accordance with the Use of Student-Created Work guidelines above.
3. Instructors who video-record their class lectures with the intention of re-using some or all of recordings for future class offerings must notify students on the course syllabus if students' images may appear on video. Instructors are also advised to provide accommodation for students who do not wish to appear in class recordings.

Example: This course employs lecture capture technology to record class sessions. Students may occasionally appear on video. The lecture recordings will be available to you for study purposes and may also be reused in future course offerings.
