### **Course Description**

This course provides an overview of speech sound disorders in children and adults. Students will learn the nature and characteristics of articulation and phonological disorders, as well as by principles of assessment and intervention.

This is an online course with a total of 16 modules. <u>Modules will open no later than the Friday of the previous week and will close on Saturday of each designated week. At least one assignment will be due each week, so be sure to regularly check Canvas.</u>

Note: All modules will not be opened at the beginning of the semester, though multiple modules may be open at certain times throughout the semester.

Volunteer study sessions will be available to provide more interaction between the professor and students. These may take place in person or over Zoom. Regular sessions will be held where students can discuss and ask questions about the lecture material, assignments, exams, discussions and observational videos as well as receive extra hands-on instruction for classwork.

A survey will be sent the first week of classes to determine how often to meet, the best time(s) to meet based on the availability of majority of students as well as the mode of delivery.

Although this course is asynchronous and online, in-person office hours will still be held with no appointment required. You may also schedule a meeting if you need help or have any questions.

## **Course Objectives**

Upon completion of this course, students will be able to:

- Define and apply terminology related to speech sound disorders.
- Describe key milestones in typical phonological development.
- Identify and explain principles of assessment for articulation and phonological disorders, including the appropriate selection of tools.
- Evaluate the presence and nature of speech sound disorders using diagnostic criteria.
- Select appropriate treatment targets and write behaviorally stated intervention goals with clear rationales.
- Compare and apply intervention approaches and sound facilitation strategies.
- Locate, interpret, and apply research findings to inform clinical decision-making.
- Analyze the effects of cultural and linguistic diversity on speech sound development and disorder presentation.

### **Course Requirements**

All submissions will be submitted online and are **due at 11:59 pm** on the designated due date (based on time posted on Canvas). Plan ahead to complete work before the deadline and avoid last-minute technical issues. **Anything submitted after the deadline is considered late.** Late work will receive a 10% penalty of the total possible points for the first 24 hours. Anything submitted after 24 hours will receive a penalty of 20% of the total possible points. It is better to turn in an assignment late than to not turn one in at all.

All work must be submitted as WORD DOCS, any other file type will be counted as missing and graded as a zero.

## Assignments

Students will complete 13 assignments (10 points each) throughout the semester. These are meant to reinforce the material from the lectures and provide students with hands-on experience with the material. Assignments will be graded to show errors, but correct answers will not be provided. It is strongly suggested you attend study sessions to review and discuss corrections of these assignments.

### Activities

Students will complete 13 activities (5 points each) throughout the semester, but only 12 will be graded (the lowest grade will be dropped at the end of the semester). These will be graded for general completeness and effort. The majority of activities will be clinical video observations, which will count towards your observation hours (see the Observation Hours section below). *Total points:* 60

#### Exams

Students will take two exams (55 points each) and a cumulative final (100 points) throughout the semester. The exams will include information from lectures, readings, and previous activities. They will be a combination of short answer and essay questions. Reviews will be provided before the exam.

## Grading

Your grade is determined by the total number of points you have earned during the semester divided by the total number of possible points (400). Course grades will be based on the cumulative total of the points using the following scale:

No extra credit opportunities are planned at this time. Grades are not curved.

Grades will be posted throughout the semester on Canvas. When grades are posted, a grade of a 0 will be recorded if your work was not received or submitted incorrectly. Please report **via email** any discrepancy to Dr. Krajewski within one week of posting the grades. Grades will not be changed after that time as it will be assumed that you agree with your grade.

### **Observation Hours**

As part of this course, students will earn observation hours that will count toward the total of 25 hours needed for graduate school or SLP-A license. Observation hours will be counted for each Clinical Video Report completed. To receive observational credit for Master Clinician hours, students must register with Master Clinician. The fee for one year is \$54 and will cover the videos shown in your classes this semester and classes next semester such as: Introduction to Language Disorders, Clinical Methods I and II. To register, students will go to www.masterclinician.org and sign up.

## **Tracking of Hours**

All observation hours will be tracked through CALIPSO. CALIPSO is a web-based application used by speech-language pathology and audiology programs across the nation. This computer program tracks both observation hours and clinical experience hours. This program is designed for a student to keep up with their own observation and clinical treatment hours and use them as needed. This program is designed so that the hours earned can be easily approved by professors and/or supervisors during undergraduate and graduate coursework.

Students must log observation hours for this course through CALIPSO for the instructor to approve **no later than November 22<sup>nd</sup>.** The hours will then be approved at the end of the semester which may be after the last day of class. Hours will only be approved in the semester the course was taken as the hours are not saved in any other format to be reviewed at a different time.

As an ASLP student at the University of North Texas, you are required to register for an account at CALIPSO via an email invite sent from the ASLP department. This is a one-time sign-up with a one-time fee of \$100.00. If you already have a CALIPSO account at UNT, you will not need to sign up again and can continue to use the same account to submit your observation hours each semester for each class that offers observation hours. If you have paid this fee and signed up for an account with another/previous class, continue to use the same account, as the hours will accrue. If you need to set up a new account, send an email to Dr. Krajewski.
