Course Description

Supervised work in a job related to student career objective.

Course Objective

Students should use their internship to gain valuable work experience and increase your knowledge in the field of your major. It is a good idea to seek a position in a firm or industry where you have an interest in possible permanent employment, and where you will gain desired competencies.

Students that complete the course will be able to:

- 1. Apply and explain the relationship between coursework taken and work being performed in the internship
- 2. Continue to develop communication skills in the areas of written, oral and presenting
- 3. Practice work habits and attitudes needed to be successful professionally
- 4. Identify strategies for continued development of skills most relevant for success in the student's targeted industry.

Internship Hours and Credit Hours

The PD&A program requires six credit hours of internship spread over three summers in three internships. Students can also elect to take two internships instead of three to fulfill their degree requirements. Based on need and availability, we would also work with students to take internships during the regular semester. Students may take internships in increments of one Credit Hour up to three Credit Hours at a time where each credit hour is equivalent to 65 actual work hours of internship.

Work Hours Required: 65 Hours for 1 Hour of Credit

130 Hours for 2 Hours of Credit 195 Hours for 3 Hours of Credit

Overview of Course Requirements

This is an online course. Students will access course content and submit assignments in Canvas. The seminar also requires that students participate in occasional, small-group presentation sessions during the session. Times for these sessions will be set with student input.

Required Readings

Participants in the class will read, reflect upon, and present their ideas on a non-fiction book recommended by their internship/practicum supervisor. Students are responsible for obtaining copies of the book recommended by their supervisor.
