

BIOL 4035 & 5035: Behavioral Ecology

Fall 2025, 3 credits

Welcome to Behavioral Ecology! This topic investigates how organisms change what they are doing as they interact with other organisms and with their environment. We will focus on understanding the evolution of behavior, primarily with animals. You may find some of the material challenging, but I hope you will also be fascinated by what you learn.

Course Structure: Live class meetings *TuTh 9:30-10:50* in Chilton 245. Students are expected to attend class in the classroom unless there are extenuating circumstances. Canvas: All syllabus updates, assessments, supplemental readings and videos, and other class materials will be on Canvas. Students are responsible for regularly checking for announcements and course materials. I recommend that you set notifications to "on" in your Canvas settings.

Homework will be turned in, and quizzes will be conducted, via Canvas. Canvas provides a [Student Guide](#).

Course Goals:

Upon successful completion of this course, students should:

- 1) Be familiar with major concepts in behavioral ecology.
- 2) Understand and be able to apply standard methods used to design, analyze and critique behavioral ecology experiments.
- 3) Understand how to apply the scientific process to behavioral ecology questions, and be able to evaluate the use of the scientific process in papers from this field

Learning Objectives:

Students should be able to:

- 1) Explain how behavior links genetics, organisms and the environment.
- 2) Critically read journal articles.
- 3) Confidently interpret data and graphs.
- 4) Develop specific predictions from hypotheses about behavior, and design experiments to test those predictions.

Assessment and Grading: Assessments are designed to confirm that you understood and are able to apply what you are learning. In this course, you are assessed every week. To do well, it is very important to review course material on a regular basis, keep an eye on deadlines, and make sure you complete all coursework. Because life sometimes affects everyone, at the end of the semester I will drop your lowest quiz and article annotation scores.

1. **Quizzes:** Quizzes will assess your understanding and retention of textbook readings, lecture material, and assigned articles. They will be administered via Canvas, in class on the weeks indicated in the schedule. You will have 10 minutes to complete the quiz. Questions will include a mix of multiple choice, matching, definitions, and short answer questions. Quizzes will be closed note and closed book. At the end of the semester, your lowest two quiz scores will be dropped.
2. **Homework**
 - a. Textbook readings: You are expected to read the assigned textbook chapters before the day we discuss a topic. Readings reinforce lectures and provide additional examples to help you better understand course material. Textbook content may be on quizzes.
 - b. Other readings/videos: I will occasionally assign supplemental material that needs to be read or watched before class. These assignments will be posted on Canvas.
 - c. Syllabus and Questions assignments: These are explained in Canvas, and due Monday, 8/25 (Syllabus) or 9/1 (Questions) by 11:59pm.
 - d. Article annotations: This homework involves annotating assigned journal articles. These are due on Mondays at 11:59pm. At the end of the semester, your lowest article annotation score will be dropped.

- e. Graduate student extra assignment: Students enrolled in the graduate section will complete an extra assignment, due on Dec. 8. Details will be provided in Canvas.
3. **Final project:** Each student will independently prepare a project due near the end of the semester, with intermediate deadlines throughout the semester. See Canvas for details.

Since analysis and critical thinking are part of the learning objectives, all assignments should be prepared by the student. Developing these competencies will prepare you for a competitive workplace. Thus, ***plagiarism and use of generative AI (e.g., ChatGPT) for any work in this course are prohibited*** and will be treated as academic misconduct.

Late/makeup Policy: Grading is structured so that if you miss a quiz or article annotation, it will not significantly affect your grade. At the end of the semester, your lowest 2 quiz and 1 article annotation grades will be dropped. You will have at least a week to submit all other assignments. Thus, no late work or make-ups will be accepted.

The University is committed to providing a reliable online course system to all users. - Avoid using all caps while communicating digitally. This may be interpreted as “YELLING!”
- Be cautious when using humor or sarcasm in emails or discussion posts as tone can be difficult to interpret digitally.
- Avoid using “text-talk” unless explicitly permitted by your instructor.
- Proofread and fact-check your sources.
- Keep in mind that online posts can be permanent, so think first before you type.

Academic Integrity Policy

Academic Integrity Standards and Consequences. According to UNT Policy 06.003, Student Academic Integrity, academic dishonesty occurs when students engage in behaviors including, but not limited to cheating, fabrication, facilitating academic dishonesty, forgery, plagiarism, and sabotage. A finding of academic dishonesty may result in a range of academic penalties or sanctions ranging from admonition to expulsion from the University.

Examples where no credit will be given for the assignment include:

- Discussing a quiz with one or more classmates before the entire class has completed it.
- Copying a classmate's annotation in Perusall.
- Copying other work from a classmate, or letting a classmate copy your work.
- Copying text from an article without quoting and citing.
- Citing non-existent sources.
- Using generative AI such as ChatGPT on assignments.

Examples where a student will be reported to the Office of Academic Integrity are:

- Committing any of the above types of academic dishonesty more than one time.

Important Notice for F-1 Students taking Distance Education Courses

Federal Regulation

To read detailed Immigration and Customs Enforcement regulations for F-1 students taking online courses, please go to the [Electronic Code of Federal Regulations website](http://www.ecfr.gov/) (<http://www.ecfr.gov/>). The specific portion concerning distance education courses is located at Title 8 CFR 214.2 Paragraph (f)(6)(i)(G).

The paragraph reads:

(G) For F-1 students enrolled in classes for credit or classroom hours, no more than the equivalent of one class or three credits per session, term, semester, trimester, or quarter may be counted toward the full course of study requirement if the class is taken on-line or through distance education and does not require the student's physical attendance for classes, examination or other purposes integral to completion of the class. An on-line or distance education course is a course that is offered principally through the use of television, audio, or computer transmission including open broadcast, closed circuit, cable, microwave, or satellite, audio conferencing, or computer conferencing. If the F-1 student's course of study is in a language study program, no on-line or distance education classes may be considered to count toward a student's full course of study requirement.

University of North Texas Compliance

To comply with immigration regulations, an F-1 visa holder within the United States may need to engage in an on-campus experiential component for this course. This component (which must be approved in advance by the instructor) can include activities such as taking an on-campus exam, participating in an on-campus lecture or lab activity, or other on-campus experience integral to the completion of this course.

If such an on-campus activity is required, it is the student's responsibility to do the following:

(1) Submit a written request to the instructor for an on-campus experiential component within one week of the start of the course.

(2) Ensure that the activity on campus takes place and the instructor documents it in writing with a notice sent to the International Student and Scholar Services Office. ISSS has a form available that you may use for this purpose.
