COURSE CONTENT

From the Graduate Catalog:

"Theoretical principles of music from the 17th through early 20th centuries and their application through analysis and aural skills."

My interpretation:

Application, identification, and analysis of fundamentals and principles of tonal music of the common-practice era.

In detail:

- scale, interval, and chord identification both written and aural
- basic principles of counterpoint for part writing
- identify and write chord types and their inversions in context
- identify and write cadences and sequences as components of harmonic progressions
- apply figured bass in part writing
- apply Roman Numerals in analysis
- Analyze rhythm and meter in the context of musical phrases
- Identify and analyze basic and principal forms in tonal music (binary/ternary, rondo, sonata)

Course-level Learning Objectives

Upon successful completion of this course, the learner will be able to...

Elements, structures and procedures of tonal music, as outlined here:

- diatonic and chromatic chords
- scales
- intervals
- cadences and sequences
- harmonic progressions
- figured bass settings
- harmonic reductions
- melody harmonizations
- diatonic and chromatic modulations

- harmonic and rhythmic analysis (Roman Numerals, for instance)
- basic form analysis, along with formal functions and harmonic analysis

METHOD AND ORGANIZATION

The content is organized in ten modules and an introductory module. For learning objectives and a detailed schedule for each module see the page "What we will learn and What to do" in each respective module (posted dates may be adjusted as needed):

- 1 Week 1, 2: Fundamentals, Literature, Roman numerals, Rule of the Octave (January 17, 22, 24)
- 2 Week 3, 4: basic part writing, counterpoint, Intro to figured bass, Cadences and sequences (January 29, 31, February 5, 7)
- 3 Week 5: Basic Analysis with Roman Numerals (February 12, 14)
- 4 Week 6, 7: Chromatic Harmony, chromatic chords, Modulation (February 19, 21, 26, 28)
- 5 Week 8, 9: Harmonic Analysis. (Student Assignments, Midmester, Spring Break), March 4, 6, 18, 20
- 6 Week 10: Rhythm and Meter, Hypermeter (March 25, 27)
- 7 Week 11: Phrase Structure (April 1, 3)
- 8 Week 12: Binary and Ternary Form (April 8, 10)
- 9 Week 13: Rondo Form (April 15, 17)
- 10 Week 14, 15: Sonata Forms (Student Assignments), April 22, 24, 29, May 1

Final Analytical Essays due: May 7, 2024

The course is taught in a hybrid mode. There will be classroom sessions and online sessions, as announced in class and on Canvas. Homework, and Assignments be completed on the Canvas assignment page.

Grading:

Grading is based on four assignment categories:

• **Homework**: 40% of the final grade. Homework consists of CANVAS Quizzes and Discussions. This also includes classroom aural skills quizzes. Content: multiple choice,

- fill-in-the-blank, and short answer-type quizzes asking for details of the content of the respective module
- **Midterm assignment**: 20% of the final grade. More complex analytical questions requiring short essays, form tables, and harmonic reductions to be turned in (uploaded) via CANVAS.
- Classroom Presentation: 20% of the final grade. Both the midterm assignment and the final analysis will be presented.
- FINAL ESSAY: 20% of the final grade. Elaborated analytical essay about a movement of a common-practice work, including form table/graph, as applicable. In addition, a harmonic reduction that represents that large-scale harmonic design as relevant to formal sections may be uploaded for extra credit in order to improve grades lower than A. All materials must be uploaded through CANVAS
- **SPOT evaluation**: extra credit (3 points to the final grade) will be assigned to every student if at least 60% of the participants fill out the SPOT class evaluation at the end of the term

I will grade usually within 48 hours after the due date during the work week.

Undergraduates

Students cannot exceed attempted credit hours above 150% of their required degree plan. If a student does not maintain the required standards, the student may lose their financial aid eligibility.

Students holding music scholarships must maintain a minimum 2.5 overall cumulative GPA and 3.0 cumulative GPA in music courses.

Music scholarships require a 3.5 cumulative GPA. Students cannot exceed maximum timeframes established based on the published length of the graduate program.
