## **COURSE TITLE:**

MUAC 1503.710 (3631): First/Second Semester Concentration Students

**PREREQUISITES:** None

# **COURSE OBJECTIVES:**

- To direct each student on a mental, physical, and psychological quest to develop a stronger, healthier, more beautiful ability to sing
- To learn Vocal Literature appropriate to each student's voice
- To apply vocal abilities in the interpretation of the vocal literature
- appropriate to each student's developmental stage (beginning students to graduate-level students)
- to To learn how to practice and adapt optimal Vocal Skills and Appropriate Artistic Interpretations in Performance

#### **CONTENT OUTLINE:**

During weekly private voice lessons, each student with the instructor will work together through the learning of relevant vocalises and standard voice appropriate vocal literature in order to develop and cultivate good musicianship.

# **TEXT & REFERENCES:**

- Various musical scores as directed by the instructor to meet each student's repertoire needs.
- Italian, French, and/or German Dictionaries of the student's choice as dictated by the language of each student's assigned repertoire. Recommended resources available under "resources" in this syllabus.

# Repertoire Requirements

All translations and IPA transcriptions are expected to be written in your score by the second week of September.

## **Concentration Students**

Voice Concentration students must take 6 semesters of applied lessons and **perform a jury each semester**. (Note: an exception is the 5<sup>th</sup> semester recital option in place of a jury. First year students are exempted from performing a jury in their first semester of study in this program. (See the Handbook for details.)

## **Voice Concentrations - Music Education**

For students entering the program Fall 2024 or after: 26 selections total, a minimum of 5 songs each in English, Italian, German, and French, two in Spanish, and 4 in any language. For students entering the program before Fall 2024: 26 selections total: a minimum of 5 songs each in English, Italian, German, and French, and 6 in any language.

# Repertoire Assessment.

All five pieces are expected to be memorized by mid November. You will have the opportunity to work on all pieces by the end of October.

# **Departmental Recitals**

Departmental voice recitals are scheduled on selected Tuesdays at <u>4:00 pm</u>. Attendance is **mandatory**. It is the responsibility of each student to notify their studio teacher of their attendance during departmental recitals in order to receive a full grade for each departmental attendance.

A schedule listing the departmental recital weeks and other vocal events will be posted under files on your class canvas page. All concentrations students are required to submit a recital attendance record sheet with confirmed signatures of faculty present during each recital, by the end of the semester.

## **Studio Performance Class**

All students taking MUAC 1503 are required to attend at least four studio classes with their private voice teacher and two more classes outside of their voice studio (with prior confirmation or permission from that faculty member). That makes a total of six required studio classes.

# **Attendance Policy**

Concentration voice lessons are scheduled for 50 minutes per week. Students are required to schedule their private lessons with their assigned teacher no later than the first full week of classes, or risk being dropped from lessons for the semester. The College of Music has established THIRTEEN as the normal number of lessons per semester, and EIGHT as the minimum number of lessons a student must attend to receive a passing grade. Therefore, students who have missed a total of six lessons, either excused or unexcused, will be asked to drop voice for the semester.

Attendance at class times is mandatory. You are allowed three unexcused absences. After three unexcused absences your final grade will be lowered by 2 points for each additional unexcused absence.

If you must miss a lesson, your teacher should be notified by text, phone, or e-mail with at least 24 hours notice. If this notice is not provided, your teacher is not obligated to make up your lesson, unless there are unavoidable and extenuating circumstances. Lessons that occur on *official university holidays* (e.g., Thanksgiving) do not have to made up by your teacher nor do lessons that were scheduled for a day that the university is closed due to inclement weather.

If a student misses two lessons without notification, the student will receive a "Notice of Unsatisfactory Progress" report. If an additional lesson is missed without notification, the student will receive a failing grade if still enrolled when grades are due.

## **ACADEMIC INTEGRITY**

Students caught cheating or plagiarizing will receive a "0" for that particular assignment or exam [or specify alternative sanction, such as course failure]. Additionally, the incident will be reported to the Dean of Students (Office of Academic Integrity), who may impose further penalty. According to the UNT catalog, the term "cheating" includes, but is not limited to: a. use of any unauthorized assistance in taking guizzes, tests, or examinations; b. dependence upon the aid of sources beyond those authorized by the instructor in writing papers, preparing reports, solving problems, or carrying out other assignments; c. the acquisition, without permission, of tests or other academic material belonging to a faculty or staff member of the university; d. dual submission of a paper or project, or resubmission of a paper or project to a different class without express permission from the instructor(s); or e. any other act designed to give a student an unfair advantage. The term "plagiarism" includes, but is not limited to: a. the knowing or negligent use by paraphrase or direct quotation of the published or unpublished work of another person without full and clear acknowledgment; and b. the knowing or negligent unacknowledged use of materials prepared by another person or agency engaged in the selling of term papers or other academic materials.
