Course Description

This course will continue to expand a framework for understanding and interpreting tonal music. We will complete our study of diatonic harmonies and begin to explore chromatic harmonies (e.g., applied dominants). In addition to these harmonic topics, we will explore sequences, diatonic modulations, dominant extensions, phrase structures, and 32-bar song form (AABA).

Course Structure

This is a 15-week asynchronous online course (students learn course content on their own time rather than via online live lecture meeting at specified times with the instructor). The course will be delivered in modules that are usually one week in length. Additional modules will contain resources

and other content. There will be synchronous web conference meetings on Zoom for office hours and review sessions. These will be scheduled and announced in advance. Please check the Announcements area on Canvas frequently to stay informed.

Course Prerequisites or Other Restrictions

Prerequisites: MUTH 1400 (Theory I) and MUTH1410 (Aural Skills I) both with a grade of C or higher

Corequisite: MUTH1510 (Aural Skills II)

Restrictions: enrollment is restricted and non-Texas resident students residing outside of the state are not eligible to enroll in this section. Contact the department for enrollment assistance in an appropriate section of the course, if applicable.

Course Objectives

By the end of this course, students will be able to:

1. Identify all diatonic chords, certain types of chromatic chords, common harmonic sequence types, and diatonic modulations employed in common-practice Western art music through score analysis.
2. Illustrate diatonic and chromatic chord spelling and resolutions, harmonic sequence types, and diatonic modulations through 4-voice (SATB) part writing.
3. Analyze, compare and contrast, and interpret multiple musical examples of musical phrase structures and small-scale forms from vocal and instrumental repertoires.
4. Compose sequences, musical phrase endings, and phrase types using music notation software. These composition exercises will require students to demonstrate their command of harmony and its interaction with melody, cadences, and phrase structures.
5. Communicate the technical vocabulary relating to harmony, phrase types and musical forms clearly and accurately.

Materials

- **Required Book:** there is no required textbook or workbook for this course (assignments are created by the instructor).
- **Recommended Materials & Technology:** Staff paper, pencils for homework assignments, binder/folder for lesson notes and homework assignments (if completing by hand), printer, scanner or mobile app that converts images to PDFs (e.g., Office Lens), and the Canvas mobile app (available for Android and iOS).

Success in an Online Course

Course Requirements

You are expected to complete course assessments ***independently*** (see Academic Integrity statement on p. 8 for more details). Please ask for clarification if you are unsure about the

instructions or direction of any assessment *before* its due. Class assessments will be weighted according to the following breakdown:

<i>Discussion/Participation Activities</i>	10%

Homework Assignments: assignments will feature part-writing, harmonic analysis, form analysis, etc. Students will complete the assignments by hand, scan the assignment using a cell phone/scanner, and upload a PDF of the assignment into Canvas. Alternatively, students can annotate their answers on the PDF using a tablet and stylus. Assignments are due on the dates specified for each assignment, usually by 11:59 pm Sunday nights. Your assignments *must be completed neatly, and the scans must be legible*. Your lowest 2 homework assignment scores will be dropped at the end of the semester.

Quizzes: some quizzes will be formatted as reading and comprehension (based on the lesson content), while other quizzes will focus on acquiring new musical skills (e.g., spelling chords). Most quizzes can be attempted an unlimited amount of times until the quiz closes. *Your highest attempted score* will be the one that is recorded in the grade book. Your lowest 3 quiz scores will be dropped at the end of the semester.

Exams: there will be an exam at the end of each unit (a midterm and final exam) that you can complete online (available from 8:00 am–11:59 pm CT). Part of the exam may include a short worksheet with part-writing questions (complete by hand or using a tablet and stylus). More details will be provided about the exam formats the week of the exams. Given the nature of the course, the final exam will be cumulative, but the main emphasis will be on the topics covered since the midterm.

Composition Project: students will compose different phrase types using music notation software. Further details about the composition will be provided before the project is due.

Discussion/Participation Activities: to foster engagement and to help with content understanding, students will have various types of participation activities or discussions to answer throughout the course.

Grading

Letter grades will be assigned according to the percentages below. *A grade of C (70%) or higher is needed to pass this course and move on to Theory III.*

A = 90–100% B = 80–89% C = 70–79% D = 60–69% F = 0–59%

Late Policies for Course Assessments: Each student can use **three “late passes” in order to turn in three separate homework assignments late without penalty** (up to a max. of 3 days or 72 hours after the Canvas deadline). Please email the grader before the late period is over to request one of your late passes for the assignment. Once you’ve used up your late passes, any additional homework assignments submitted late will be subject to a grade deduction. The points deducted from a late assignment will be the equivalent of a 5% deduction per day it is late, with a maximum deduction of 15% (e.g., after 11:59 pm Sunday through 11:59 pm Monday = 5% deduction etc.).

Quizzes and discussion/participation-related exercises are due by the deadline posted. These will typically be open for an additional 48 hours after the due date (it will display as a late submission in Canvas, but there won’t be a grade deduction). Any late policies for the composition project will be specified in more detail in the instructions/rubrics for this assessment.

Exams will be due by 11:59 pm CT the day it is scheduled. Only students who have a documented excused absence will be allowed to take an exam at an alternate time.

N.B. I will not be accepting late or missing homework assignments, re-opening missing quizzes, etc. after the last day of class.

Extra Credit: except for possible bonus questions on homework assignments and exams, there will be no other extra credit or make-up assignments in this class.

Assessment Policy

Each assessment type will be available for students to complete for a specified amount of time and will include instructions on how to complete the assignment, what the acceptable file types for submission are (e.g., .pdf), and an official due date (usually set for 11:59 pm). All assessments will be submitted online through Canvas. If any changes need to be made (e.g., extensions), I will notify students via a Canvas Announcement. Due dates can be found in each assessment as well as in your Canvas calendar and in your To-Do list on the homepage.

GenAI Software Policy

Prohibited Use

In this course, I want you to engage deeply with the materials and develop your own critical thinking and writing skills. For this reason, the use of Generative AI (GenAI) tools like ChatGPT or Gemini are not permitted. While these tools can be helpful in some contexts, they do not align with our goal of fostering the development of your independent thinking. Using GenAI to complete any part of an assignment, exam, or coursework will be considered a violation of academic integrity, as it prevents the development of your own skills, and will be addressed according to the [Student Academic Integrity](#) policy.

Instructor Responsibilities and Feedback

My responsibilities in the course are to:

- Help students learn and grow
- Provide clear instructions and grading rubrics
- Answering questions about course content and assignments
- Identify additional resources as necessary
- Review and update course content

Instructor Feedback: Students will generally receive immediate feedback on quizzes upon submission (unless there are questions that need to be graded manually). Homework assignments, discussion board posts, and exams will typically be graded within a week of the due date. Other projects may take more time, depending on the scope of the project and the number of students in the class.

Late Work & Late Passes

Homework assignments are typically due by 11:59 pm CST and will remain accessible/available 72 hours after the due date. If you submit your assignment after the due date and before the 72-hour “available until” date, Canvas will mark your submission as late. Late homework submissions will receive a daily penalty of 5%, up to a maximum of 15%, unless you request to use one of your late passes. There are no late penalties applied when you use one of your late passes. Please see “Late Policies” under the Grading section (p. 6) for more details.

Attendance Policy

According to UNT’s policy, a student’s absence may be excused for the following reasons: religious holy day observances (including travel for that purpose), active military service (including travel for

Gaining fluency in music takes consistent practice so I expect you to be watching the lesson videos and/or reading lesson materials, completing any assigned readings and practice questions, and participating in any other discussions or activities I assign that you would normally encounter during a face-to-face class.

Undergraduates

Important Notice for F-1 Students taking Distance Education Courses

Federal Regulation

To read detailed Immigration and Customs Enforcement regulations for F-1 students taking online courses, please go to the [Electronic Code of Federal Regulations website](http://www.ecfr.gov/) (<http://www.ecfr.gov/>). The specific portion concerning distance education courses is located at Title 8 CFR 214.2 Paragraph (f)(6)(i)(G).

The paragraph reads:

(G) For F-1 students enrolled in classes for credit or classroom hours, no more than the equivalent of one class or three credits per session, term, semester, trimester, or quarter may be counted toward the full course of study requirement if the class is taken on-line or through distance education and does not require the student's physical attendance for classes, examination or other purposes integral to completion of the class. An on-line or distance education course is a course that is offered principally through the use of television, audio, or computer transmission including open broadcast, closed circuit, cable, microwave, or satellite, audio conferencing, or computer conferencing. If the F-1 student's course of study is in a language study program, no on-line or distance education classes may be considered to count toward a student's full course of study requirement.

University of North Texas Compliance

To comply with immigration regulations, an F-1 visa holder within the United States may need to engage in an on-campus experiential component for this course. This component (which must be approved in advance by the instructor) can include activities such as taking an on-campus exam, participating in an on-campus lecture or lab activity, or other on-campus experience integral to the completion of this course.

If such an on-campus activity is required, it is the student's responsibility to do the following:

- (1) Submit a written request to the instructor for an on-campus experiential component within one week of the start of the course.

Transmission and Recording of Student Images in Electronically-Delivered Courses

1. No permission is needed from a student for his or her image or voice to be transmitted live via videoconference or streaming media, but all students should be informed when courses are to be conducted using either method of delivery.
2. In the event an instructor records student presentations, he or she must obtain permission from the student using a signed release in order to use the recording for future classes in accordance with the Use of Student-Created Work guidelines above.
3. Instructors who video-record their class lectures with the intention of re-using some or all of recordings for future class offerings must notify students on the course syllabus if students' images may appear on video. Instructors are also advised to provide accommodation for students who do not wish to appear in class recordings.

Example: This course employs lecture capture technology to record class sessions. Students may occasionally appear on video. The lecture recordings will be available to you for study purposes and may also be reused in future course offerings.

No notification is needed if only audio and slide capture is used or if the video only records the instructor's image. However, the instructor is encouraged to let students know the recordings will be available to them for study purposes.
