# **Course Description**

This course is an introduction to diatonic music of the common-practice era. We will briefly review music fundamentals before moving on to the basics of harmony, including reading/interpreting chord labels (Roman numerals, figured bass, and lead sheet) and writing harmonies in four-parts (SATB). We will also analyze different repertoire examples in order to understand common harmonic patterns and paradigms.

### **Course Structure**

This is a 15-week asynchronous online course (students learn course content on their own time rather than meeting at specified times each day with the instructor). The course will be divided into two halves and delivered in modules that are one week in length. There will be a test for the music fundamentals topics, a midterm exam, and a final exam. Additional modules will contain resources and practice materials.

# **Course Prerequisites or Other Restrictions**

Prerequisite: limited to current music majors or with consent of instructor

Corequisite: MUTH1410 (Aural Skills I)

**Restrictions:** enrollment is restricted and non-Texas resident students residing outside of the state are not eligible to enroll in this section. Contact the department for enrollment assistance in an appropriate section of the course, if applicable.

# **Course Objectives**

Upon successful completion of the course, students will be able to:

- 1. **Construct** scales (major, natural minor, harmonic minor, and melodic minor) and diatonic modes in treble and bass clefs.
- 2. **Write/compose** functional, tonal harmonic progressions featuring diatonic triads and seventh chords on the grand staff in SATB style (chorale style).
- 3. **Elaborate** upon a basic SATB-style chord progression by adding embellishing tones and seventh chords.
- 4. **Interpret and spell** diatonic triads and seventh chords from multiple music nomenclatures, including figured bass, Roman numerals, and chord symbols.
- 5. **Analyze** musical elements such as diatonic harmonies (chords), embellishing tones, and cadences in short score excerpts.
- 6. **Classify** diatonic harmonies (triads and seventh chords) within a musical score excerpt by their harmonic function within the phrase model (structural T, PD, or D chords; or as embellishing P, N, IN chords)

### **Materials**

No textbook or workbook is required for this course. I recommend the following materials: staff paper, pencils/erasable pens for homework assignments (if completing them by hand), binder/folder for lesson/video notes and homework assignments, access to a printer, and the Canvas mobile app (available for Android and iOS).

### **Rules of Engagement**

Rules of engagement refer to the way students are expected to interact with each other and with their instructors online. Here are some general guidelines:

- Treat your instructor and classmates with respect in email or any other communication.
- Always use your professors' proper title: Dr. or Prof., or if in doubt use Mr. or Ms.
- Unless specifically invited, don't refer to your instructor by first name.
- Use clear and concise language.
- Remember that all college level communication should have correct spelling and grammar (this includes discussion boards).
- Avoid slang terms such as "wassup?" and texting abbreviations such as "u" instead of "vou."
- Use standard fonts such as Ariel, Calibri or Times New Roman and use a size 10 or 12 point font
- Avoid using the caps lock feature AS IT CAN BE INTERPRETTED AS YELLING.
- Limit and possibly avoid the use of emoticons like:) or ©.
- Be cautious when using humor or sarcasm as tone is sometimes lost in an email or discussion post and your message might be taken seriously or sound offensive.
- Be careful with personal information (both yours and other's).
- Do not send confidential information via e-mail

### **Success in an Online Course**

While the online classroom shares many similarities with the face-to-face classroom, success in online education requires certain skills and expectations. You will need to be actively engaging with this course (logging in and accessing course content) most days during the week. Although this course is asynchronous, it is not strictly a complete-when-you-want course—there are a few assessments due on a week-to-week basis. I recommend that if you are struggling with any course topic, navigation, or access issue, that you contact me and seek help earlier, rather than later. One of the toughest hurdles for many students taking an online class, is time management, particularly in regard to scheduling time to learn the course content and completing assignments by the stated deadlines. # **Course Requirements**

You are expected to complete course assessments *independently* (see Academic Integrity statement on p. 9 for more details). Please ask for clarification if you are unsure about the instructions or the directions of any assessment before its due. Class assessments will be weighted according to the following breakdown:

**Homework Assignments:** there will be one homework assignment due at the end of most weeks (except during Test/Exam weeks). Students will complete the assignments by hand or in a program that enables PDF annotations, scan the assignment using a cell phone/scanner, and upload a PDF of the assignment into Canvas. Assignments are due on the dates specified in the schedule, usually by 11:59 pm CT; these must be completed neatly, and the scans must be legible (scans aren't necessary if you're annotating the file digitally). Your *lowest two* homework assignment scores will be dropped at the end of the semester.

**Quizzes:** quizzes will be focused on reading and comprehension (i.e., relating to the lesson content) and/or demonstrating new musical skills (e.g., chord spelling and analysis) based on the new chords and musical elements we cover. Students can attempt these types of quizzes 3–5 times each, depending on the particular quiz (there will often be different questions on additional attempts from a bank of questions). Your highest attempted score will be the one that is recorded in the grade book.

Fundamentals quizzes focus on music fundamentals (e.g., key signatures, scales, intervals etc.). Students can re-take these quizzes until they score 70% or higher by the due date. If a student is unable to score 70%, then the student will need to meet with the instructor and/or TA for extra help before the guizzes can be re-opened and re-attempted.

Make sure to always read quiz instructions, particularly for information on answer formatting. Your lowest two quiz scores (excluding the fundamentals quizzes) will be dropped at the end of the semester.

**Music Fundamentals Test:** a written fundamentals test will be available in the Music Fundamentals Module after students complete all of the music fundamentals quizzes with a minimum score of 70%. Students will be able to complete the written test by printing out the test or annotating a PDF version of it.

**Exams:** there will be an online midterm exam and an online final exam. Part of these exams will include a short worksheet for you to complete by hand or through PDF annotations. This worksheet would be scanned and submitted along with the other online questions. More details will be provided about the exam formats prior to the assessments. Given the nature of the course, the final exam will be cumulative, but the main emphasis will be on the topics covered since the midterm exam.

**Participation Activities**: to foster engagement and to help with content understanding, students will have various types of activities or discussions to answer. These types of assessments include surveys, discussion post responses, and short activities relating to course topics.

### Grading

Letter grades will be assigned according to the percentages below. A grade of C (70%) or higher is needed to pass this course and move on to Theory II.

A = 90-100%, B = 80-89%, C = 70-79%, D = 60-69%, and F = 0-59%

**Late Policies:** Each student can use **two "late passes"** in order to turn in two separate **homework assignments late** without penalty (up to a max. of 3 days or 72 hours after the Canvas due date). Please email the grader to request one of your late passes for the assignment (try to request the late pass within roughly 12 hours of the due date). Once you've used up your 2 late passes, any additional homework assignments submitted late will be subject to a grade deduction. The points deducted from a late assignment will be the equivalent of a 5% deduction per day it is late (e.g., after 11:59 pm Sunday through 11:59 pm Monday = 5% deduction etc.).

Quizzes and discussion/participation-related activities are due by the deadline posted. However, these assessments typically have an "available until" date, which is usually 24 hours after the due date, so you can still submit these assessments "late" by the available until date. Exams will be available from 8:00 am – 11:59 pm CT on the scheduled dates. Students may request adjustments to the time frame if they live in a different time zone (other than Central).

Students who have a documented excused absence will be allowed to write the midterm exam and/or final exam at an alternate time.

**Extra Credit:** except for possible bonus questions on homework assignments and exams and a bonus participation activity, there will be no other extra credit or make-up assignments in this class. It is important to complete assignments and quizzes as they are assigned (homework and quizzes account for almost half the grade at 45%).

### **Course Policies**

### **Assignment Policy**

Each assessment type will be available for students to complete for a specified amount of time and will include instructions on how to complete the assignment, what the acceptable file types for submission are (e.g., *pdf*), and an official due date (usually set for 11:59 pm CT). All assessments will be submitted online through Canvas. If any changes need to be made (e.g., extensions), I will notify students via a Canvas Announcement. Due dates can be found in each assessment, in your Canvas calendar, and in the To-Do list on the homepage. Keep in mind that the 2 late passes are reserved for homework assignments only.

Students taking an internet class are responsible for having a working computer and internet access. If your home Wi-Fi is not working, try to find alternative internet access if possible. Please contact me ASAP if your access to a computer or Wi-Fi is suddenly unavailable and I'll work with you to find a solution.

Students should immediately report any problems with Canvas videos or documents not working or opening to the class TA (sending a screenshot of these kinds of issues will be helpful). The University is committed to providing a reliable online course system to all users. **Instructor Feedback:** Students will generally receive immediate feedback on quizzes upon submission (unless there are questions that need to be graded manually). Homework assignments, discussion posts, and tests/exams will typically be graded within a week of the due date.

### **Late Work**

Homework assignments are typically due Sundays by 11:59 pm CST and will remain accessible until Wednesdays at 11:59 pm CT after the due date. If you submit your assignment after the due date and before the "available until" date (Wednesday 11:59 pm CST), Canvas will mark your submission as late. Late homework submissions will receive a daily penalty of 5%, up to a maximum of 15%, unless you request to use one of your two late passes. There are no late penalties applied when you use one of your late passes. Please see "Late Policies" under the Grading section for more details.

Gaining fluency in music takes consistent practice so I expect you to be watching the lesson videos and/or reading lesson materials, completing any assigned readings and practice questions, and participating in any other discussions or activities I assign that you would normally encounter during a face-to-face class (refer to the Assessment section of the syllabus for more on how participation factors into your overall grade).

### Important Notice for F-1 Students taking Distance Education Courses

### **Federal Regulation**

To read detailed Immigration and Customs Enforcement regulations for F-1 students taking online courses, please go to the Electronic Code of Federal Regulations website (http://www.ecfr.gov/). The specific portion concerning distance education courses is located at Title 8 CFR 214.2 Paragraph (f)(6)(i)(G).

The paragraph reads:

(G) For F-1 students enrolled in classes for credit or classroom hours, no more than the equivalent of one class or three credits per session, term, semester, trimester, or quarter may be counted toward the full course of study requirement if the class is taken on-line or through distance education and does not require the student's physical attendance for classes, examination or other purposes integral to completion of the class. An on-line or distance education course is a course that is offered principally through the use of television, audio, or computer transmission including open broadcast, closed circuit, cable, microwave, or satellite, audio conferencing, or computer conferencing. If the F-1 student's course of study is in a language study program, no on-line or distance education classes may be considered to count toward a student's full course of study requirement.

### **University of North Texas Compliance**

To comply with immigration regulations, an F-1 visa holder within the United States may need to engage in an on-campus experiential component for this course. This component (which must be approved in advance by the instructor) can include activities such as taking an on-campus exam, participating in an on-campus lecture or lab activity, or other on-campus experience integral to the completion of this course.

If such an on-campus activity is required, it is the student's responsibility to do the following:

- (1) Submit a written request to the instructor for an on-campus experiential component within one week of the start of the course.
- (2) Ensure that the activity on campus takes place and the instructor documents it in writing with a notice sent to the International Student and Scholar Services Office. ISSS has a form available that you may use for this purpose.

Because the decision may have serious immigration consequences, if an F-1 student is unsure about his or her need to participate in an on-campus experiential component for this course, s/he should contact the UNT International Student and Scholar Services Office (telephone 940-565-2195 or email internationaladvising@unt.edu) to get clarification before the one-week deadline.

### **Student Verification**

UNT takes measures to protect the integrity of educational credentials awarded to students enrolled in distance education courses by verifying student identity, protecting student privacy, and notifying students of any special meeting times/locations or additional charges associated with student identity verification in distance education courses.

### **Use of Student Work**

A student owns the copyright for all work (e.g. software, photographs, reports, presentations, and email postings) he or she creates within a class and the University is not entitled to use any student work without the student's permission unless all of the following criteria are met:

- The work is used only once.
- The work is not used in its entirety.
- Use of the work does not affect any potential profits from the work.
- The student is not identified.
- The work is identified as student work.

If the use of the work does not meet all of the above criteria, then the University office or department using the work must obtain the student's written permission.

### Transmission and Recording of Student Images in Electronically-Delivered Courses

- 1. No permission is needed from a student for his or her image or voice to be transmitted live via videoconference or streaming media, but all students should be informed when courses are to be conducted using either method of delivery.
- 2. In the event an instructor records student presentations, he or she must obtain permission from the student using a signed release in order to use the recording for future classes in accordance with the Use of Student-Created Work guidelines above.
- 3. Instructors who video-record their class lectures with the intention of re-using some or all of recordings for future class offerings must notify students on the course syllabus if students' images may appear on video. Instructors are also advised to provide accommodation for students who do not wish to appear in class recordings.

Example: This course employs lecture capture technology to record class sessions. Students may occasionally appear on video. The lecture recordings will be available to you for study purposes and may also be reused in future course offerings.

No notification is needed if only audio and slide capture is used or if the video only records the instructor's image. However, the instructor is encouraged to let students know the recordings will be available to them for study purposes.
