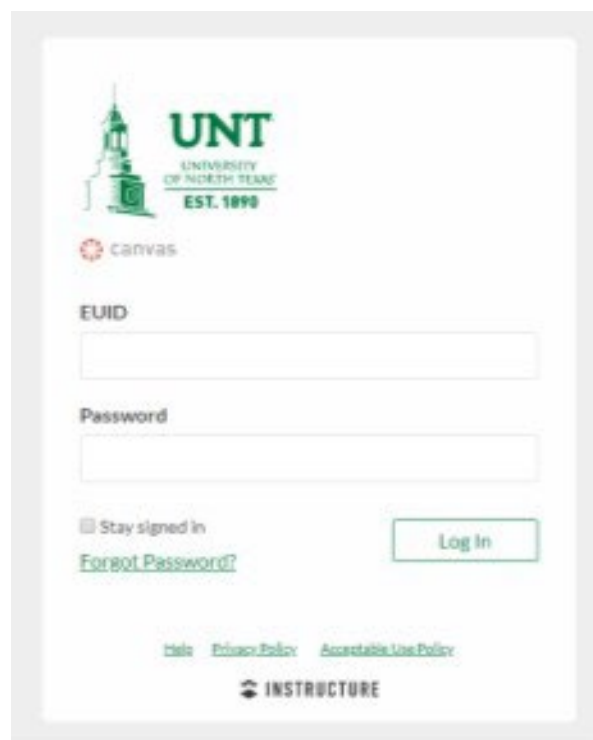
CATALOG DESCRIPTION

COURSE OBJECTIVES

Over the last decade, we have witnessed a major shift in business towards globalization. Global supply chains are a source of competitive advantage. The global configurations of firms provide access to cheap labor and raw materials, subsidized financing opportunities, larger product markets, arbitrage opportunities, and incentives offered by host governments to attract foreign capital. These benefits are available to firms today because of unprecedented transnational mobility of capital, information, people, products, and services; tremendous

leaps in information and communications technology; and increased opportunities and willingness of businesses to engage in e-commerce.

While it is easy to buy a good or service from any part of the global within a few minutes using the Internet, the products cannot be shipped using the Internet. We still need to rely on transportation and distribution of goods using traditional modes.

This course focuses on the application of different technologies to support logistics operations in supply chains.

At the end of this course, you should be able to:

- Explain the role of information and technology in supply chain integration.
- Describe information and technology applications in the areas of purchasing and supply, customer relationship, distribution, and reverse logistics, particularly in the context of Internet-enabled supply chains.
- Apply problem-solving skills using MS Excel.
- Complete sales and distribution, and purchasing exercises using SAP ERP package.
- Critique evolving technologies such as wireless applications and RFID and being able to assess the appropriateness of such technologies for a given situation or a problem.

Letter grades will be assigned according to the combination of both “absolute” points earned and performance “relative” to other students as follows. First, the total points earned will be compared to an absolute scale and a grade determined as per table below. Then, class standing (rank) will be determined based on total points earned, and a grade determined based on relative ranking as per the table below. The final grade will be no lower than the higher of the two grades (absolute or relative).

FEDERAL REGULATION: IMPORTANT NOTICE FOR F-1 STUDENTS TAKING DISTANCE EDUCATION COURSES

To read detailed Immigration and Customs Enforcement regulations for F-1 students taking online courses, please go to the [Electronic Code of Federal Regulations website](http://www.ecfr.gov/) (<http://www.ecfr.gov/>). The specific portion concerning distance education courses is located at Title 8 CFR 214.2 Paragraph (f)(6)(i)(G).

The paragraph reads:

(G) For F-1 students enrolled in classes for credit or classroom hours, no more than the equivalent of one class or three credits per session, term, semester, trimester, or quarter may be counted toward the full course of study requirement if the class is taken on-line or through distance education and does not require the student's physical attendance for classes, examination or other purposes integral to completion of the class. An on-line or distance education course is a course that is offered principally through the use of television, audio, or computer transmission including open broadcast, closed circuit, cable, microwave, or satellite, audio conferencing, or computer conferencing. If the F-1 student's course of study is in a language study program, no on-line or distance education classes may be considered to count toward a student's full course of study requirement.

University of North Texas Compliance

To comply with immigration regulations, an F-1 visa holder within the United States may need to engage in an on-campus experiential component for this course. This component (which must be approved in advance by the instructor) can include activities such as taking an on-campus exam, participating in an on-campus lecture or lab activity, or other on-campus experience integral to the completion of this course.

If such an on-campus activity is required, it is the student's responsibility to do the following:

- (1) Submit a written request to the instructor for an on-campus experiential component within one week of the start of the course.
- (2) Ensure that the activity on campus takes place, and the instructor documents it in writing with a notice sent to the International Student and Scholar Services Office. ISSS has a form available that you may use for this purpose.

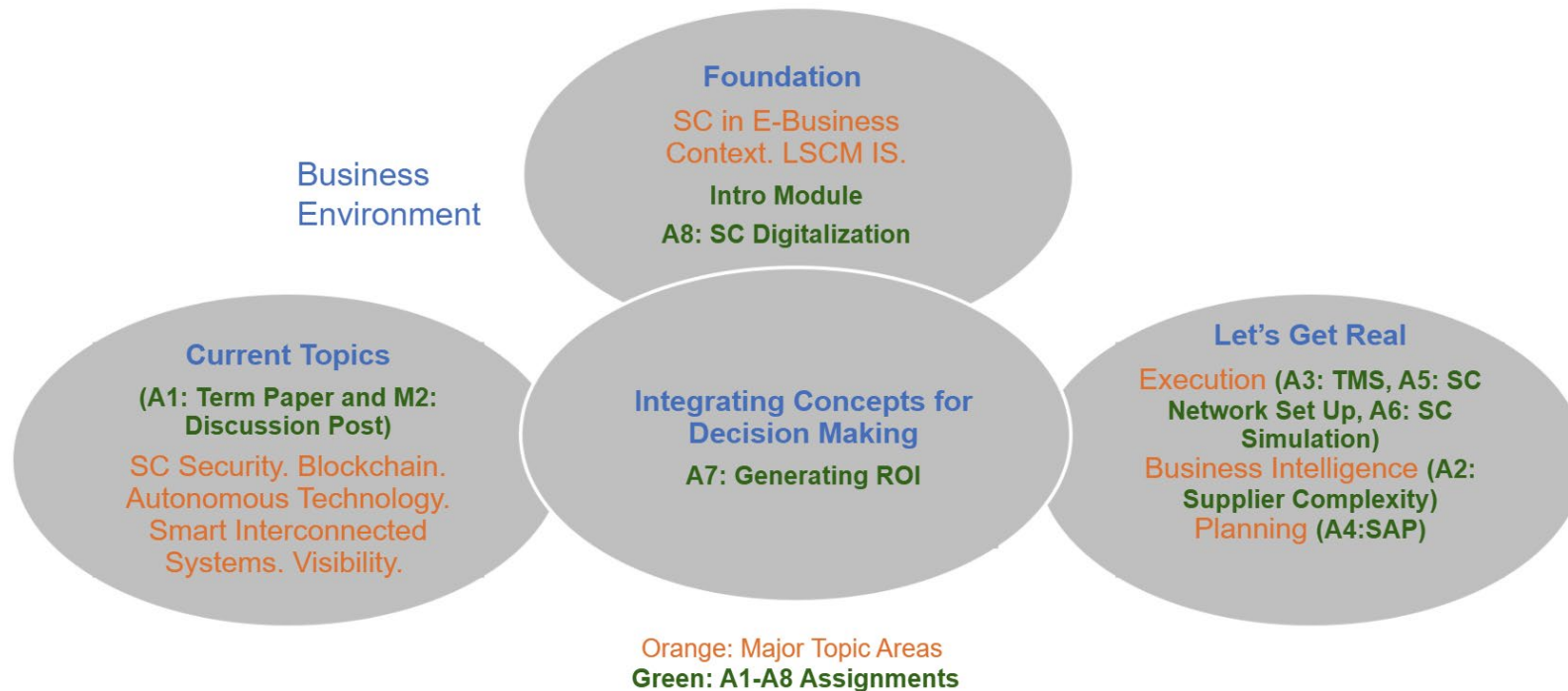

COURSE FRAMEWORK

This chart shows the overall course framework. The major topics and assignments are all aligned to develop a better understanding of how technology may be leveraged to develop a competitive advantage. The schedule in the syllabus provides detailed information on the components of the course framework. Broadly, the course aims to create understanding in four areas. First, understanding the strategic foundations of supply chains. Second, understanding the components of logistics and supply chain information systems and critical decisions regarding these systems. Most of these components are practically applied using real-world software. Third, multiple current topics are explored. The course involves assignments employing an Enterprise Resource Planning software called SAP, a Transportation Management System called MercuryGate, a simulation modeling software called SC Guru, and two Excel based assignments on Generating ROI and Supplier Complexity. Fourth, assignments A1, A7, and A8 are employed to integrate multiple concepts and tools explored in this course for decision making.

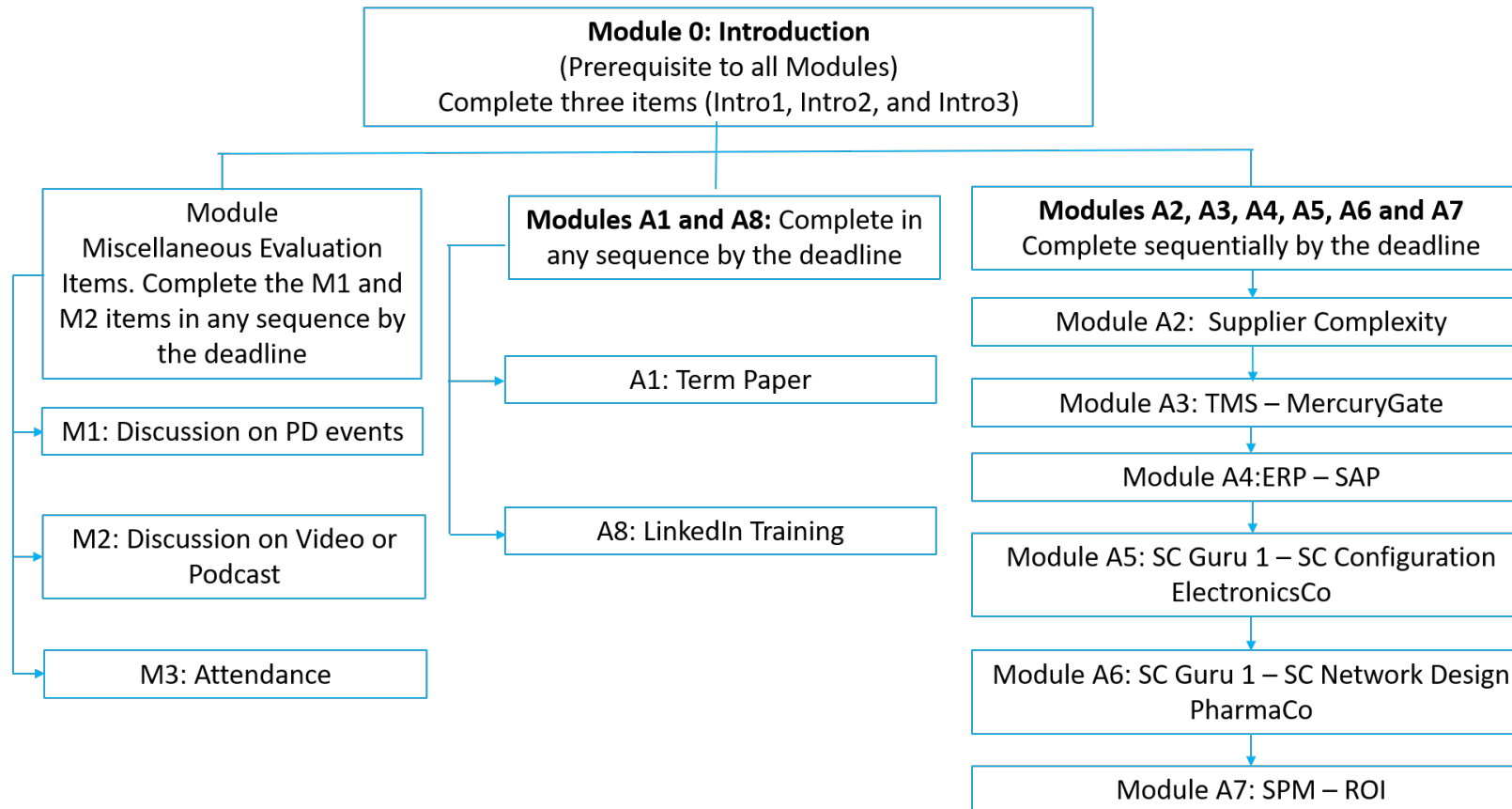

MODULES

The course comprises of ten modules. Module 0 (Introduction) is a prerequisite for all other modules in the course. There are eight assignment modules. A1 had multiple parts with different deadlines. A8 is available early on in the semester but is due at the very end. All other assignments have fixed deadlines. See [Course Schedule](#) for deadline. The assignments A2 through A7 must be completed sequentially. As soon as you submit ALL parts of one assignment, the next one opens up. The remaining three evaluation items - Video/Podcast Discussion Post, Professional Development, and Attendance - items are posted in a module titled Miscellaneous Evaluation Items. Each one has a deadline and must be completed before the stipulated deadlines.
