Course Description:

3 Credit Hours. Visual observation of the figure and interpretation through various graphic techniques. Prerequisite: ART 1600 and 1700 or 1800 with a C or better.

Course Content:

This drawing class is designed to develop your observational abilities and rendering skills, and to provide a concentrated investigation into gesture, proportion, light, space, form, composition, and anatomy. The emphasis will be on realism (i.e. drawing what you see) using traditional academic drawing techniques. Students will learn methods of describing what they observe through an exploration of the basic visual elements of line, shape, and value. We will be using primarily charcoal and graphite.

Course Objectives:

- Develop acute observational skills and hand-eye coordination, using the figure as our primary subject.
- Acquire foundational knowledge and skills in the use of basic tools, techniques, and processes sufficient to work from concept to finished product, including knowledge of drawing media and surfaces.
- Develop skill in the analysis and evaluation of drawing.
- Apply the vocabulary of art and design to the critique and analysis of your drawings and the works of others.
- Become aware of basic elements of human anatomy and anatomical landmarks.

Course Content:

- Learn to translate the illusion of 3D forms onto a flat 2D surface.
- Observe and represent accurate shapes, proportions, and gestures.
- Develop a sensitivity to value relationships (both general and subtle, large and small) by investigating how light interacts with 3D forms and spaces.

- Hone your awareness of anatomical landmarks, and how they help to understand proportions of the body.
- Develop an understanding of, and sensitivity to, the various media used throughout the course.

Course Structure:

- Online: Course information, including announcements, syllabus, assignments, lecture presentations, and other resources, can be found on Canvas. You must turn on email notifications for announcements to receive important information about the class throughout the semester.
- Lab: This class requires a 2-hour 50-minute in-person lab meeting twice a week. You will learn about the fundamentals of figure drawing through lectures and demos by the instructor and will apply these principles through guided and independent studio exercises. You will also receive feedback about your work during one-on-one meetings with the instructor and in-progress/formal critiques with your peers.

Course Expectations:

- Communication: You will promptly notify the instructor of any questions, concerns, requests, updates, or any other necessary inquiries through email. Responses will be provided at a reasonable timeframe, usually within 24 hours, on weekdays.
- Etiquette: You are expected to come to class on time, be prepared with your materials, and treat everyone with courtesy and respect. Follow all guidelines posted in the studio regarding material handling and safety measures. Do not bring food and drinks inside the studio. Do not use, take, or move other students' materials without permission. Make sure to clean up after yourself at the end of each class and respect the shared space of the classroom.
- Engagement: Your full attention and active involvement during class are expected. Phone/laptop usage is strongly prohibited; after excessive warnings, the instructor reserves the right to lower your grade for distractive behavior. Wearing headphones/earphones is also not permitted outside of independent studio time. Working on assignments from other classes is also prohibited. Leaving early during class with no prior notice to the instructor will result in an absence for the day. Engaging in any other behavior or conduct deemed as disruptive, impeding, hostile, or interfering with your classmates' ability to learn will not be tolerated.

- Class Breaks: The instructor will provide several breaks throughout each class. During this time, feel free to check your devices, get water, eat snacks outside the room, and so on.
- Critique: You are expected to bring a selection of finished work on critique days. When talking about your work or others', try to use vocabulary terms that you have learned in the course to demonstrate your grasp and mastery of the course concepts. Take notes of any input that you receive and offer thoughtful, constructive feedback to others.
- Figure Models: This class will use nude live models to aid us in our drawing exercises. Please treat all models with respect. We will be working with models from various walks of life. Please do not take photographs of the models or make any inappropriate advances. Do not ask for their information and always make sure to respect their personal space. Any form of behavior that is deemed inappropriate will be subject to a report to the Dean of Students.
- Time Management: You are expected to devote around 10-12 hours per week for this class, including lab time. Outside of class, you are expected to work on assignments, practice skills you have learned in exercises, and continually build on your sketchbook by conducting visual research, material exploration, and more.
- Cleanup: You must participate in the studio cleanup at the end of the semester.

Drawings

You will submit your work electronically on Canvas, which will also have the details, rubrics, and file formatting guidelines for each assignment. Late work will incur a 10% penalty for each day after the deadline. Extension requests must be communicated in advance to the instructor through email with proper documentation attached as needed. You are expected to photograph your artwork effectively, using proper lighting and documentation techniques. CVAD Photo Documentation Services is also a resource that provides professional artwork documentation services to CVAD students by appointment at no cost (<https://cvad.unt.edu/cvad-it-services/it-services-photo-documentation.html>).

Sketchbook

You will keep a record of your visual research, practice, and observations in your sketchbook which you are expected to bring each class. As a compendium and journal, it serves as your space to freely explore, test materials, and make sketches/composition studies without the pressures of a finished assignment. It is a place to document ideas, write down notes, and digest or process any assigned course material. You will submit your cumulative sketchbook entries electronically on Canvas both at the midpoint and end of the semester. It is recommended that you use a scanner to document the pages of your sketchbook. Scanners can be found in the CVAD Student Computer Lab or Willis Library.

Critique

During critiques, you are expected to present a selection of your work up to that point in the class that best demonstrates your grasp of various techniques taught in the course. These

will include work from assignment submissions, which can be reworked based on instructor feedback. You will be graded on your ability to present a collection of your own work and engage in critical dialogue about the development and progression of applied concepts across different approaches, both within your work and those of your peers.

Critiques are mandatory and cannot be made up, so plan for these days accordingly.

Participation

Your participation grades will entail your adherence to all studio etiquette, guidelines, and expectations; your level of engagement during lectures, demonstrations, exercises, studies, and one-on-one conversations with the instructor; your involvement and effort in sketchbook check-ins; and your participation in the end-of-semester studio cleanup.

Attendance Policy:

Attendance is mandatory and is a critical part of this course. You are expected to be punctual and bring your materials and sketchbook to class each day. The instructor will take roll call at the start of class; ten minutes is considered late. **Three absences will be tolerated.** More than three absences will require a note from a doctor or a note from the art office excusing the absence for a reason covered under UNT policy 06.039 (Student Attendance and Authorized Absences). **Accruing more than three absences will lower your final grade by one letter grade per additional absence.** Most lectures, demonstrations, and exercises will occur at the beginning of class periods and will not be repeated for those who come in late. HEALTH & SAFETY AREA SPECIFIC INFORMATION: DRAWING

1. Hazards of Media (inherent)

Educate yourself about the drawing materials you are using by reviewing the SDS for all materials you use.

Drawing materials are pigments suspended in “vehicles” such as wax (crayons), inert materials (pastels, conte crayons, chalks), clay (pencils), and liquids (solvent/water-based inks and marking pens). The hazards of traditional drawing materials arise from exposure to pigments, vehicles, and solvents, and are dependent on the toxicity of those elements. Exposure can cause a variety of health issues (for both you and those around you) ranging from skin irritation to lung cancer. The primary forms of exposure to these toxic materials are inhalation, contact, and accidental ingestion. See the “Best Practices” section for way to avoid/lessen exposure.

Fixative				High exposure through inhalation of solvent and plastic particulates.
Spray Adhesive (not allowed in CVAD spray booths)				High exposure through inhalation of solvent and other toxic chemicals. Possible skin irritation.

Charcoal/Chalk				Nuisance dust, but can cause chronic lung problems if large amounts are inhaled.

Liquid Materials (solvent-based)				Solvent-based drawing inks and permanent felt tip markers often contain Xylene or Alcohol.

2. Best Practices

Working safely means becoming more knowledgeable about the hazards of the media that you work with, making changes in how you select and handle your art materials, and creating a healthier environment to work in. Many of these hazards can be prevented by following these guidelines:

- In case of emergency, call campus police at (940) 565-3000 or call 911
- Wear gloves, wash hands regularly, and avoid any over exposure to materials.
- Try to brush items rather than spraying if possible.
- Never use aerosol media in the classroom. Use the spray booths provided.
- Never try to spray paint by blowing air from your mouth through a tube.
- Use the least dusty types of pastels, chalks, and charcoal
- Don't blow off excess pastel or charcoal dust with your mouth. Instead tap off the build up dust so it falls to the easel tray, trash bin, or floor.
- Wet-wipe or vacuum all surfaces clean of dusts. Do not sweep.
- Use water-based media rather than solvent-based media when possible.
- Alcohol-based markers are less toxic than aromatic solvent-based markers
- All solvent-based drawing inks and permanent markers should be used with good dilution ventilation.

3. Area Health & Safety Rules

All users of the studio classrooms are expected to follow studio area rules. If you have any questions, ask your instructor.

- Follow all CVAD Health and Safety handbook guidelines (the handbook should be reviewed by your instructor and can be found here:
<https://art.unt.edu/healthandsafety>)
- Follow the CVAD Waste Management Chart in the classroom and other health & safety guidelines posted
- File an incident report (forms may be found in the CVAD H&S handbook and in the main office) within 48 hours of the event)
- Do not prop classroom doors. Doors are to remain closed to ensure the building HVAC and ventilation work properly
- Respect the workspace and your fellow classmates.
- Leave the space cleaner than you found it
 - Clean up and organize your surroundings
 - Throw away trash- whether it is yours or not
 - Wipe down your easels, drawing horse and floor area using a wet towel

- Wipe down sinks at the end of class
- Respect other's work. Do not use or move other students' work/materials
- No food or drink allowed in the studio
- Practice best practices for material handling. If you have questions, ask your instructor
- Do not create "daisy chains" with multiple electric cords.
- No hazardous materials down the sink
- Store all flammables in the flammable cabinet. Always keep the flammable cabinet door closed.
- First aid kits are found in each studio. Notify your instructor or area technician.
- All courses must engage in the end of semester clean up.
- Only use your class's designated flat files for storage
- Theft will not be tolerated.
- Follow the CVAD CONTAINER POLICY (see below)

There are 3 types of labels used in CVAD.

All containers must have a label always identifying the contents.

UNIVERSAL LABELS (while chemical is in use):

All secondary/satellite containers for hazardous materials (or what might be perceived as hazardous -i.e., watered-down gesso, graphite solutions, satellite containers of solvents, powders, spray paints, fixatives, oils, solvents) must be marked with content, your name and the date opened. All unmarked containers will be disposed of with no notice. Labels can be found in the studios. All containers must be marked with your name, contents and date opened.

UNIVERSAL WASTE LABELS (when material is designated as waste):

All containers solely containing a universal waste must have a universal waste label identifying the contents as "Universal Waste - (type of universal waste)" that are designated as waste for proper disposal. The label must also include the date the first item of universal waste entered the container.

HAZARDOUS WASTE LABELS:

All hazardous waste containers must have a label identifying the contents as hazardous. Labels should include all constituents in the waste mixture as well as an approximate percentage of the total for that item. All constituents should equal 100%.
