Broad Course Goals:

-Developing a fundamental music literacy necessary to the appreciation of a century of musical ideas and essential to effective function among fellow musicians.

-Developing tools to understand how music is put together, which will empower you to be stronger in listening, performing, teaching, and writing.

Specific Course Goals:

Developing a comprehensive analytical toolbox for approaching the diverse styles of the 20th-century. A broad sweep of the period will be tackled conceptually (rhythm, harmony, melody, etc.)

Attendance
