COURSE DESCRIPTION

(from course catalog, which can be found at <http://catalog.unt.edu>)

Introduction to painting practices and issues, including the study of methods and materials (oil, acrylic, tools, building of supports and surfaces), composition, value, color, and pictorial space centered on observation. Course work focus on the capacities of painting and introduces students to technical and historical issues central to painting.

REQUIRED COURSE MATERIALS

Supply List

- 3 sheets Heavy duty drawing paper (Arches Cover, Rives BFK, or similar)
- 2-18" x 24" canvases
- 1-24" x 36" canvas
- 1-36" x 48" canvas

- Gesso 1 quart
- Gesso brush (cheap house painting brush, 2")
- Metal palette knife(s) Style optional—you may want to try out a couple of different designs
- Brushes: range of small to large sizes...MUST have two each (one set synthetic for Acrylic paint, one set natural boar hair for oil paint) -Flat 8, 10, 12, Bright 8, 10.
- Paint: Required colors in both acrylic paint and oil paint: **You must find these exact color names in your paint. Learning to mix colors will be difficult or impossible unless these color names are purchased. Do not simply buy "Red, Yellow, Blue"...pay attention to the names of each color and buy exactly those.**

Cadmium Red Deep (Cad. Red Deep Hue is acceptable)

Cadmium Yellow Light (not "Pale")

Ultramarine Blue

Titanium White.

You are required to use these colors **only** until your Self Portrait assignment, at which time I will suggest other colors to add to your set that will help you mixing hues for your skin.

→ Mediums for Oil Paint. Liquin, Galkyd, or other kinds of alkyd medium. (wait to buy these after we've discussed the use of mediums)

→ Rags: Rags are a must! Cotton painting rags from Home Depot or Lowe's are a good buy. You can also recycle old t-shirts and other cotton fabrics.

READINGS

Readings will be assigned as required, and available on Canvas in PDF form.

CLASS PARTICIPATION EXPECTATIONS

I expect you to attend every class. You are responsible for completing all of the required assignments. I expect all students to participate in class discussions, contributing ideas and perspectives on topics or art. All your work should incorporate aspects or issues addressed in class in relation to your personal or professional interests.

You are expected to assist in maintaining a classroom environment that is conducive to learning. In order to assure that everyone has an opportunity to gain from time spent in class, unless otherwise approved by the instructor, you are prohibited from using cellular phones or beepers, checking your email or surfing the internet, updating your social networking sites, eating or drinking in class, making offensive remarks, reading newspapers or magazines, sleeping or engaging in any other form of distraction. Inappropriate behavior in the classroom shall result in, minimally, a request to leave class, which will be counted as an unexcused absence

ATTENDANCE POLICY

- Regular and punctual attendance is mandatory.
- Three absences will be tolerated.
- More than three absences will require a note from a doctor or a note from the art office excusing the absence for a reason covered under UNT policy 06.039 (Student Attendance and Authorized Absences) in order to be counted as excused.
- More than three absences will lower your final grade by one letter grade per additional absence (4 or more)
- Most lectures, demonstrations, and assignments will occur at the beginning of class periods and will not be repeated for those who come in late. If you are late to class, you will need to notify me at the end of the class period to replace an absence with a tardy. Three tardies will constitute an absence.
- A tardy is considered to be arrival 5 minutes after the beginning of class.
- Assignments that are turned in late will receive one letter grade lower per day for each day they are late.
- Examinations, quizzes, and in-class assignments missed may only be made up with an official doctor's excuse or note from the art office excusing the absence for a reason covered under UNT policy 06.039 (Student Attendance and Authorized Absences).
- Critiques missed may not be made up and grades will reflect the student's failure to participate in the critique discussions.

LATE WORK / MAKE-UP POLICY

Late work may be subject to a penalty of 10% deducted from the assignment's value per day the work is late, unless the student provides proof of an acceptable mitigating circumstance: serious illness, death of a family member, or other circumstance if approved by the instructor.

GRADING

Grades will be provided regularly through the semester (after assignments are submitted, critique, etc...) and at mid-term.

Students enrolled in this class are required to use proper safety procedures and guidelines as outlined in UNT Policy 15.2.4 Safety in Instructional Activities. While working in laboratory sessions, students are expected and required to identify and use proper safety guidelines in all activities requiring lifting, climbing, walking on slippery surfaces, using equipment and tools, handling chemical solutions and hot and cold products. Students should be aware that the UNT is not liable for injuries incurred while students are participating in class activities. It is strongly suggested that students get a large locker on the third floor of the art building to store supplies. Students will not be allowed to leave paintings on easels or walls of the studio after class. The shelving provided in the classroom may be used to store paintings currently being worked on, but students should be aware of the potential for damage, vandalism, and theft when storing work in public areas. It is not safe to leave materials in the painting studio...they will be stolen! Once a painting assignment is completed and graded, the student must take the work home. SOVA does not provide long term storage of work. Students will dispose of all hazardous liquids (thinners, brush cleaners, turpentine)

in the hazardous liquids jugs in the corner of the room next to the storage cabinet. Dispose of all oily rags in the red fire bins also in the corners of the painting studio. No paint, acrylic or oil, should be disposed of in the sink drains! Throw all scraped paint into a trash can containing a liner. Brushes for acrylic paints may be cleaned in the sink, but only after sufficiently rinsing them in your thinner containers.

There will be no smoking, eating, or drinking allowed in the classroom. Headphones are not allowed during class.

Though painting would seem to be relatively risk free, there are risks and safety practices you should be aware of. Most of the solvents used in oil painting (Turpentine, thinners, mediums, etc.) are toxic. In fact, some paints, like cadmium red, are also toxic. Consult the labeling of solvents and pigments for information. Toxic materials should not be ingested or allowed to touch the skin. Wear protective gloves when using these materials in order to avoid skin contact. When using solvents, always have good ventilation. When spraying commercially available enamels, lacquers, or fixatives, do so in the spray booth and wear a respirator designed for organic vapor protection. A dust mask or a scarf or t-shirt pulled over your face will not protect you. Furthermore, it is never a good practice to eat while using painting materials. If you intend to use the shop, make certain to observe ALL safety rules. If you decide to use materials not addressed above, read the safety labels and consult with your instructor as to their safe use.

Students should be aware that the University of North Texas is not liable for injuries incurred while students are participating in class activities.
