## COURSE DESCRIPTION

(from course catalog, which can be found at <http://catalog.unt.edu>)

Introduction to painting practices and issues, including the study of methods and materials (oil, acrylic, tools, building of supports and surfaces), composition, value, color, and pictorial space centered on observation. Course work focus on the capacities of painting and introduces students to technical and historical issues central to painting.

## COURSE REQUIREMENTS

Students are required to complete 9 completed paintings (as stated by assignments below), participate in class discussions and critiques, learn and execute the building of two (2) stretchers. In the process of completing these tasks, you will learn to properly prepare your ground (painting surface), prepare and use a glass painting palette, mix colors correctly, use mediums and paint additives correctly, apply paint to ground (both acrylic and oil), complete an illusionistic image in various ways, properly store and clean painting tools, and understand correct studio safety and cleaning protocols.

Students are required to attend and participate in studio clean up on December 1<sup>st</sup> during class hours. Failure to attend and participate in final clean-up will result in a **one-letter-grade drop in your final grade**. You are responsible for cleaning your work area, your storage area, your checked out palette, and your hazardous materials area (inside the chemical cabinet). You are to remove on this day all stored work and materials from both your storage cubby and your rented locker. Gamsol Silcoils will be recycled on this day if you do not take yours home with you.”

**The final studio clean up of all the rooms on the fourth floor is Friday, Dec. 10<sup>th</sup>, 12pm. Any artwork or materials left after this day will not be stored for you and will be disposed of. There are no exceptions to this deadline.**

#### **REQUIRED & OPTIONAL COURSE MATERIALS / TEXTBOOKS**

##### Supply List

- Masonite panel, 2x4 feet x ¼”
- 3 sheets Heavy duty drawing paper (Arches Cover, Rives BFK, or similar)
- 2 canvases 18x24, 1 canvas 24” x 36”, 1 canvas 36” x 48”
- Gesso
- Palette knife (Style optional—you may want to try out a couple of different designs)
- Brushes: range of small to large sizes...MUST have one each-Flat 8, 10, 12, Bright 8, 10. **Please buy good quality brushes. They will be worth the investment and will last for years if cared for properly!**
- Gesso Brush: 2” or larger latex house painting brush
- Singel Edge Razor blade scraper, 10-15 blades
- Paint: Required colors: Cadmium Red Deep, Cadmium Yellow Light (not “Pale”), Ultramarine Blue, Titanium White (Large (200ml) Tube...you will probably use more than one of these this semester!). Optional colors: Naples Yellow, Burnt Sienna, Cobalt Blue, Raw Umber, Pthlalo Green, Ivory Black. You must buy all required colors in Oil and Acrylic paint..(Stay Away from “Aritisan” water Soluable Oil Paints.
- Mediums for Oil Paint. Galkyd (Gamblin product), Liquin (Windsor-Newton product) or other brands of alkyd medium. You may also mix your own medium with pure gum turpentine, dammar varnish, linseed and/or stand oil (small amounts of turpentine will be allowed in the form of painting medium)

→ Rags: Rags are a must! Cotton painting rags from Home Depot or Lowe's are a good buy. You can also recycle old t-shirts and other cotton fabrics. **DO NOT USE PAPER TOWELS FROM OUR DISPENSERS!**

→ Containers for medium and thinners. Lids are strongly suggested! Large Coffee cans are great, as are mason type jars. Tin foil, if no lids. (you are provided a Silcoil container, and unlimited Gamsol...the only approved oil painting thinner. You will need to provide your own containers for water when using acrylic paint.)

→ Optional for Oil Painting: Liquin, Galkyd, Galkyd Lite, Galkyd Slow Dry, Dammar Varnish or Crystals, Walnut Oil, Poppy Oil, Stand oil, and/or linseed oil. Do not buy boiled linseed oil from hardware stores. This is not suitable for oil painting.

→ Other options: Boraxo soap for cleaning brushes, surgical or cleaning gloves, sponges, modeling paste, acrylic mediums and additives, Lava soap, Fast Orange, or other mechanic's type hand cleaners.

→ Other items may need to be purchased throughout the semester. You will be expected to replenish supplies as you run out.

## **REQUIRED READINGS**

Readings will be assigned as required, and available on Canvas in PDF form.

## **CLASS PARTICIPATION EXPECTATIONS**

I expect you to attend every class. You are responsible for completing all of the required assignments. I expect all students to participate in class discussions, contributing ideas and perspectives on topics or art. All your work should incorporate aspects or issues addressed in class in relation to your personal or professional interests.

You are expected to assist in maintaining a classroom environment that is conducive to learning. In order to assure that everyone has an opportunity to gain from time spent in class, unless otherwise approved by the instructor, you are prohibited from using cellular phones or beepers, checking your email or surfing the internet, updating your social networking sites, eating or drinking in class, making offensive remarks, reading newspapers or magazines, sleeping or engaging in any other form of distraction. Inappropriate behavior in the classroom shall result in, minimally, a request to leave class, which will be counted as an unexcused absence

## **ATTENDANCE POLICY**

- Regular and punctual attendance is mandatory.
- Three absences will be tolerated.
- More than three absences will require a note from a doctor or a note from the art office excusing the absence for a reason covered under UNT policy 06.039 (Student Attendance and Authorized Absences) in order to be counted as excused.
- More than three absences will lower your final grade by one letter grade per additional absence (4 or more)
- Most lectures, demonstrations, and assignments will occur at the beginning of class periods and will not be repeated for those who come in late. If you are late to class, you will need to notify me at the end of the class period to replace an absence with a tardy. Three tardies will constitute an absence.
- A tardy is considered to be arrival 5 minutes after the beginning of class.

- Assignments that are turned in late will receive one letter grade lower per day for each day they are late.
- Examinations, quizzes, and in-class assignments missed may only be made up with an official doctor's excuse or note from the art office excusing the absence for a reason covered under UNT policy 06.039 (Student Attendance and Authorized Absences).
- Critiques missed may not be made up and grades will reflect the student's failure to participate in the critique discussions.
- COVID-19 impact on attendance:

Please contact me if you are unable to attend class because you are ill, or unable to attend class due to a related issue regarding COVID-19. Students enrolled in this class are required to use proper safety procedures and guidelines as outlined in UNT Policy 15.2.4 Safety in Instructional Activities. While working in laboratory sessions, students are expected and required to identify and use proper safety guidelines in all activities requiring lifting, climbing, walking on slippery surfaces, using equipment and tools, handling chemical solutions and hot and cold products. It is strongly suggested that students get a large locker on the third floor of the art building to store supplies. Students will not be allowed to leave paintings on easels or walls of the studio after class. The shelving provided in the classroom may be used to store paintings currently being worked on, but students should be aware of the potential for damage, vandalism, and theft when storing work in public areas. It is not safe to leave materials in the painting studio...they will be stolen! Once a painting assignment is completed and graded, the student must take the work home. SOVA does not provide long term storage of work. Students will dispose of all hazardous liquids (thinners, brush cleaners, turpentine)

in the hazardous liquids jugs in the corner of the room next to the storage cabinet. Dispose of all oily rags in the red fire bins also in the corners of the painting studio. No paint, acrylic or oil, should be disposed of in the sink drains! Throw all scraped paint into a trash can containing a liner. Brushes for acrylic paints may be cleaned in the sink, but only after sufficiently rinsing them in your thinner containers.

There will be no smoking, eating, or drinking allowed in the classroom. Headphones are not allowed during class.

Though painting would seem to be relatively risk free, there are risks and safety practices you should be aware of. Most of the solvents used in oil painting (Turpentine, thinners, mediums, etc.) are toxic. In fact, some paints, like cadmium red, are also toxic. Consult the labeling of solvents and pigments for information. Toxic materials should not be ingested or allowed to touch the skin. Wear protective gloves when using these materials in order to avoid skin contact. When using solvents, always have good ventilation. When spraying commercially available enamels, lacquers, or fixatives, do so in the spray booth and wear a respirator designed for organic vapor protection. A dust mask or a scarf or t-shirt pulled over your face will not protect you. Furthermore, it is never a good practice to eat while using painting materials. If you intend to use the shop, make certain to observe ALL safety rules. If you decide to use materials not addressed above, read the safety labels and consult with your instructor as to their safe use.

Students should be aware that the University of North Texas is not liable for injuries incurred while students are participating in class activities. All students are encouraged to secure adequate insurance coverage in the event of accidental injury. Students who do not have insurance coverage should consider obtaining Student Health Insurance for this insurance program.
