

- 3. Identify and apply effective strategies to assist individuals with disabilities in obtaining meaningful employment.
- 4. Utilize vocational evaluations, job analyses, and labor market information to support informed career planning for individuals with disabilities.
- 5. Understand the principles and practices of supported employment and their role in vocational rehabilitation.
- 6. Demonstrate the ability to work effectively with clients from diverse backgrounds.

Rules of Engagement

Rules of engagement refer to the way students are expected to interact with each other and with their instructors. Here are some general guidelines:

• Be cautious when using humor or sarcasm in emails or discussion posts as tone can be difficult to interpret digitally.

- Avoid using "text-talk" unless explicitly permitted by your instructor.
- Proofread and fact-check your sources.
- Keep in mind that online posts can be permanent, so think first before you type.

Course Requirements

Assessments

This course is made up of assignments and assessments to assist you in achieving the course learning objectives/outcomes. Each week you will work on various assignments, activities, discussions, readings, research, etc. which will be made available to you by Monday at 8:00 am and close on the Sunday at 11:59 pm. Discussion Forum (15 total 5 points) = 75 points

Students will be active and engaged participants in the discussion forums by analyzing, constructing/creating, and evaluating information presented within the textbook, external readings/resources, student postings, and class activities. Heavy emphasis will be placed on participation related to the week's topics.

The discussion forums are related to the chapter readings, external resources, and activities. Upon completion or near completion of the assigned readings and activities, you are expected to engage in an ongoing discussion/debate with your learning community peers.

Assessment Method: Rubric

Quiz (15 total 5 points) = 75 points

Four quizzes will be conducted to evaluate your understanding of the assigned readings and related course content. All exams will be completed online through the Canvas exam platform. Each exam will be timed, and grades will be made available to students upon submission.

Community Connection Project (25 points) = 25 points

This assignment is designed to help you actively explore and connect with community-based resources that support individuals with disabilities. Understanding these resources is essential for future counselors, as it helps build a network of support systems you can share with your clients.

Identify and explore a **local community resource** that you believe would be valuable to your future clients. Your chosen organization should either:

- Have an employment-focused mission,
- Provide employment-related services, or
- Hire individuals with disabilities

Examples of potential resources include:

- Local branches of national organizations
- Supported employment programs
- Vocational rehabilitation services
- Clubhouses or community centers
- Disability advocacy organizations

Your entry should be between three to five paragraphs in length and include:

- The name and location of the organization
- A brief description of its mission and services
- An explanation of how it supports individuals with disabilities
- How the resource connects to employment and other areas of life that support employability
- A short reflection on how you might use or refer this resource in your future counseling practice

Important Notice for F-1 Students taking Distance Education Courses

Federal Regulation

To read detailed Immigration and Customs Enforcement regulations for F-1 students taking online courses, please go to the Electronic Code of Federal Regulations website at http://www.ecfr.gov/. The specific portion concerning distance education courses is located at Title 8 CFR 214.2 Paragraph (f)(6)(i)(G).

The paragraph reads:

(G) For F-1 students enrolled in classes for credit or classroom hours, no more than the equivalent of one class or three credits per session, term, semester, trimester, or quarter may be counted toward the full course of study requirement if the class is taken on-line or through distance education and does not require the student's physical attendance for classes, examination or other purposes integral to completion of the class. An on-line or distance education course is a course that is offered principally through the use of television, audio, or computer transmission including open broadcast, closed circuit, cable, microwave, or satellite, audio conferencing, or computer conferencing. If the F-1 student's course of study is in a language study program, no on-line or distance education classes may be considered to count toward a student's full course of study requirement.

University of North Texas Compliance

To comply with immigration regulations, an F-1 visa holder within the United States may need to engage in an on-campus experiential component for this course. This component (which must be approved in advance by the instructor) can include activities such as taking an on-campus exam, participating in an on-campus lecture or lab activity, or other on-campus experience integral to the completion of this course.

If such an on-campus activity is required, it is the student's responsibility to do the following:

- (1) Submit a written request to the instructor for an on-campus experiential component within one week of the start of the course.
- (2) Ensure that the activity on campus takes place and the instructor documents it in writing with a notice sent to the International Student and Scholar Services Office. ISSS has a form available that you may use for this purpose.
