**Course Description**: Intermediate through advanced skill development in MIDI sequencing, recording, editing, mixing and audio mastering using the Logic Pro X Digital Audio Workstation (DAW) software for Mac.

**Required Textbook**: <u>Creating Sounds from Scratch: A Practical Guide to Music</u> <u>Synthesis for Producers and Composers.</u>

### Preferred Names, Preferred Gender Pronouns

## Credit Load:

This course carries a 3 hour credit load. Students should expect to spend additional 6 hours each week outside of class preparing. Some weeks will require more time spent working outside of class than others and actual time spent may vary depending on previous experience and knowledge.

#### **Student Learning Outcomes**

- Demonstrate intermediate to advanced proficiency as an engineer in Logic Pro X, knowing the interface, tools and keyboard shortcuts.
- Apply a professional workflow and set of techniques to produce tracks in any genre using software instruments, MIDI, loops and audio.
- Learn to record and edit to movie files in Logic Pro X for scoring and sound designing your own videos.
- Customize Logic's built-in sound library and create original presets to suit your artistic preferences.
- Learn basic synthesis techniques for creating your own sounds from scratch using digital and analog-modeled synthesizers.
- Compile a shareable portfolio of original projects, including composition sketches and several full-length song arrangements.

• Command basic mixing abilities using levels, panning, corrective signal processing(EQ, compression, etc.), creative signal processing (reverb, delay, distortion, modulation) and automation.

• Implement a basic mastering chain on your stereo output for finalizing your tracks to commercial specs.

### **Teaching Philosophy**

You will learn by doing in this course.

• The instructor will present tools and demonstrate their application, then you will practice applying the same techniques to create your own original music.

• Each student will produce something unique for every assignment and project. The instructor will give you information, direction, support and feedback always with the goal of empowering you.

### **Course Organization**

This course will be divided up into a handful of main units each lasting a few weeks. Each unit will have submissions of Logic sessions (or bounces), quizzes, peer reviews, and self reflection. I will meet individually with each student after each unit, where you will provide yourself a grade for that unit and justify it.

I will be finalizing all of the Unit choices after receiving some feedback from the class. Two of them will certainly be:

- 1 Understanding and implementing the principles of music synthesis in popular music styles
- 2 Creating and editing music and sound design against picture.

Other options will be: multitracking in the UNT music studio, advanced mixing routing and concepts, and using Flex Pitch / Flex Time.

#### Format (Canvas-Driven)

Canvas will be the hub for everything in this course. All lab and project assignments will be submitted online via Canvas. All quizzes will be administered online via Canvas.

The lecture material and assignment *might* be given *before* our weekly classmeeting. Our class time will be used for follow-up group work, individual work with instructor support, asking and answering questions and/or sharing drafts of your work with the instructor and your classmates.

### Materials

The following materials are all supplied in the Computer Music Lab for working at school when the lab is open. You can also <u>check out a Mac laptop with Logic</u> <u>Pro installed from the Lab for 24 hours</u> and/or other materials below for your home use during this course. As such you are **not required** to purchase any materials for this class. **BUT...** Purchase of the following materials is *recommended* so that you can work on audio projects at home and in the future as a music professional.

### Highly Recommended but Not Required:

Mac Computer with Logic Pro X installed. Although there is no academic discount for Logic Pro X alone (\$199), this price is very low for the features included when compared with ProTools, Cubase or any other professional DAW. It is well worth the investment. Before you buy, please consider Apple's Pro Apps Bundle for Education that includes Logic Pro X plus four other valuable video and live music production apps (\$199--same price as Logic by itself!)

2. Reference headphones are needed for all audio work. Earbuds and any other headphones you already own are almost assuredly not reference headphones. There are many companies and options, but be sure to choose headphones that *explicitly specify* they have a flat frequency response for studio reference monitoring. A popular, affordable option are <u>Sony MDR 7506</u>

reference headphones. If you have a slightly higher budget, <u>Beyerdynamic DT</u> <u>770</u> are my current personal favorite.

Optional:

3. MIDI keyboard controller. If you want to input notes and control other Logic Pro parameters not using only your mouse and laptop's keyboard, consider spending \$80+ on a <u>USB MIDI controller</u>. Compare the features and pick what suits you best. Some have smaller/larger keys. Some work with iOS as well as Mac OS. Some have bundled software or even built-in USB audio interface

4. **Audio recording interface**. This is needed to plug an instrument or external microphone into your computer for recording audio into a Logic session. There are <u>MANY</u> available options, ranging from inexpensive to very expensive. A few high quality options I can personally recommend:

5. Microphone (and accessories). There are many, MANY microphone options for all budgets. A great mic to start with for studio recording is a <u>Largediaphragm condenser microphone</u>. I recommend you first set your budget then compare reviews of mics in that budget. <u>https://www.sweetwater.com/</u>

## **Grading Summary:**

This course will focus on qualitative not quantitative assessments, as these are the type of assessments you will receive in the professional world.

You will receive a final grade at the end of the semester, as required by university policy, but I will not be conventionally grading individual assignments. Instead, I will be asking questions and making comments that engage your work (and invite you to do so as well) rather than simply evaluate it. Crucially, this course will stress incorporating that feedback into your subsequent work.

You will be reflecting on your work and that of your peers in a way that supports constant improvement.

I am interested in what success looks like for you in this course and how to help you achieve this goal. Why are you taking this course and what do you hope to gain from it? These questions are important to answer for yourself as will be actively involved in deciding your final grade for this course. Learning to be selfreflective on your work will be important in professional settings. Taking note of feedback and finding ways to incorporate it into your work is an absolute necessity. The intention behind working collaboratively in your grading is to simulate as best we can the relationship between a client and yourself.

### How does this work?

You will receive credit/no credit for most assignments. If the assignment is not of a sufficient standard per the rubric or assignment description, you will be allowed to revise or resubmit it, assuming you turned it in on time. Late work will not have this chance for improvement. Just as late proposals would not be chosen by a client.

Your final grade will be a combination of your honest self-reflections, peer reviews, peer feedback, and instructor feedback. The instructor reserves the right to change any final grade to one they feel is a more appropriate reflection of the work submitted. The goal is for there to be an alignment of what quality work is and how to create it.

### ATTENDANCE, DRAFTS, LATE WORK AND EXTENSION POLICIES:

This is a highly interactive class. There is no replacement for experiences that take place during class time. Attendance is integral to improvement in this area of study. It is also an opportunity to practice professionalism in your work. *The instructor must be notified in advance of an absence or tardy.* 

In the event of an absence, **students are still responsible for turning in assignments on time** (unless previous arrangements have been made) and **staying caught up on what was missed.**  Work more than a week late will not be accepted at all unless prior arrangements have been made ahead of time.
