## Course Description

## Course Structure

The University has classified this course as REMOTE/asynchronous. There are no on-site meetings.

I will deliver the course contents primarily through asynchronous (prerecorded) lectures. There may be occasional synchronous (live) Zoom meetings. Even those live sessions will be recorded so that you can view or review them later.

*There will be fixed time windows in which you will need to complete assignments and take exams.* These will be spaced approximately evenly throughout the semester and announced on the course calendar.

The Canvas modules will open sequentially, usually one week at a time, throughout the semester.

## Course Prerequisites or Other Restrictions

*MKTG 3650* is a prerequisite for this course.

## Materials

This course does not require you to buy or rent a traditional paper-based textbook. Instead, I strongly urge you to *subscribe* to a "virtual book" (also known as an *online course*) available on the website at [World Class Courses](https://worldclass-courses.com) (<https://worldclass-courses.com>). The relevant online course on that website is [Digital Marketing \[3720\]](https://worldclass-courses.com/product/internet-marketing/) (<https://worldclass-courses.com/product/internet-marketing/>).

The retail price of the online course is \$189.95. However, I will give you a discount code to reduce its cost by 90% (and, consequently, bring your price down to \$19). However, *that code will be valid only*

*through 11:59 PM, July 9, 2021.* After that time, it will revert to the original retail price. I will make the discount code available to you via an announcement on *Canvas*. Please do not subscribe to this online course if you are unsure of continuing enrollment in this course. As an e-commerce purchase of a digital product, all sales are final and non-refundable.

*Disclaimer:* I, your instructor, am the author of this course. I have used this online course (virtual textbook) to teach students in multiple educational institutions in the US and overseas. Because I am the author, I will not *require* you to subscribe to it. But I urge you to adopt it because it will be extremely helpful to you. But the platform costs and intellectual property agreements related to the book's content preclude me from doing so.

## Course Grading

Your overall semester grade will include evaluations of your performance in the following **two** areas:

- Exams (delivered through Canvas/Respondus LockDown browser) — 70% of the overall grade
- Assignments (short quizzes, essays, and discussions) — 30% of the overall grade

The final course grade will be determined using the following formula:

$$\text{OVERALL} = \begin{aligned} &[(\text{AVERAGE of } \textbf{EXAMS}) * 0.70] + \\ &[(\text{AVERAGE of } \textbf{ASSIGNMENTS}) * 0.30] \end{aligned}$$

The LETTER GRADE assignment, based on the *OVERALL* score, will be as per the following scheme:

*There will be **no** rounding **up** of scaled points; the grades will be determined **precisely** by the ranges shown above.*

- You may be able to submit some (but not all) assignments after the original deadline. However, for submissions after the expiration of the deadline (where it is allowed), Canvas will automatically deduct 10% of the grade for each day by which you are late. ***This policy is immutable.*** Please note that all assignments will close at 11:59 PM, August 02, 2021. There will be no opportunities for late submission after that deadline.
- Please be advised that written (essay-format) submissions of all kinds are liable to be scanned by (or submitted via) **TurnItIn** or other plagiarism detection utilities.

## Important Notice for F-1 Students taking Distance Education Courses

### Federal Regulation

To read detailed Immigration and Customs Enforcement regulations for F-1 students taking online courses, please go to the [Electronic Code of Federal Regulations website](http://www.ecfr.gov/) (<http://www.ecfr.gov/>). The specific portion concerning distance education courses is located at Title 8 CFR 214.2 Paragraph (f)(6)(i)(G).

The paragraph reads:

(G) For F-1 students enrolled in classes for credit or classroom hours, no more than the equivalent of one class or three credits per session, term, semester, trimester, or quarter may be counted toward the full course of study requirement if the class is taken online or through distance education and does not require the student's physical attendance for classes, examination, or other purposes integral to completion of the class. An online or distance education course is a course that is offered principally using television, audio, or computer transmission, including open broadcast, closed circuit, cable, microwave, or satellite, audio conferencing, or computer conferencing. If the F-1 student's course of study is in a language study program, no online or distance education classes may be considered to count toward a student's full course of study requirement.

### University of North Texas Compliance

To comply with immigration regulations, an F-1 visa holder within the United States may need to engage in an on-campus experiential component for this course. This component (which must be approved in advance by the instructor) can include activities such as taking an on-campus exam, participating in an on-campus lecture or lab activity, or other on-campus experience integral to the completion of this course.

If such an on-campus activity is required, it is the student's responsibility to do the following:

- (1) Submit a written request to the instructor for an on-campus experiential component within one week of the start of the course.
- (2) Ensure that the activity on campus takes place, and the instructor documents it in writing with a notice sent to the International Student and Scholar Services Office. ISSS has a form available that you may use for this purpose.

## Transmission and Recording of Student Images in Electronically Delivered Courses

1. No permission is needed from a student for his or her image or voice to be transmitted live via videoconference or streaming media, but all students should be informed when courses are to be conducted using either method of delivery.
2. In the event an instructor records student presentations, he or she must obtain permission from the student using a signed release in order to use the recording for future classes in accordance with the Use of Student-Created Work guidelines above.
3. Instructors who video-record their class lectures with the intention of reusing some or all of the recordings for future class offerings must notify students on the course syllabus if students' images may appear on the video.
