Course Description

Welcome to HIST 2610! In addition to learning about significant historical events, people, and periods this semester, I will introduce to you the process of thinking with historical documents, or primary sources. You will learn how to think with primary sources while exploring American history from the Pre-Colonial period to the Civil War. You will learn how to contextualize and interpret historical documents. We will prioritize process and inquiry over the accumulation of facts, names, and dates in order to think more critically about history and its significance to us today. Historian and History teacher Lendol Calder calls this approach to learning history “uncoverage.” Rather than attempting “to cover” *everything that happened* over 400 years of history, we will “uncover” how history is made by thinking critically with, and about, historical sources.

Course Prerequisites or Other Restrictions

There are no prerequisites or other restrictions for this course.

American History State Core Objectives

Courses in this category focus on the consideration of past events and ideas relative to the United States.

Courses involve the interaction among individuals, communities, states, the nation, and the world, considering how these interactions have contributed to the development of the United States and its global role. Successful students in this course will develop:

- *Critical Thinking Skills*, including creative thinking, innovation, inquiry, and analysis, evaluation and synthesis of information;
- *Communication Skills*, including effective development, interpretation and expression of ideas through written, oral and visual communication;
- *Personal Responsibility*, including the ability to connect choices, actions and consequences to ethical decision-making;
- *Social Responsibility*, including intercultural competence, knowledge of civic responsibility, and the ability to engage effectively in regional, national, and global communities.

History 2610 Student Learning Outcomes

By the end of this course, students will be able to:

- Paraphrase primary sources;
- Contextualize primary sources;
- Analyze primary sources and make inferences;
- Evaluate the significance of an historical event, person, idea, or primary source;
- Identify the significance of why we study history.

Course Assignments*Introductory Essay (40 points)*

An essay of 200-500 words where students introduce themselves to the instructor and their teaching assistant. In addition to introducing themselves, students will be asked to describe their current understanding of history and historical study.

Midterm Exam - Primary Source Analysis (100 points)

Students will complete an in-class midterm exam where they will practice primary source analysis.

History and Careers Short Assignment (40 points)

Towards the end of the semester, students will complete an online module in Canvas where they explore careers that align with the skillsets learned in History. A short assignment will conclude the module.

Incidents in the Life of a Slave Girl Small Group Discussions (160 points)

In the second half of the semester, students will read *Incidents in the Life of a Slave Girl* and complete the following assignments:

- Introduce yourself to your small group (20 points)
- Reading Quizzes (20 points, 2 quizzes, 40 points total)
- Discussion Board Posts (20 points, 2 discussion boards, 40 points total)
- Formal Reflection (60 points)

Signature Assignment (100 points)

Students will complete the core assessment which evaluates what students have learned about primary source analysis and contextualization.

Historical Documents and Artifacts Mini-Research Project (160 points)

Students will conduct a mini-research project where they will seek out historical documents and artifacts and create a PowerPoint presentation explaining the significance of their historical sources. The project will consist of:

- Topic Proposal (20 points)
- Primary Sources Worksheet (40 points)
- PowerPoint Slides (100 points)

Time Management, Communication, and Late Work

Academic Dishonesty and AI Usage

Academic dishonesty, according to UNT's "Student Academic Integrity" policy, includes the intentional and unintentional engagement in cheating, plagiarism, and the facilitation of academic misconduct, to name a few. Additionally, with the rise of generative AI, I understand that you will use such tools in various writing activities both in and out of the classroom. I will therefore support your understanding of the uses, ethics, and limitations of generative AI tools. This technology has many abilities and also limitations; its use requires research skills, critical thinking, and digital literacy. Therefore, you may use AI tools in this class provided that

you acknowledge your use through citation and annotation. The following is a template for citing your use of generative AI:

Chat-GPT-3. (YYYY, Month DD of query). "Text of your query." Generated using OpenAI.

Additionally, I will expect you to describe in your own words the strategies and techniques you used to compose with AI tools in a descriptive annotation of 3-5 sentences following your citation. Even if you use Grammarly to proofread your assignment, please provide a citation and brief note as the AI-Detection software cannot distinguish between AI-Generated content and softwares. Be as specific as possible in your annotation. It is your responsibility to be transparent and proactive. Both citation and annotation are required. Failure to acknowledge your use of AI tools through citation and transparency through a descriptive annotation will result in an automatic 0 for academic dishonesty. ***Students in this class may only use generative AI to brainstorm, research, and outline for their assignments as well to proofread and edit their work.***

Example of a citation and annotation:

Chat-GPT-3. (2025, May 1). "What is the historical context for Christopher Columbus's voyage journals?" Generated using OpenAI. <https://chat.openai.com/>.

I asked ChatGPT for help understanding the historical context surrounding Columbus's document. I read its answer and checked for accuracy using American Yawp. Then, I used ChatGPT's response to help me write my historical context section.

Important Notice for F-1 Students taking Distance Education Courses

Federal Regulation

To read detailed Immigration and Customs Enforcement regulations for F-1 students taking online courses, please go to the [Electronic Code of Federal Regulations website](http://www.ecfr.gov/) (<http://www.ecfr.gov/>). The specific portion concerning distance education courses is located at Title 8 CFR 214.2 Paragraph (f)(6)(i)(G).

The paragraph reads:

(G) For F-1 students enrolled in classes for credit or classroom hours, no more than the equivalent of one class or three credits per session, term, semester, trimester, or quarter may be counted toward the full course of study requirement if the class is taken on-line or through distance education and does not require the student's physical attendance for classes, examination or other purposes integral to completion of the class. An on-line or distance education course is a course that is offered principally through the use of television, audio, or computer transmission including open broadcast, closed circuit, cable, microwave, or satellite, audio conferencing, or computer conferencing. If the F-1 student's course of study is in a language study program, no on-line or distance education classes may be considered to count toward a student's full course of study requirement.

University of North Texas Compliance

To comply with immigration regulations, an F-1 visa holder within the United States may need to engage in an on-campus experiential component for this course. This component (which must be approved in advance by the instructor) can include activities such as taking an on-campus exam, participating in an on-campus lecture or lab activity, or other on-campus experience integral to the completion of this course.

If such an on-campus activity is required, it is the student's responsibility to do the following:

- (1) Submit a written request to the instructor for an on-campus experiential component within one week of the start of the course.

Transmission and Recording of Student Images in Electronically-Delivered Courses
